

Instructions for Changing Your Gender Designation (Adult) BC Services Card / BC Driver's Licence / BCID

Option 1: With an Updated Birth Certificate

If you are planning to change your gender designation on your birth certificate, do that first. The BC Vital Statistics Agency website has information on how to update your BC Birth Certificate: www2.gov.bc.ca/gov/content/life-events/order-certificates-copies.

Submit a copy of your updated birth certificate to Health Insurance BC and then to ICBC to change your gender designation on your BC Services Card, BC Driver's Licence (BCDL) or BCID¹.

STEP 1 — Update your birth certificate

Important Note: Step 2 and Step 3 only apply if you are changing your gender on your BC Services Card. If you are changing your gender on a BCDL or BCID only, then there is no requirement to send the form to HIBC first; you may proceed to Step 4.

- Submit a COPY of your updated birth certificate to Health Insurance BC at Health Insurance BC, PO Box 9035 Stn Prov Govt, Victoria BC, V8W 9E3. Change of gender designation requests and uploading documents can also be done at www.gov.bc.ca/managingyourmspaccount
- Wait for and receive a Confirmation Letter from Health Insurance BC

 If you are a Non Photo BC Services Card holder, a card will be sent to you in the mail
- To change your gender designation on your photo BC Services Card, BCDL, or BCID go to a driver licensing office with your updated birth certificate and confirmation letter, if applicable
- STEP 5 Wait for and receive a new photo BC Services Card and/or BC Driver's Licence (BCDL) and/or BCID

Option 2: Without an Updated Birth Certificate

If you are not updating your birth certificate, follow the instructions below to submit the attached 'Application for Change of Gender Designation (Adult)' to Health Insurance BC and then to ICBC.

What You Will Need: • 2 copies (one is for your records) of the Application for Change of Gender Designation (Adult) (next page)

Important Note: Step 1 and Step 2 only apply if you are changing your gender on your BC Services Card. If you are changing your gender on a BCDL or BCID only, then there is no requirement to send the form to HIBC first; you may proceed to Step 3.

For changing a BC Services Card with or without a BCDL and/or BCID. If you are ONLY changing your BCDL and/or BCID, proceed to Step 3.

Send **a copy** of your 'Application for Change of Gender Designation (Adult)' to: Health Insurance BC, PO Box 9035 Stn Prov Govt, Victoria BC, V8W 9E3 *Important: keep the original for Step 3* Change of gender designation requests and uploading documents can also be done at www.gov.bc.ca/managingyourmspaccount

- Wait for and receive a Confirmation Letter from Health Insurance BC. If you are a Non Photo BC Services Card holder, a card will be sent to you in the mail. If you are not updating your BC Services Card, you do not need a Confirmation Letter from HIBC.
- STEP 3 If you hold a Photo BC Services Card or combined BC Services Card and BCDL, after you receive a confirmation letter from Health Insurance BC, take the following to a driver licensing office:
 - The original (preferred) or a copy of your 'Application for Change of Gender Designation (Adult)'
 - · One piece of primary identification
 - One piece of secondary identification

Wait for and receive a new BC Services Card and/or BCDL and/or BCID
