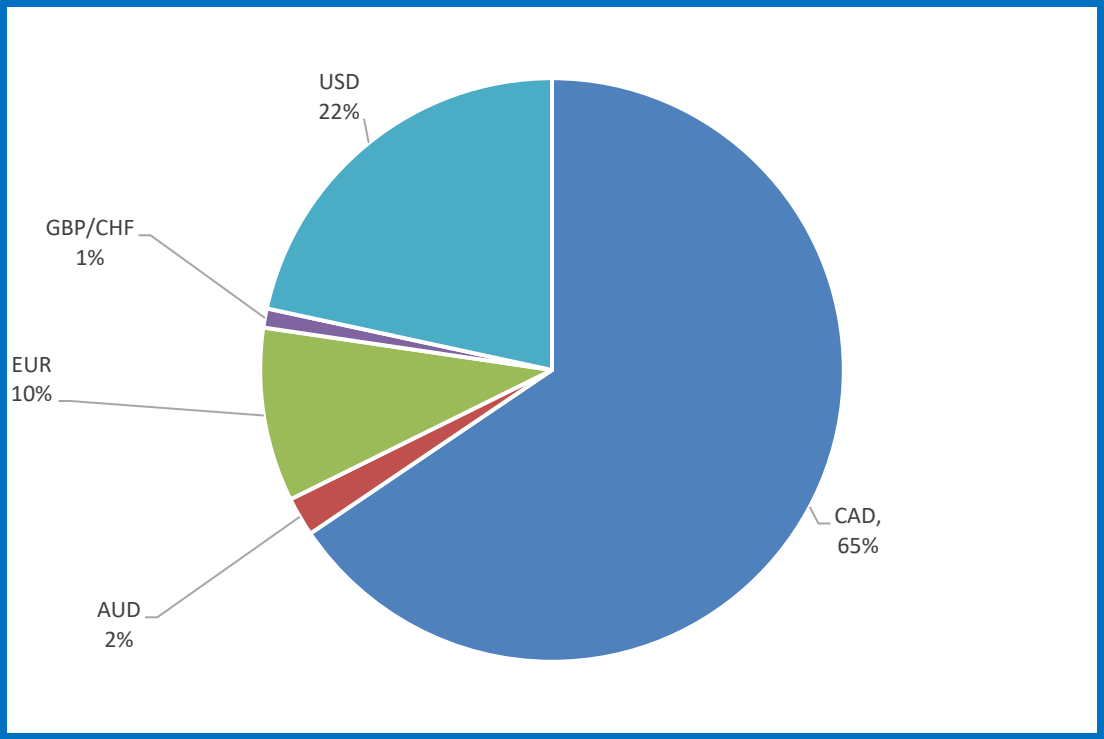


# Gross Market Debt Outstanding by Currency<sup>1</sup> – March 31, 2026
