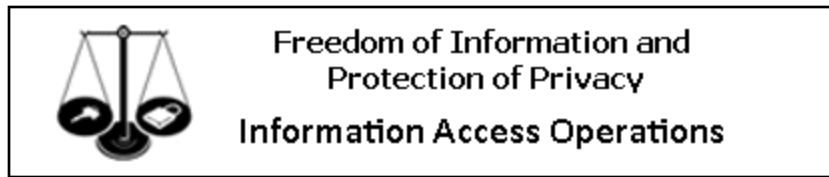

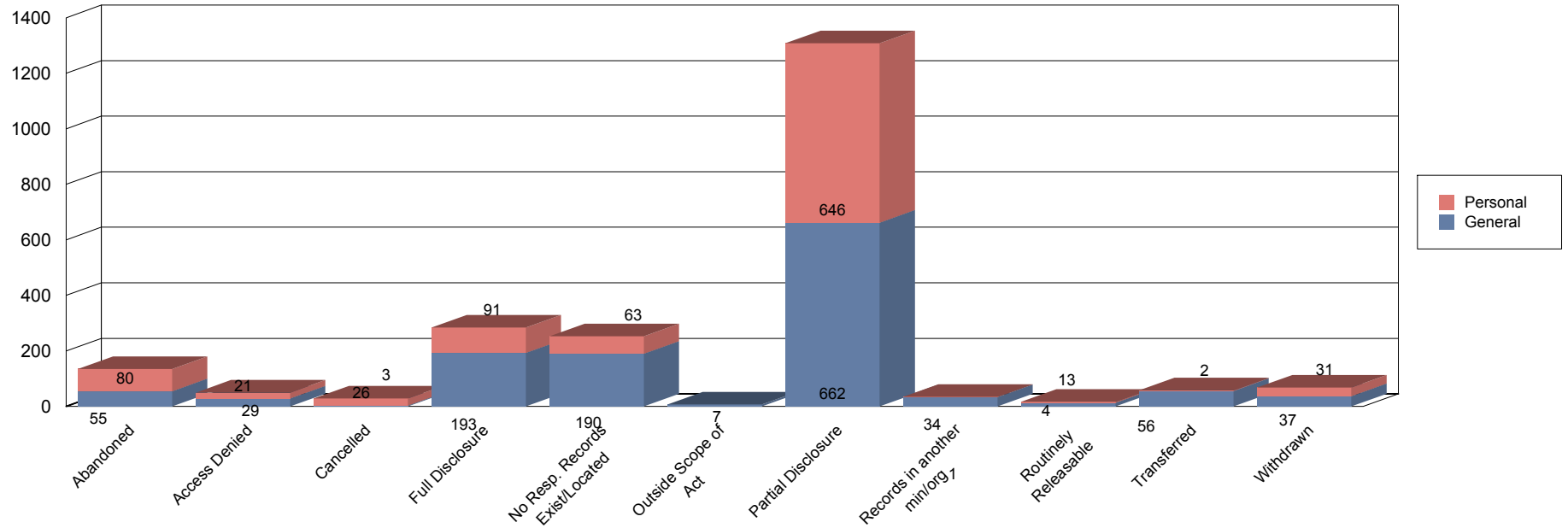

Disposition Definitions

Abandoned	Applicant has failed to respond to requests by the public body for clarification of some aspect of the request
Access Denied	Access to the records requested has been denied as the records requested are either subject to exceptions under the Act or are outside the scope of the Act
Access Denied - Section 20	Access to the records have been denied - Section 20 - release in 60 days
Annotated	Added an explanatory note
Cancelled	Applicant cancelled the request
Correction	Correction to personal information in the applicant's file
Full Disclosure	All records released without severing
No Responsive Records Located	No Responsive Records Located
Outside Consultation	Outside Consultation, ie another public body or other government
Outside Scope of Act	Not covered by the legislation
Partial Disclosure	Some records released without severing
Records Do Not Exist	The records sought by the applicant do not exist.
Routinely Releasable	Records have been identified as not requiring FOI review and are released in full
Transferred	It is determined that the records requested either reside solely in another public body or another public body has a greater interest in the records
Undetermined	Undetermined
Withdrawn	The applicant has requested that the public body not proceed with responding to the request
