- ❖ Keep overall criteria (see above) and funding amount (\$50,000) in mind for all questions.
- ❖ Preference will be given to projects that could be replicated in other similarly-sized B.C. communities.
- ❖ Preference will be given to projects that use, encourage, or provide open data.
- ❖ Projects must be implemented with current broadband infrastructure.

Question 7: Please describe your proposed project, including timeline, budget and projected outcomes.

- Provide an overview of your pilot project, including the problem that your project will tackle.
- The outcomes must be measurable and achievable through the proposed use of data and connected technology.
- Include or append a tentative budget, including any procurement costs.
- Include or append a month-by-month timeline with deliverables.
- Note that there will be an informal six-month check-in (March 2019) with the Province and a formal one-year report out (September 2019).

Question 8: What is the rationale for applying a Smart Communities approach to your project? How does your project align with one or more of the five themes?

- Align project with the pilot definition: “Smart communities (also known as “smart cities”) are communities that use connected technology and data to improve their infrastructure.”
- Align project with one or more of the five themes mentioned in the Criteria section:
 - Economic diversity and growth
 - Energy efficiency and climate change mitigation
 - Engaged citizens
 - Efficient transportation and mobility
 - Community resiliency and safety

Question 9: Do you have any identified partners or companies? If so, please list and describe.

- Highlight any agencies, organizations or community groups that you might partner with to develop and deliver your project.

Question 10: Have you secured additional funding from your local government?

- 10% of total project budget must be from local government (or partner) funding. Only 50% of this funding can be in-kind.
- Preference may be given to communities who have identified funding at time of application.

Question 11: How have you engaged your community?

- Clearly state community need.
- Describe previous engagement with residents, businesses, organizations, and other stakeholders on your proposed pilot project.
- Describe feedback from engagement, conversations etc. and, if applicable, how feedback was incorporated into the application.
- Provide evidence of efforts to be inclusive and represent community's diversity.
