Dear Mr. Gruber:

Thank you for your letter.

In light of the Primary Poultry Processors Association of BC's (PPPABC) application for non-disclosure, and as set out in the BC Farm Industry Review Board's (BCFIRB) letter dated December 11, 2023, which states:

"I note that the deadline for making submissions in response to the November 23, 2023 process letter is currently December 22, 2023 ... these deadlines will need to be extended until such time as the panel makes its decision on PPPABC's non-disclosure application and makes any necessary procedural orders to accommodate confidentiality concerns. The panel will provide a revised submission schedule at that time."

As such, we are writing to confirm that review participants are not required to provide their submissions by December 22<sup>nd</sup> as originally set out in BCFIRB's November 23, 2023 letter, and that the Panel will provide further direction for submissions once a decision is made on PPPABC's non-disclosure application.
