Re: Investigation Schedule

I write further to Chair Donker's letter of September 16, 2021 confirming that the oral hearing in this supervisory review will be adjourned to January 31, 2022 to allow for the orderly completion of my investigations.

My revised investigation schedule is set out below. This schedule is subject to revision depending on any substantive or procedural matters that may arise during the investigation process. I will provide a further update if significant changes become necessary.

September 27, 2021

Response due from Prokam Enterprises Ltd. to additional investigation questions from Hearing Counsel (September 10, 2021).

Week of September 27, 2021

Hearing Counsel interviews with Bajwa Farms and MPL British Columbia Distributors Inc.

Week of October 4, 2021

Hearing Counsel document distribution, including interview summaries, to counsel for the BC Vegetable Marketing Commission, Commissioners and staff named in the Notices of Civil Claim (non-complainant respondents).

Tentative October 22, 2021 (14 days following document distribution)

Documents and witness lists to be provided to Hearing Counsel by the non-complainant respondents.

Week of November 8, 2021

Hearing Counsel interviews with the non-complainant respondents.

Week of November 15, 2021

Hearing Counsel document distribution, including interview summaries, to counsel for Prokam Enterprises Ltd., Bajwa Farms and MPL British Columbia Distributors Inc.

The above schedule will give all the parties approximately two months to prepare for the hearing, including adequate time to request further documents if needed and to respond to any document disclosure requests.
