# **Implementation Plan – French Language Policy 2024-2028**

#### Preamble

Announced on January 5, 2024, and implemented as of April 1, 2024, the French Language Policy helps ministries incrementally increase their capacity to provide services in French across the province, based on needs and available resources.

The policy supports ministries through increased engagement, coordination, and planning activities.

# **Implementation Plan**

The plan identifies priority sectors and initiatives that will support the implementation of the policy and the continued development of government services available in French. The plan covers the period from April 1, 2024 to March 31, 2028.

As needed, the plan can be updated to reflect emerging needs and/or available resources.

The implementation plan focuses on two main strategic objectives:

- 1. Strengthen the internal capacity of the B.C. public service.
- 2. Maintain and/or increase the availability of French-language services in priority areas.

## 1. Strengthen the Internal Capacity of the B.C. Public Service

**Goal:** Promote the implementation of the French Language Policy within the public service.

**Desired Result:** Ministries consider the needs and priorities of Francophones in decision-making, program development, and/or service delivery, particularly in priority areas.
