BC Identification Card (BCID) (accepted up to three years after expiry)

Driver's License (accepted up to three years after expiry)

Valid passport (Canadian or foreign)

Original citizenship papers/immigration documents

Offender identification card (issued by Correctional Services of Canada)

Other recognized identification such as CNIB cards, employee cards (with photos) from recognized employers
