I,, EFFECTIVE AS OF THE DATE I SIGN BELOW, HEREBY ACKNOWLEDG
AND AGREE WITH HIS MAJESTY THE KING IN RIGHT OF THE PROVINCE OF BRITISH COLUMBIA, represented by the Minister of the "PROVINCE") AS FOLLOWS:

I confirm my understanding that: the Province and Others may, but are not obligated to, disclose my name in connection with their use of the Recordings; I do not own or have any interest in the Recordings, or any right to pre-approve use of the Recordings by the Province or Other and I am not entitled to any compensation (financial or otherwise) for any use of the Recordings by the Province or Others.
I agree to waive my rights and to release and hold harmless the Province and Others from any and all claims I may have against them be reason of any fact or matter in any way relating to their use of the Recordings or this Consent and Release and, further, I hereby waive in favour of the Province and Others all "moral rights", as described in subsection 14.1(1) of the <i>Copyright Act</i> (Canada), I may have in any Recording provided to the Province by me and/or by others on my behalf. I further agree to fully indemnify the Province and Others for all expense costs and damages arising from any third party claim relating to any Recordings provided to the Province by me and/or others on my behalf including with respect to the misuse of personal information and the infringement of any intellectual property or other proprietary rights.
This Consent and Release forms the entire agreement between the parties and any modification must be in writing and signed by the Province
