Reporting to British Columbia's Police Complaint Commissioner, the Deputy Commissioner will be responsible for overseeing the OPCC's oversight operations and play a major role in determining the strategic direction of the Office. The successful candidate will also work collaboratively with senior leadership and interested parties to shepherd the Office through a time of expanding legislative responsibilities.

This position will be of interest to passionate leaders who think creatively, wish to help effect positive change in policing, and demonstrate the following: Post-secondary education in a related field (e.g., business/public administration, law); minimum 7 years of experience as a senior leader responsible for overseeing components of an organization and leading senior managers and their teams in a complex statutory environment; advanced proficiency with interpreting and applying related complex legislation (e.g., federal or provincial law enforcement statutes).

The Deputy Commissioner will be based in the OPCC's future office in downtown Vancouver or head office in Victoria.
