

Project Cargo Corridors Requiring Utility Approvals

Certain configurations travelling along the along Project Cargo corridors may, depending on the overall height (OAH), be required to travel along municipal roadways. This routing is not preapproved for heights beyond 4.15 m and will require utility company approval prior to travel. Utility approval requests may be submitted up to 90 days in advance, with a minimum of five business days required. The following chart shows a general breakdown of when utility approvals are required based on routing and OAH.
