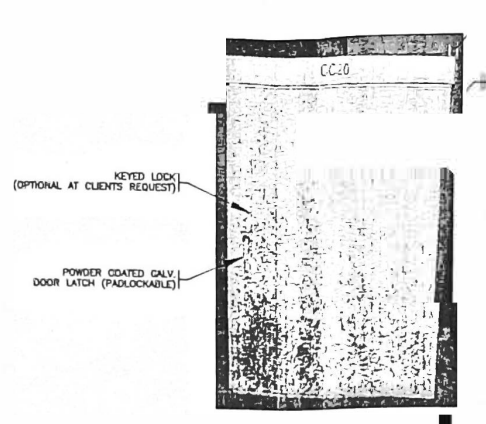


FIGURE 3 SINGLE DOOR KIOSK CLOSED

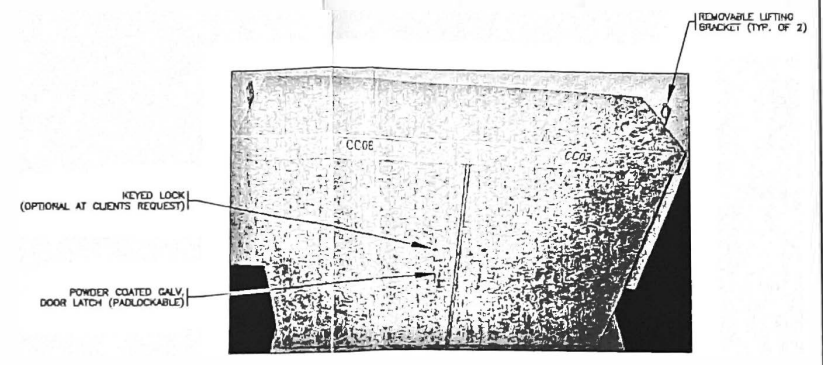


FIGURE 5 DUAL DOOR KIOSK CLOSED

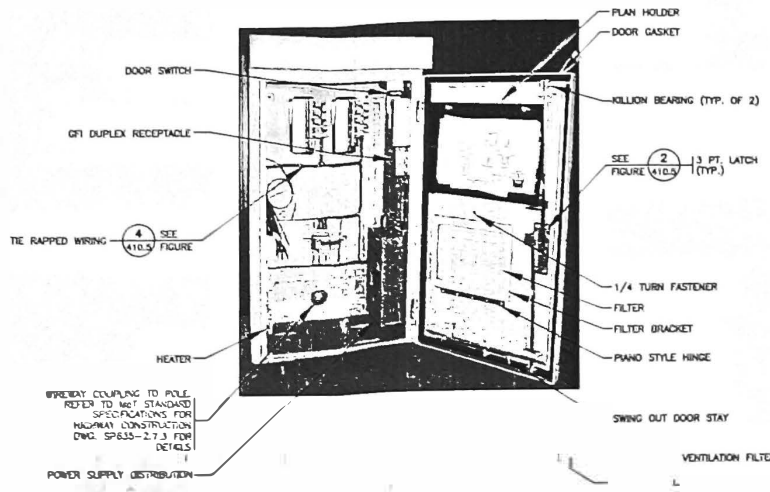


FIGURE 2 POLE MOUNT CABINET OPEN

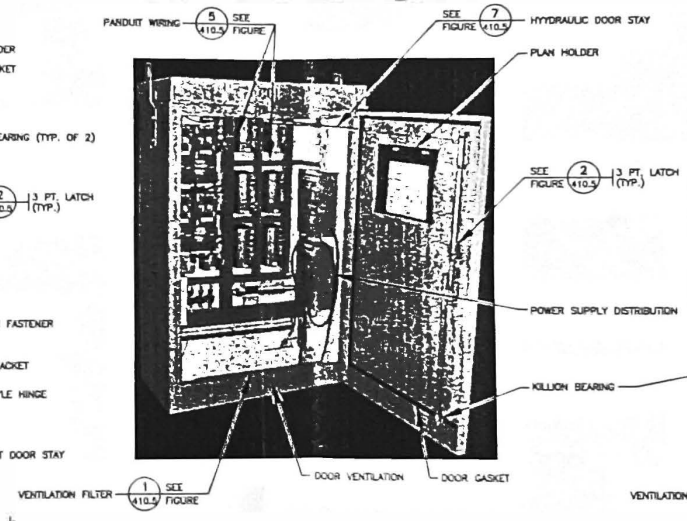


FIGURE 4 SINGLE DOOR KIOSK - OPEN

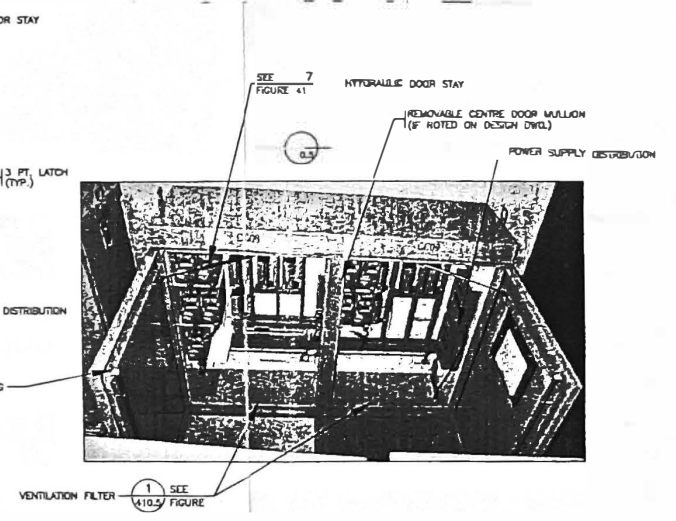


FIGURE 6 DUAL DOOR KIOSK OPEN
