## 100 Overview

The Construction Supervision Survey Guide has been developed to bring consistency to the workflows undertaken by Ministry Field Services Construction Surveyors, and outlines the procedures and standards required to fulfill their duties.

The intended audience for this guide includes Ministry and consultant surveyors engaged with construction supervision activities. This document covers a range of topics and is designed to be used as a minimum standards reference for all parties involved with construction supervision.

The Construction Supervision Survey Guide has been developed by the Field Services Workflow and Technology Working Group.

## 100.01 Overview

Provincial Field Services is a business unit of the BC Ministry of Transportation and Infrastructure. Field Services operates under the Highways and Regional Services Division, Southern Interior Region.

Field Services administers construction supervision activity for Ministry road and highway construction projects. Standardized construction supervision workflows are required for the following:

- 1. Provide Quality Assurance checks for work completed by construction contractors.
- 2. Support monthly payments to contractor based on field measurement and calculations.
- 3. Ensure all survey records and calculations are completely auditable by a third party.
- 4. Provide consistent framework for training and continued improvement of workflows.

A Field Services Construction Supervision Team is comprised of the following:

- Ministry Representative
- Assistant Ministry Representative
- Ground Modeler
- Construction Surveyor (Field Services Assistant)

The two technical roles and associated major tasks on the Construction Supervision Team are as follows:

- **Ground Modeler** The Ground Modeler is a Civil 3D expert responsible for: data compliance checks, preparation of the construction survey data package, modeling construction material volumes and support to Construction Surveyors.
- Construction Surveyor The Construction Surveyor is a Trimble Business Center (TBC) expert responsible for: field survey original ground (FSOG) surveys and surface, horizons and remeasure surveys and surfaces, construction quantity (removals and new) calculations, QA on contractor layout, and other construction supervision tasks.

Standardized components used to fulfill the needs of the construction supervision workflow are provided for both Civil 3D and Trimble Business Center and are addressed in this manual.

The primary data deliverable to the Construction Supervision Team is a standardized Civil 3D construction archive consisting of design model and production drawings, which was prepared by a geomatics and design team.

## **100.02** Requirements For Use of Workflows and Standards

The workflows and standards outlined in this document are required to be used in the following circumstances:

- Construction Supervision Teams consisting of Ministry staff only.
- Construction Supervision Teams consisting of Ministry staff and consultants.

It is recommended that consultant Construction Supervision Teams follow the workflows and standards outlined in this document, but it is not a requirement. If consultants are not using workflows and standards outlined in this document, then they must ensure that their processes and data will stand up to a detailed audit in the event of a dispute, or litigation.

## **100.03** Construction Surveyor Duties and Responsibilities

This section describes the duties and responsibilities of the Construction Surveyor. Please note that the Construction Surveyor may have technical interactions with the project Ground Modeler on the Construction Supervision Team.

The primary duty of the Construction Surveyor is to provide QA (quality assurance) on the work completed by the contractor. Quality assurance has many components however, the following bullets represent the major tasks to be completed by the Construction Surveyor on road and highway construction projects to support the quality assurance mandate:

- 1. **Survey Control** establish secondary survey control on the site for instrument setup for subsequent observations and measurements (construction supervision surveyors may also obtain secondary control established by the Contractor).
- 2. **FSOG Feature and Surface Model** collect field survey original ground data to model existing conditions surface features and create surface models, with the former being used as the basis for calculating removal quantities, and the latter as a basis for earthworks calculations.
- 3. Horizon and Remeasure Surveys, Surfaces and Volumes conduct horizon and remeasure surveys and create surfaces to calculate monthly excavation quantities for the various materials encountered on site.
- 4. **Spot, Linear and Area Quantity Surveys** survey and record newly constructed point, linear and area features for the purpose of quantification and for validation of location.
- 5. **Quality Assurance on Construction Layout** work with layout data files provided by GMG to validate the correctness of contractor layout stakes before grading occurs.

All aspects of these major tasks must incorporate Ministry quality management mandates to ensure calculations are supported by measurements and models that can be sourced back to the original survey observations.

A suite of Ministry standardized tools for Trimble Business Center and Microsoft Excel is available to help the Construction Surveyor accomplish these tasks.

## **100.04** Geomatics General Survey Guide

Construction surveyors are expected to apply best practices when conducting field surveys. The Ministry's <u>Geomatics Resources</u> web page contains the General Survey Guide and other information relating to conducting field surveys. Construction surveyors should become familiar with the contents of the above web page, to ensure best practices for conducting field surveys are being followed.

## **100.05** Standard Specification for Highway Construction

All Ministry construction projects must follow the minimum requirements for highway construction as specified in the <u>Standard Specifications for Highway Construction</u>.

## **100.06** Survey Equipment and Software

Ministry surveyors and consultants working with Ministry staff on Construction Supervision Teams are required to use Trimble Access data collection software on their controllers, or an approved alternate software, provided that Ministry survey codes are used.

Survey equipment used in conjunction with Trimble Access or equivalent controller software shall be current total stations and/or GPS or GNSS (RTK/RTN) capable equipment that meets or exceeds required survey tolerances as per the Ministry standard specifications. Consultant approval for the use of survey controller software other than Trimble Access is required from the Ministry Representative.

Ministry Construction Surveyors are provided with survey instruments for total station and GNSS surveying. Survey equipment is to be cleaned and maintained as follows:

- **Cleaning** all survey equipment is cleaned regularly and peripheral equipment such as tribrachs, level bubbles, cables, etc. are checked regularly and adjusted or replaced, if necessary.
- **Regular Maintenance** survey equipment is regularly field inspected and calibrated including horizontal and vertical collimation, tilt axis correction, and tracker calibration.
- Yearly Maintenance survey equipment is to be sent in once a year to a service center for maintenance, factory calibration, and certification.
- **Storage** survey equipment should always be stored in a secure dry area with cases open to airflow to ensure no damage occurs from condensation.

Consultants on Construction Supervision Teams not permitted to use Ministry survey equipment and are to provide their own survey equipment.

It is expected that:

- Data collection and reduction procedures are discussed with and approved by the Ministry Representative.
- All field and office procedures are in line with those outlined in this document.
- All work will be performed by suitably skilled personnel.

All construction supervision surveyors must have the ability to substantiate and supply the following upon request:

- Accuracies and survey closures achieved.
- Methodologies used for all field and office tasks.
- Equipment capabilities.
- Qualifications of personnel.

Ministry and consultant surveyors working with Ministry Construction Supervision Teams are required to use Trimble Business Center version 5.6 or later for survey data processing and record keeping. This version introduced project and surface data sharing functionality, which are both central to Ministry workflows.

The Ground Modeler on the Construction Supervision Team will create and provide the construction survey data package (CSDP) to the Construction Surveyors. The CSDP is a collection of application neutral data files (XML, DWG, PDF) created from the Civil 3D archive (from designers) that can be efficiently

consumed using a customized project template in TBC. The CSDP also includes layout RXL files and grade sheets extracted from Civil 3D corridor models. The source data for the CSDP consists of the following information, which is provided by design teams:

- 1. Civil 3D archive
- 2. Construction Tender Data Package

None of the major tasks (previous section) completed by the Construction Surveyor are to be completed using Civil 3D, unless the Ground Modeling role is onsite.

## **100.07** Civil 3D Survey and Design Terms of Reference

The Ministry's Civil 3D **Project Organization and Submission Requirements** document outlines standards and data assembly and submission requirements for the preparation of both geomatics and detailed design data. This is a required document for survey and design consultants providing services to the Ministry, and was created to:

- 1. Ensure standardized data deliverables to Construction Supervision Teams and contractors.
- 2. Provide consistency in the appearance of production drawings.
- 3. Form a common reference point for continued development and improvements.

For more information on Civil 3D refer to the Ministry's <u>Civil 3D Resources</u> web page.

## **100.08** Safety, Traffic Control and Property / ROW Entry Policies

#### <u>Safety</u>

The Ministry is a safety-oriented organization with Provincial, regional, and district level occupational health and safety committees. All employees are expected to perform their duties in a safe manner, adhering to all laws, regulations, and rules affecting their work. Copies of safety assessments are to be kept on file and readily available upon request.

All Ministry, WorkSafeBC, and prime construction contractor safety policies will apply to all surveys, including policies regarding safety equipment, signs, traffic control and procedures. Refer to the <u>WorkSafeBC Health and Safety</u> website for information.

#### **Traffic Control**

Traffic control requirements are required to be adhered to, and are clearly outlined in the Ministry's Traffic Management Manual for Work on Roadways.

#### **Right of Way Entrance**

Property owners must be contacted in writing, stating the intent, and requesting permission to enter their property if required. Refer to section 1.05 Entry onto Private Properties of the General Survey Guide on the Ministry's <u>Geomatics Resources</u> web page for private property entrance requirements.

The Ministry Representative shall be notified prior to contacting property owners for access to private property and notified immediately if private property access is denied. If entry onto a railway right of way is required, the Ministry Representative will contact the railway company to seek permission prior to accessing the railway right of way. Special instructions regarding railway right of way access are to be followed.

## **100.09** Provision of Electronic Information to Contractor

The **General Conditions** section of a Ministry contract states:

At the construction contractor's request and at the Ministry Representative's option, the Ministry or Ministry Representative may provide the construction contractor with electronic copies of the drawings, design digital terrain models, or other such information.

If the Ministry does provide such information, it is provided "as is" and at the construction contractor's request, without warranty of any kind, whether express or implied. All implied warranties, including, without limitation, implied warranties of accuracy, completeness, merchantability, fitness for a particular purpose, and non-infringement, are hereby expressly disclaimed.

Under no circumstances will the Ministry be liable to any person or business entity for any direct, indirect, special, incidental, consequential, or other damages based on any use of this information, or any information referenced therein, including, without limitation, any lost profits, business interruption, or loss of programs or information, even if the Ministry has been specifically advised of the possibility of such damages.

This also covers data collected by Construction Supervision Teams such as FSOG (Field Survey Original Ground) and TYPED and TYPEA horizon data.

## **100.10** Construction Tender Data Package CTDP

Design consultants are required to submit a Construction Tender Data Package (CTDP) along with the Civil 3D construction archive at IFT, to complete the project design phase. This requirement is outlined in the <u>B.C. Supplement to TAC (2019)</u> section 100.5.5.12 Deliverables. CTDP specifications can be found in the Ministry's Civil 3D Terms of Reference document in section 1280.11.02.02 (2300 Tender Data) available on the Ministry's <u>Civil 3D Resources</u> web page.

The CTDP is a collection of application neutral data files (no Civil 3D) that represents the design elements of the project, and are provided to construction contractors during tendering as part of Schedule T3, Contract Specific Reference Documents. Contractors use this data to help prepare their tender responses, which prevents the expensive and time-consuming recreation of design data in various contract estimating software packages, and allows for more emphasis on construction execution during bid preparation.

A summary of the standardized contents in the CTDP is as follows:

- 1. Vectorized PDF plan set tender / production drawings (the contract drawing set)
- 2. Vectorized PDF design model space data (no layouts or title blocks) from 100 series plan drawings
- 3. AutoCAD 2D DWG from model space (no layouts or title blocks) of 100 series plan drawings (with external references detached)
- 4. Separate AutoCAD 2D DWGs from each of the 100 series plan drawing external references (no layouts or title blocks)
- 5. Survey control in PNEZD (comma delimited)
- 6. Existing (pre-design) surfaces in LandXML format
- 7. Control alignment and profile in LandXML format
- 8. Proposed surfaces in XML
- 9. Proposed underground culverts and utilities in XML
- 10. Earthworks reports in XLSX (Excel)

Data required for construction tendering is provided in a standardized folder structure and delivered within the Civil 3D project folder structure containing the Civil 3D construction archive. The CTDP also

forms the basis for the construction survey data package (CSDP) which is prepared by the Ground Modeler for the Construction Supervision Team and discussed in the next section.

Please note that items 3 and 4 from the above list greatly simply the consumption of design model data in Trimble Business Center by construction supervision surveyors. Individual TBC projects created from 100 series model space drawings and for each external reference can be referenced by other TBC projects (like AutoCAD external references) which allows construction supervision surveyors to load/unload references selectively, and without loading design layers into their projects.

Details of the Construction Tender Data Package can be found in the Ministry's Civil 3D Terms of Reference document.

## **100.11** Construction Survey Data Package (CSDP)

The Construction Survey Data Package, prepared for each project by the Ground Modeler for the Construction Surveyor, represents a data extraction from the Civil 3D construction archive that is exclusively for consumption using Trimble Business Center. The intent with the development of the CSDP is to eliminate Construction Surveyor dependency on Civil 3D. The CSDP represents the surveyors first exposure to digital project data. The bulk of the CSDP is created by design teams when the Construction Tender Data Package is submitted for tendering purposes.

The CSDP is created by duplicating the Construction Tender Data Package and adding layout RXL data and grade sheets created directly from the Civil 3D corridor models and sample lines.

The CSDP folder structure, upon reception by the Construction Surveyor, is copied to the projects standardized construction survey folder structure (see section <u>200.01</u>).

For any design revisions, the Ground Modeler will receive a new Civil 3D archive, update the CSDP, and communicate these changes to the Ministry Representative and the Construction Surveyor.

## 200 Standardized Components for the Construction Surveyor

This following sections address the standardized components and the tools available to the Construction Surveyor. Specific folders are assigned to the various tasks undertaken by the Construction Surveyor.

## 200.01 Construction Survey Folders and Data Organization

Construction supervision survey data is organized in the 05) Survey folder of the Field Services Unified Folder System.



#### FS UNIFIED FOLDER SYSTEM

Quality assurance protocols warrant a standardized folder structure that is used to store the following types of information:

- **Construction Survey Data Package** extracts from Civil 3D IFT/IFC/Addendum archive, created by the Ground Modeler, for use in TBC
- **Records and Correspondences** survey records and data tracking, correspondences, and requests, final quantity reports and data transfer with project Ground Modeler
- Survey Control survey control files and for project
- **Downloaded Field Data** CSV and JXL (legal record) files downloaded from survey controller. CSV files are used to create task specific input files for transfer to task specific TBC projects and folders
- **Geomatics Design** TBC project for consumption of AutoCAD drawings provided with the in Construction Survey Data Package
- Horizon and Remeasure Folders for data, TBC projects and quantity calculations for FSOG, STRP, TYPED, TYPEA and SUBEX horizon and remeasure tasks
- **Surveyed Quantities** Folders for data, TBC projects and spot/linear/area quantity calculations for surveyed constructed features
- Layout TBC Projects for managing and creating construction layout data

One of the most challenging aspects of construction supervision surveyor workflows is data organization, especially given the number of tasks Construction Surveyors are responsible for. Trimble Business Center

version 5.6 introduced the following functionality, which is a cornerstone of Ministry construction supervision survey workflows:


- **Dynamic Project Graphic References** a TBC project (FSOG, for example) can reference another TBC Project (SURVBASE, SURVUTIL, DESIGN etc.) as a graphics overlay, without loading the data and associated standardized components (layers, blocks etc.) into the current project.
- **Dynamic Surface References** a TBC project (TYPEDSTRP, for example) can reference a surface from another TBC Project (FSOG) for volume calculations.

Given the ability to create data references, the TBC folder structure allows for the creation of multiple TBC projects that can be inter-referenced. This is discussed in more detail in section 200.07 TBC Project Management.

The complete folder structure is shown in the following diagram:

## Construction Surveyor Folder Structure





Details of these folders are discussed in the following sections.

### 200.01.01 Construction Survey Data Package

The (5.1) ConstructionSurveyDataPackage folder is where contents of the Construction Survey Data Package are copied.

The Ground Modeler performs QA on the construction tender data package and then creates layout RXL data files, grade sheets from Civil 3D corridor models and sample lines for the construction supervision surveyor. Corridor LandXML files can also be provided upon request by the Construction Surveyor.

This folder has the following subfolders to accommodate project submissions.

- (5.1.1) IFT Issued for Tender
- (5.1.2) IFC Issued for Construction
- (5.1.3) DesignAddendum Design Addendums.

The Construction Survey Data Package consists of the following sub-folders, which are located under the folders noted above.

(5.1.1.1)TenderDrawingsPDF

Vector PDF of drawings in production drawing set.

(5.1.1.2) 100SeriesPlanPDFDWG

AutoCAD drawing files (no Civil 3D) showing complete drawing production models of geomatics and design data complete with all engineering annotations.

(5.1.1.3) SurveyControlXML

LandXML file containing survey control data created by Geomatics surveyors.

(5.1.1.4) ExistingSurfacesXML

LandXML files containing surface models for pre-engineering Geomatics surfaces.

(5.1.1.5) AlignmentsProfilesXML

LandXML files containing control centreline alignment and profile data.

(5.1.1.6) ProposedSurfacesXML

LandXML files containing proposed surfaces including datum, subgrade, granular surfaces and top.

(5.1.1.7) ProposedGravityPressureNewtorksXML

Proposed gravity networks and pressure networks representative of underground utilities and culverts are provided in XML format and can be imported into Trimble Business Center.

(5.1.1.8) EarthworksReportsXLSX

Earthworks reports for each control alignment in Microsoft Excel format.

(5.1.1.9) LayoutDataRXL

Layout RXL files created from Civil 3D corridors.

(5.1.1.10) SlopeStakeReportsandCorridorXML

Slope stake reports are hardcopy reports created from sample lines with corridor section data attached, and indicate offsets, elevations, slopes and codes for the corridor subgrade (datum).

The Ground Modeler will create/update the CSDP at IFC and with any design revisions. The construction supervision Ground Modeler is notified of these changes by the Ministry Representative.

#### 200.01.02 Records and Correspondence

The *O2*) *RecordsandCorrespondence* folder contains files reflecting all records and correspondences relating to construction survey activity. The following are the subfolders:

01) Correspondence

Outlook MSG (dragged and dropped from Outlook) and other documents supporting correspondences between the Construction Surveyor, Ministry Representative, contractor, and other parties.

02) RecordsandTracking

Microsoft Excel XLSX workbooks and other documents used to track survey and other construction supervision data.

03) Final Quantity Reports

Final reports for removal, excavation and spot, linear and area quantities.

04) GMDataTransfer

01) Sent and 02) Received folders for data transfer to and from the project Ground Modeler.

#### 200.01.03 Survey Control

The *03) SurveyControl* folder contains TBC project, data and other records relating to primary (and other) survey control, which has been establish by Ministry Geomatics. The project survey control file is delivered as part of the construction survey data package.

#### 200.01.04 Downloaded Field Data

The 04)DownloadedFieldData folder contains the 01) CSVDownload folder for the original, unedited CSV files downloaded from the controller, the 02) JXLLegalDownload folder contains the raw JXL file for each of the corresponding CSV files and the 03) DataCollectorBackup folder can be used to store backups for data on the controllers.


CSV files are used to export task-based CSV files for transfer and use in task-based folders in 06) *HorizonRemeasure*, 07) *QuantitiesSpotLinearArea* and 08) *LayoutData*.

#### 200.01.05 Geomatics Design

The 05) GeomaticsDesign folder contains the TBC project used for modeling geomatics and design data. The DWG files provided in 01) ConstructionSurveyDataPackage \ 02) 100SeriesPlanPDF DWG are imported to GeomaticsDesign TBC project. Specific geomatics and design data can be extracted from this project and used in various calculations.

#### 200.01.06 Horizon and Remeasure


The *06) HorizonRemeasure* folder contains task specific subfolders for material horizon and remeasure surfaces and volume calculations. Subfolders are used for materials such as FSOG, STRPTYPED, TYPEA, and are where the TBC Project VCE file is saved.



Subfolders for each of the task folders are used to organize unprocessed data, processed data, quantity calculations and superseded TBC projects. Surveyors can create their own task subfolders for other horizon and remeasure tasks, provided the same subfolder structure is used. Folders under \06)HorizonRemeasure that are not required for the project can be removed.

By default, TBC creates a project subfolder which is used mostly for copying imported data files. The standard folder structure contains folders for both unprocessed and processed data, leaving it up to the Construction Surveyor to manage import files and move imported data from the unprocessed data folder to the processed data folder.

To ensure TBC does not create project subfolders, from TBC go to File  $\rightarrow$  Options  $\rightarrow$  General  $\rightarrow$  Project Management and ensure Use project subfolders is toggled off, prior to creating your TBC project.



After the project has been created, you can specify the *Download and input folder* from the *Project Management* options.

Task based CSV files created from files in 04) Downloaded Field Data are copied to 06 HorizonRemeasure 01) Unprocessed Data folder. Once data has been imported to TBC the file is then moved to the 06 HorizonRemeasure 01) Processed Data folder.

## 200.01.07 Spot, Linear and Area Surveyed Quantities

The 07) QuantitiesSpotLinearArea folder contains task specific subfolders for various types of constructed quantities. Folder structure is similar to folders in 06) HorizonRemeasure and are used for items such as drainage, fences and barriers, or all surveyed quantities. The TBC project VCE file is stored in the task specific root folder.

## 200.01.08 Layout Data

The *08) LayoutData* folder contains TBC project and subfolders for creating and organizing corridor layout data.

## 200.02 Construction Survey Codes

Consistency in the use of survey codes is of paramount importance for all construction survey related tasks. Survey codes are important as they are used for the following:

- Identify points as either spot or linework features
- Place point and line on specific layers, which are part of predefined layer groups
- Identify points and lines for surface inclusion

Available survey codes include those used by Ministry Geomatics surveyors, in addition to several codes specific to construction supervision tasks.

Construction survey codes are applicable to the following tasks:


- Establishing secondary survey control
- Construction original ground surveys
- Horizon and remeasure surveys
- Spot, linear and area construction quantity surveys
- Quality assurance on construction layout activity

For the Construction Surveyor, the survey codes manifest themselves in the Trimble Business Center Feature Definition File (FXL). The FXL file is loaded to survey controllers in addition to all Trimble Business Center projects required to complete survey tasks.

The complete list of survey codes can be found in Appendix A of this document.

## 200.03 Survey Linework Creation

The Trimble Business Center Feature Definition (FXL) file, which is loaded into a TBC project, automatically distinguishes between point feature and line feature definitions. This is most evident when you view survey point names and codes using the Feature Definition Manager.



Line feature parameters in the Feature Definition File are shown in the following illustration:

Note the survey Code, Feature (linestring) layer, Point layer and the DTM attribute for a line feature definition.

Line features are automatically connected based on alphanumeric point ID sort order encountered in the survey data file. Surveyors should strive to collect all linework consecutively along the line to properly create the linestring in TBC.

After importing a point file to TBC, use the Survey  $\rightarrow$  Process Feature Codes command to process survey codes from that file against the Feature Definition (FXL) File. The Process Feature Codes command will generate the linestrings and place them on the layer specified in the Feature Definition File.

## 200.04 Data Collector Downloads

Data collector files downloaded from the controller, for consumption by TBC, are CSV (comma separated value) files consisting of Point ID (Name), Northing, Easting, Elevation and Code (Description) for each observation. It is important from both a quality control and auditing perspective to be able to revert back to the original, unedited file.

For this reason, all CSV files are to be downloaded to the...

\<ProjectName>\05) Survey\04) DownloadedFieldData\01) CSV Download

...task specific folder. The task specific folder is user defined. A few examples are as follows:

- FSOG (Field Survey Original Ground)
- TYPEDSTRP (TYPED and Stripping)

BC Ministry of Transportation and Infrastructure

- TYPEA (TYPEA)
- Layout (Layout Data)
- Quantities

Construction surveyors are also required to download the corresponding JXL file, for each of the CSV files to the following folder

\<ProjectName>\05) Survey\04) DownloadedFieldData\02) JXL Legal Download

The raw data is original record of data that has not been processed for use and is required for the following reasons:

- 1. Serves as the legal record of what the instruments observed, whereas coordinates and elevations are derived from the raw data.
- 2. RAW data can be used to rederive the coordinates and elevations, in the event that total station and GPS setup parameters were entered incorrectly.

Survey best practices warrant backups using RAW data.

A Trimble JXL file is a "raw" data file that stores the actual instrument measurements. In the case of a total station information stored consists of height of instrument, height of rod, horizontal angle, vertical angles and slope distances. For GPS the raw data file is the JOB file.

## 200.05 Naming Standards

Consistency with naming standards is of the utmost importance for workflow audits and for data sharing and handoff. This section addresses naming standards for folders, data files, points, TBC projects, surfaces and XML files for data transfer. All naming conventions require some level of intuition, in order that others who may not have worked on the project, understand the nature of the object being described.

The date is a very important component for all naming standards and should generally be the prefix for the object name. This allows for sorting and facilitates the identification of chronological activities on a project.

#### Project Folders

Project folders are named using numeric prefixes to sort based on the chronology of construction supervision events. The naming standards for project folders has been established as part of the standardized folder structure. If new folders are required, use a numeric prefix for folder sorting, and assign a representative name to the folder.

#### Survey Point Files and DXF

Survey point and DXF files are to be named using the following convention:

YYMMDD-PROJDESC-PROJ#-TASK-INIT.txt

#### YYMMDD-PROJDESC-PROJ#-TASK-INIT.dxf

Using the date as a prefix enables chronological sorting in both Windows Explorer and TBC.

*PROJDESC* is an abbreviated description of the project, refer to the following examples:

- *HWY1Glover* Highway 1 and Glover Road Interchange
- *HWY9932* Highway 99 and 32<sup>nd</sup> Avenue Interchange
- *HWY1FordTapp* Highway 1, Ford to Tappen
- *NSTP* North Surrey Truck Parking Lot

BC Ministry of Transportation and Infrastructure

#### *PROJ# is the project number.*

TASK represents the predominant type of data in the survey data file, refer to the following examples:

- FSOG Field Survey Original Ground
- TYPEDH TYPED Horizon
- TYPEDR TYPED Remeasure
- TYPEAH TYPEA Horizon
- L100STK L100 Stakeout

*INIT* represents the surveyor initials.

Surveyors can apply an additional suffix to the file name, after the *INIT* field, to further describe the contents of the file (location, for example).

#### Point ID's / Names

With the exception of survey control (refer to section 5.04.01), all point IDs are to use the following format:

• YYMMDDINIT####

#### represents an ascending 4-digit number (0001, 0010, 0100, 1000 etc.).

#### Feature Codes (Point Descriptions)

Point descriptions are based on the Ministry's FXL file and are summarized in the Appendices of this document.

Point feature definitions must match the code exactly (no alpha or numeric suffixes within the code unless they are separated from the feature code with a space). If additional information is required to describe the point, use the Description 1 or Description 2 fields to further describe the points. Point attributes, although enabled in the FXL, are currently not being supported.

Line feature definitions must incorporate a unique numeric suffix to distinguish between different lines for the same type of feature (ZD1 and ZD2, KA1 and KA2, for example). All line feature points with the same codes will be connected to create a linestring upon execution of the Process Feature Codes command.

#### Surface Names

Surfaces in TBC are to be named using the following format:

YYMMDD-PROJDESC-PROJ#-TYPE

Some examples for *TYPE* are as follows:

- FSOG Field Survey Original Ground
- TYPEDH TYPED Horizon
- TYPEDR TYPED Remeasure
- TYPEAH TYPEA Horizon
- TYPEAH TYPEA Remeasure
- SUBEXH SUBEX Horizon

*PROJDESC* represent the project name and helps clarify the data upon handoff to GMG. The *YYMMDD* represents the date for the last operation on the surface. Since remeasure surfaces are generally calculated monthly the date represents the date that the remeasure surface was created. Horizon surface, on the other hand, may evolve throughout the course of a construction project. The date for the horizon surface, therefore, should reflect the date of the most recent operation (data addition) on the surface.

*PROJ#* represents the project number.

This is especially important for horizon surface handoff to the project Ground Modeler.

#### XML Surface Transfer Files

XML files containing horizon surfaces transferred from the Construction Surveyor to the Ground Modeler shall have the same name as the surface name.

#### Isopach (Volume) Surfaces

To prevent overwriting, isopach surface are to be renamed using the following convention:

• YYMM-V-Material-Desc

The *DESC* field further describes the material being calculated, and would typically relate to a Schedule 7 pay item. An example is as follows:

• 2207-V-TYPED-Offsite (offsite disposal of TYPED)

#### TBC Projects

TBC Projects are to be named using the following convention:

PROJDESC-PROJ#-TASK

*PROJDESC* is an abbreviated description of the project. *PROJ#* is the project number. Examples of *TASK* are Geomatics, Design, Control, FSOG, TYPED and QUANT (spot, linear and area quantities)

## 200.06 TBC Standards for Construction Survey Workflows

Standardized components for Trimble Business Center include the following:

- Feature Definition FXL Files
- TBC Project Templates
- Drafting Templates for Plan Production (Plan, Profile and Cross Section)

These standardized components are discussed in the following sections:

#### 200.06.01 Feature Definition FXL File

The feature definition file is an FXL file that is optionally loaded into a TBC project, and is used for the following:

- The master survey feature code list for all surveyed features
- Distinguish between point and line features
- Specifies a *name* for the feature (point and line)
- Assigns the point to a *layer*
- Assigns the linestring to a *layer* for line features
- Assigns the *Include in surface* property for points and linestrings
- Inserts a symbol for point features
- Allows for the use of attributes (not currently implemented)

The following image shows an example of a point feature in the Feature Definition Manager:

- 21 Const General

Categories 00 through 12 are used by Ministry Geomatics Department for pre-engineering survey data collection activities and can be used by Construction Surveyors for COG (Construction Original Ground) and spot/linear/area quantification survey tasks only. Categories 20 and 21 are used exclusively for construction supervision.

To set the path for the Feature Definition File use Project Settings  $\rightarrow$  Feature Code Processing  $\rightarrow$  Feature definition file, as shown in the following diagram:

It is recommended that the Feature Definition FXL file is copied to the same folder as the TBC project templates (next section).

- *HorizonRemeasureV#* Horizon and Remeasure Surfaces and Volumes
- *SpotLinearAreaQuantitiesV#* Surveyed Spot, Linear and Area Quantities

The "V#" in the template name suffix represents the template version.

In Trimble Business Center set the path for TBC Project Templates using File  $\rightarrow$  Options  $\rightarrow$  General  $\rightarrow$  File Locations  $\rightarrow$  Project templates folder, as shown in the following diagram:

The default path for TBC project templates is as follows:

C:\Users\UserName\AppData\Roaming\Trimble\Trimble Business Center\38.0\

The last folder represents the TBC version, for example 38.0 is the folder for TBC V5.81. For TBC V5.33 the folder is 33.0. For TBC version 2023.11 the folder is 40.0.

The standardized components of these templates, along with workflow details are discussed in sections sections <u>600</u>, <u>700</u>, <u>800</u>, and <u>900</u>.

#### **TBC Project Coordinate Zones**

TBC Project Coordinates do not include coordinate zone settings. Provided that CSV files exported from controllers are reduced coordinates the assignment of a coordinate zone in TBC is not required. The assignment of a TBC coordinate zone is only required under the following circumstances:

- 1. When importing raw JXL (ascii) or JOB (binary) files to TBC containing instrument observation data
- 2. To enable Google Earth mapping in TBC using the Toggle Background Maps command on the task bar.

All construction supervision workflows, with the exception of primary control checks and secondary control development requires the use of reduced CSV for data imports. Control surveys require working with JXL or JOB raw data files from Trimble Access.

Ministry projects are using the following horizontal and vertical datums:


Horizontal: UTM NAD83 CSRS 2002.0 epoch (1997.0 for Vancouver Island) Vertical: CGVD28 using the HT2.0 Geoid (HTMVBC00 for Metro Vancouver, Abbotsford, and east to Hope)

The UTM zones in British Columbia are shown in the following illustration:




Alternatively, Google Earth can be used to identify the UTM zone for the project. From Google Earth:

- 1. Tools  $\rightarrow$  Options  $\rightarrow$  3D View tab
- 2. For show Lat/Long, click Universal Transverse Mercator



#### 3. Click OK

The UTM zone is displayed in the graphics area, and also on the Google Earth taskbar at the bottom of the screen, based on the position of the cursor.



To establish the coordinate zone for the TBC project, use Project Settings  $\rightarrow$  Coordinate System  $\rightarrow$  Change and then...

- 1. Select Coordinate System and Zone button, For Coordinate System Group choose World wide/UTM and for Zone, choose Zone # (North), click Next.
- 2. For Select Horizontal Datum, select NAD 1983 (Canada), click Next.
- 3. For Select Geoid Model, click Predefined geoid model, select Canada Geoid Model HT2\_0 and for Geoid model quality, select Survey Quality and click Finish.
- 4. Click Coordinate System → Local Site, and click Local Site Settings button, and click Yes to save the project settings.

- 5. In the Local Site Settings palette:
  - a. For Coordinate type, select Grid.
  - b. For Easting and Northing, enter the Grid (UTM) Easting and Grid (UTM) Northing values of the tack point, indicated in the survey control table in the drawing set.
  - c. For Elevation, enter the elevation of the tack point.
  - d. Toggle Use ground coordinates on.
  - e. For Ground scale factor enter the inverse (ground to grid) ACSF (average combined scale factor) from the control table in the drawing set.
  - f. For False northing offset, enter 5000000 and click OK to finish coordinate zone setup.

To enable background maps, click the Toggle Background Map button on the TBC taskbar.



## 200.06.03 Drafting Templates

Drafting templates are external VCL files that can be imported to a TBC project for the purpose of plan, profile and cross section sheet production using Ministry title blocks.

The default path for drafting templates is as follows:

*C*:\*ProgramData*\*Trimble*\*DraftingTemplates* 

The Ministry Field Services drafting template for Trimble business center consists of the following files:

- BCPlanSetsV#.vcl (V# is the version number)
- BCMoTILogo.jpg

The plan set VCL file needs to be copied to the folder indicated above, and the JPG logo file is copied to the TBC project template folder.

#### 200.06.04 Text Styles and Alignment Labels

Text styles and alignment label styles are preconfigured in the TBC project templates.

## 200.07 TBC Project Management

The creation and management of multiple Trimble Business Center projects for a construction project is extremely important, especially for larger projects. The creation, assembly and extent of Trimble Business Center projects is largely dictated by the number of tasks that will be undertaken by Construction Surveyors and the size of the project.

Trimble Business Center V5.6 introduced very useful functionality that allows for sharing of graphical and surface data among different TBC projects, which makes it easier to create separate task based projects that can share and leverage data from other projects.

Some examples of TBC projects include the following:

#### **Construction Supervision Survey Guide**

- 1) Geomatics survey data consumption, graphics only (from Construction Survey Data Package)
  - a) <*ProjectName>SURVBASE* (Geomatics base plan with linework and symbols)
  - b) <*ProjectName>SURVUTIL* (Geomatics survey utility drawing)
  - c) <*ProjectName>SURVPROP* (Geomatics property data)
- 2) Design data consumption, graphics only (from Construction Survey Data Package)
   a) <*ProjectName>DESIGN* (100 series model space data, no sheets)
- 3) Construction original ground modeling
  - a) *<ProjectName>COG* (for surface modeling and removal item quantification)
- 4) TYPED horizon and remeasure
  - a) <*ProjectName>TYPED* (for TYPED horizon surface, TYPED remeasure surface, STRP stripping and TYPED excavation quantities)
- 5) TYPEA horizon and remeasure
  - a) *<ProjectName>TYPEA* (for TYPEA horizon surface, TYPEA remeasure surface and TYPEA excavation quantities)

The next section describes TBC functionality that enables data sharing among projects.

## 200.07.01 Project Graphics and Reference surfaces

This section discusses project data sharing functionality which became available in Trimble Business Center V5.6. Data sharing functionality among TBC projects exists for the following:

- Load graphics from another project (for example working in COG project the surveyor may wish to see graphics representing the proposed design.
- Load a surface from another project (for example working in TYPED project load the COG surface from COG project for STRP stripping volume calculation.

The benefit of working with references is as follows:

- Entities and associated layers are not loaded into current project as they are references
- Updates are dynamic. For example if COG surface changes this is reloaded in TYPED project and volume (isopach) surfaces automatically update

TBC references are discussed in the following sections:



#### **Reference surfaces**


Reference surfaces should only be used to calculate earthworks volumes.

To create a reference surface...

Surfaces (ribbon tab)  $\rightarrow$  Create (panel)  $\rightarrow$  Reference Surface (command)

Browse to and select the VCE project first, select the surface from the drop down list and then assign a name to the reference surface. It is best to use the exact same name as the surface in the reference file.

The VCE file containing the reference surface is displayed in Project Explorer under the Reference Files collection, with the same settings as graphic references available in Properties. The VCE file containing the reference surface is also visible under the Reference Files collection in View Filter Manager. In addition to this, reference surfaces are displayed under the Surfaces collection in Project Explorer as follows:



Reference surfaces are also displayed under the Surface collection in View Filter Manager and are dynamic, meaning that if the source data changes, the reference can be updated.

#### 200.07.02 TBC Project Folders

When a TBC project is created the default settings result in the creation of the following:

- The TBC project VCE file
- A folder with the same name as the TBC project

The project folder that TBC creates stores copies of imported files. For example, if a CSV point file is imported to TBC from a thumb drive, than that file is copied to the TBC project folder.

Ministry FS workflows are such that the Construction Surveyor is responsible for managing the location of data to be imported to TBC. A summary of these requirements as it relates to the standardized project folder structure, is as follows:

1. Unedited CSV survey data files copied to the following location:

\05) Survey\04) Downloaded Field Data\01) CSV Download\01) CSV Task

2. Unedited JXL raw data file, for each corresponding CSV file, copied to the following location:

\05) Survey\04) Downloaded Field Data\01) JXL Download\01) CSV Task

The JXL file represents the "legal" file which will stand up in a court of law, and from which coordinates can be rederived, if necessary.

3. CSV files, from item 1 above, are *copied* to the following location:

\05) Survey\06) Horizon Remeasure\01) COG\01) Unprocessed Data, and then moved to...

\05) Survey\06) Horizon Remeasure\01) COG\01) Processed Data, once imported to TBC

The 01) COG folder above, could be the location of any TBC project.

For this reason, use...

...to disable *Project subfolders* and disable *Copy imported files to import folder*, as shown in the following illustration:

The Use project subfolders toggle can only be disabled when there is no active TBC project.

## **300** General Survey Requirements

This section discusses general survey requirements. These are expounded in the task specific sections of this document.

## **300.01** Spot and Linear Feature Codes

All survey codes must conform to the Ministry's Feature Definition (FXL) file, with no exceptions. The FXL file clearly distinguishes between spot feature and linework feature codes (section 200.06.01). The use of standardized survey codes ensures the following:

- Generation of a spot or linear feature
- Insertion of a spot feature symbol
- Assignment of points and linestrings to the correct layer (and TBC layer group)
- Assignment of the Include in surface property (Yes or No) for both points and linestrings

Codes for spot features must not include any suffixes or prefixes to further describe the feature. Surveyors can use the *Description 1* and / or *Description 2* point properties to record additional information relating to the point (diameter and material, for example).

Linework codes must incorporate a unique numeric suffix (no space between the code and the number) to ensure that unique linestrings are generated in Trimble Business Center. For example, left pavement and right pavement edges are coded as EP1 and EP2 respectively so that linestrings that connect the left and right sides are not generated.

## **300.02** Survey Point Accuracy

The following topographic point accuracies have been reproduced from the Ministry's Geomatics General Survey Guide.

## **300.03** Point and Linestring Point Density / Spacing


The horizontal and vertical nature of the terrain dictates most of the point spacing and TBC linestring requirements to produce accurate ground models for volume calculations.

The following sections discuss linestrings and surfaces, and address survey point density and spacing as they relate to surface modeling.


## **300.03.01** Linestrings and Surfaces

It is important to understand the nature of a TIN (Triangulated Irregular Network) model in TBC, and how linestring data affects surface triangulation. If a profile or a cross section is created from a surface, the data points for the profile or section are acquired where the alignment, or section line intersects a TIN line, and at the end points of the alignment or section line.

In the following illustration, the centreline linestring is included in the surface, as a *breakline*, and the triangulation is therefore forced along the breakline. The green arrows indicate the location of the data points for the cross section. Note that a data point has been interpolated between two consecutive shots along the centreline linestring.



If the centerline linestring is removed there is no longer a triangulation line connecting the centerline points, which means that the section data will omit the road crown. This is shown in the following illustration:



Therefore, when creating linestrings from feature codes in the FXL file with *Include in surface* property set to *Yes*, ensure that the linestrings represent distinct terrain breaks.

Linestrings created from feature codes in the FXL file with the *Include in surface* property set to *Yes* are used as TIN *breaklines* when they are added as surface members. A breakline is a distinct terrain break and triangulation lines are always forced along the breakline to properly define the surface.

Examples of features that are breaklines are as follows:

- Road crowns, pavement edges, curb lines, sidewalk edges, shoulder lines
- Tops and bottoms of banks
- Ditch tops and bottoms
- Tops and bottoms of retaining walls

The Construction Surveyor should make every effort to ensure linestrings do not overlap one another, as a TIN cannot model 2 elevations at the same location.

Finally, horizon and remeasure surfaces can be coded using spot elevation codes (J\* and Y\* for remeasure and horizon surfaces respectively) or linestring codes (K\* and Z\* for remeasure and horizon surfaces respectively), all of which have the Include in surface property set to Yes (from the FXL). When surveying horizon and remeasure surfaces, use linestrings in the following circumstances:

- To represent distinct terrain breaks, so that triangulation lines follow the break
- To represent a soft terrain break such as the bottom of a drainage swale to prevent triangulation from crossing across the bottom of the swale from the adjacent swale tops

The Construction Surveyor should use their best judgement when surveying linestrings on horizon and remeasure surfaces, as there is not necessarily a distinct "feature" (pavement edge, bottom of bank etc.) to be followed.

#### **300.03.02** Point Spacing / Density

The point densities discussed here must be used as a minimum standard, unless specific contract requirements, special provisions, or a mutual agreement between the Ministry representative and the consultant/contractor state otherwise.


#### **Construction Supervision Survey Guide**

Some guidelines for point spacing are summarized in the following bullets:


- Point spacing shall be agreed upon by the Ministry Representative.
- Point spacing shall not exceed 10m for both linework and point features
- Point spacing may be less than 5m in areas where drainage or quantities are a concern
- Steep terrain: 5-20m
- Undulating/natural terrain: 5-20m
- Rock: 5-10m
- Intersections, curb returns, traffic islands: 1-5m
- Curb and gutter, small radius curves, ditches, and water courses: 5-10m

The Construction Surveyor must consider point spacing in the context of both surface modeling and accurately measuring surveyed items for payment quantities. Finally, and, whenever possible point data should be collected in cross section format along an alignment or a feature to create a good surface model to ensure linestrings do no overlap.

The following image represents a poor example of point spacing / density, as it results in linestrings that overlap one another.



Collecting points in a cross section, or in the case of the following image, radial to the returns, will result in linestrings that do not cross over each other.



While linestrings can be edited in Trimble Business Center, the Construction Surveyor should make every effort to employ sound field procedures to minimize editing in the office.

## **300.04** Working with the Ground Modeler

The Ground Modeler assumes the following construction supervision responsibilities, as they relate to the activity of the Construction Surveyor:

- Preparation of the construction survey data package.
- Rerun design corridor models against construction horizons.

If the Construction Survey Data Package is incomplete or requires clarification or refinements, the Construction Surveyor should contact the project Ground Modeler and request updates as required.

Corridor models prepared by designers are processed against surveyed (total station, GPS and LiDAR) original ground horizons, assumed stripping horizons and assumed TYPEA horizons.

The FSOG horizon used by designers may change in LiDAR surveyed areas, as LiDAR data is collected in areas where tree removal and clearing and grubbing is required. In these circumstances, the Ministry Representative will elect to survey these areas and recreate the original ground surface by aggregating Geomatics SOG (Surveyed Original Ground) data with FSOG (Field Survey Original Ground) survey data to form an actual Field Survey Original Ground horizon. This FSOG horizon (either complete or representative of a project milestone) is handed off to the Ground Modeler via an XML file, which is exported from Trimble Business Center. The name of the XML file is to be the same as the surface name as it exists in TBC, with the date in the surface name prefix representative of the current date.

# 400 Geomatics and Design Data Consumption

This section discusses the consumption of the project geomatics (survey) and design data by the Construction Surveyor.

The primary deliverable to the Construction Surveyor is the Construction Survey Data Package (CSDP), which is prepared by the project's Ground Modeler. For more information on the contents please refer to section <u>100.11 Construction Survey Data Package (CSDP)</u>. The construction survey data package is copied to the standardized folder structure, which is shown in section <u>200.01 Construction Survey Folders and Data Organization</u>.

AutoCAD DWG data in \02) 100SeriesPlanPDFDWG\ folder, at a minimum, should consist of the following:

- Design Data AutoCAD entities created from model space (no sheet layouts) of the 100 series production drawing
- Geomatics VSOG Data AutoCAD entities created from the SURVBASE-VSOG (Surveyed Original Ground) drawing
- Underground Utilities AutoCAD entities created from STSNWM (Storm, Sanitary and Watermain) design model drawings

If any other data is required for TBC consumption, the Construction Surveyor should contact the project Ground Modeler so they can provide the necessary files.

## **400.01 TBC Project Creation** – **Design Data Consumption**

TBC projects for design data consumption are created using the following TBC project template:

BCMoTI-1Geomatics and Design-R#.vct (where # is the version of the project template)

After creating the project, save the project using the following name:

PROJDESC represents an abbreviated description of the project.

PROJ# is the project number.



- HWY1Glover-COG (Highway 1 / Glover Road Combined Original Ground, from Geomatics)

- HWY1FordTappen-DRAINAGE (Highway 1 Ford to Tappen, drainage design)

Once the project has been created, the DWGs from the CSDP can be added and then viewed using the layers and layer groups defined in the project template.

## 500 Survey Control

The most important survey aspect for construction projects are the survey controls. Control surveys provide horizontal and vertical positions of points from which additional surveys are based on, and provide the standard of accuracy for subsequent surveys to attain. Survey control is the foundation for all surveying as all field observations and measurements are based on having proper survey control in place.

Survey control applicable to Ministry geomatics, design and construction supervision workflows consists of both primary and secondary control. Primary and secondary control are established from higher order corridor and origin control points, with the origin control point being the highest order coordinate from which corridor control networks are built.

Ministry surveyors should refer to the Ministry's <u>Geomatics General Survey Guide</u> for more information and best practices as they relate to survey control, and other related survey tasks.

Primary and secondary control points, as they relate to construction supervision activity, are discussed in the following sections.

## 500.01 Primary Control Points

Primary, or project control points are the highest standard of control reference for the project, and are set outside the construction site away from potential construction disturbance (machines, and vibration).

Project specific primary control points are established by Ministry Geomatics surveyors before detailed design begins and remain in place throughout the duration of the project. They are usually a metal bar that is marked with adjacent wooden stakes. Primary control point data is provided to the Construction Surveyor in an XML file as part of the Construction Survey Data Package (CSDP).

Details of the primary control points (along with the corridor and origin control points) are provided in the construction drawing set in a table, as per the following image:

In this example the primary control points are indicated with the "Project" Class and include local and grid (UTM) coordinates along with a combined scale factor. Grid to ground coordinate (and vice versa) transformations are all based on applying the scale factor at the tack point location, which can be determined by the Point ID (TACK-12, in the table above).

Although not always required, a check of the primary control may be warranted:

- When primary control stakes / markers appear to have been disturbed
- The surveyor wants assurance that equipment and procedures are functioning properly
- As a Quality Assurance practice

If primary control points have been disturbed, Construction Surveyors are required to contact Ministry Geomatics, provided that they are able to properly demonstrate with observations and calculations, the nature of the issue.

## 500.02 Secondary Control

Secondary control is a lower order of control point established from primary control and does not require the same level of accuracy as primary control but should be treated with the same degree of importance as primary control. Secondary control points are established in the immediate project area and are the main reference points that will be used for construction survey activity for original ground surveys, horizon and remeasure surveys, spot/linear/area quantity surveys and construction layout surveys.

Construction surveyors are responsible for establishing secondary control for the project, taking the following points into consideration:

- Establish by traverse with a total station instrument, or by GNSS RTK (Global Navigation Satellite System RTK Real Time Kinematic) processing, and always closing to primary control
- Intervisible (viewable from eachother)
- Referenced by a stake with pink and blue flagging or if on pavement, with paint marking and offset stake with pink and blue flagging
- Point descriptions

Details of secondary control including point ID's, ground based coordinates, elevations and point descriptions are to be recorded and provided to the Ministry Representative.

## 500.03 Primary and Secondary Survey Control Tolerances

The required tolerances for Primary and Secondary Control are summarized in the following table:

### 500.04 Secondary Survey Control Point Names and Point Codes

This section discusses secondary control point names, which are the alphanumeric point ID, and point descriptions.

#### 500.04.01 Secondary Control Point Names

The point name represents the point ID. All secondary control points must follow a naming convention to indicate how and when the points are set. If a brass cap monument is used with an alphanumeric name, then only a suffix of "-YY" is needed where YY are the last two digits of the year the monument was set. E.g. Tonka-15. For control points using tags or a simple numeric identifier, a prefix and suffix are required. E.g. G4321-18.

Prefixes:

- G GPS Primary (Static)
- K GPS Secondary (RTK)
- T Total Station Primary (Closed and adjusted control loop)
- S Total Station Secondary (Side shot)

#### 500.04.02 Secondary Control Point Codes

Codes for secondary control must match available descriptions in the Ministry TBC Feature Definition FXL file. Allowable codes for secondary control are summarized in the following table:

#### 500.05 Detail Hubs

Detail hubs are not part of the primary and secondary control network, and will be considered as third order with accuracies as follows:

- 1:6900 or 1 part per six thousand-nine hundred for horizontal accuracy
- 0.024 times the square root of the distance in kilometres for vertical accuracy

Detail hubs must satisfy the survey accuracies documented in:

- Section 3.06.03 of the General Survey Guide for topographic original ground surveys
- Section <u>1100.04.01 Slope Staking Requirements</u> in this document
- Section 201.47 of the Ministry Standard Specifications (Finishing of Roadway)

If detail hubs are intended for continued use, care must be taken to tie these detail hubs back into the primary or secondary control network.

### 500.06 Quality Control

- All previous survey information conforming to the "General Survey Guide" will be available on request through the design coordinator
- Control must be checked at beginning of a project. Random checks will be done by closed traverse or static GPS and will include a minimum of 4 secondary and/or primary control points. Additional checks may be required by the Ministry representative (be aware of age of prior surveys when checking or re-establishing control points, prior to construction project commencement).
- Quality of control point elevations
- Minimum horizontal requirement for an optical instrument closed loop traverse is 1:10,000
- Minimum vertical requirement for a closed level loop is 0.008 times the square root of the distance levelled in kilometres.
- Records of control point check surveys will contain all electronic survey files, reports and other relevant survey data showing closures.

The following image shows an example of a check point showing closures:

- If control point checks do not meet accuracy requirements, the Ministry representative may
  consult the designer and seek a resolution to the control problem. The Ministry representative
  must be aware that design and/or quantities review may be required based on changed control
  point locations.
- GPS co-ordinate transformation parameter (i.e. site calibrations, localizations, etc.) reports should be included in the design deliverable if GPS has been used (see example below).

# 600 Field Survey Original Ground (FSOG)

The field survey original ground survey and surface is one of the first major tasks undertaken by the Construction Surveyor. The purpose of this task is as follows:

- 1. Create a field survey original ground surface model which forms the basis for earthworks calculations
- 2. Collect featurized data for the calculation of spot, linear and area removal quantities

FSOG survey data must be collected using Ministry standardized point names (ID's) and feature codes (description). The feature codes are available in the Trimble Feature Definition FXL file.

### 600.01 Field Survey Original Ground with Features

There are feature code options to be considered when surveying Field Survey Original Ground. For this section please refer to the latest version of the Ministry's Feature Code Definition FXL file.

Feature codes are organized into categories, as per the following image:

Categories 00 through 12 originate from Geomatics for pre-engineering survey work, and for the most part contain feature codes that represent actual field features – such as pavement edges, fences, manholes and power poles. Categories 20 and 21 have been specifically developed for construction supervision and are used specially for construction supervision measurements for the purpose of quantification.

Featurized Field Survey Original Ground survey data is only required if removal quantity measurements are required. When surveying Field Survey Original Ground the Construction Surveyor should be aware that featurized data was collected as part of the VSOG (Surveyed Original Ground from Geomatics), and that if applicable, removal quantities could be calculated from Geomatics VSOG data. SURVBASE VSOG and SURVBASE COG (Combined Original Ground) ACAD DWG data is made available as part of the Construction Supervision Data Package. Featurized FSOG data can therefore be used to i) calculate removal quantities and ii) be incorporated into the Field Survey Original Ground surface, provided that the *Use in surface* property for the feature code is set to *Yes*.

A retaining wall for example is a "feature" that is part of the Field Survey Original Ground survey and surface model as the *Include in surface* property is set to Yes. This is shown in the following illustration:

The retaining wall is also a feature that requires quantification for removal. A retaining wall observation, therefore, serves 2 purposes. The Construction Surveyor should also be aware that the geomatics survey base data (SURVBASE-VSOG) in the Construction Survey Data Package, could be sourced to quantify items for removal.

Please note that the mechanism for surface inclusion is the *Include in surface* property. The optional DTM property is not used in Trimble Business Center.

## 600.02 Field Survey Original Ground Without Features

If removal quantities are not required from FS Original Ground surveys, care must be taken to ensure the use of the original ground codes in the 20 – Const Horizon Remeasure category, which are as follows:

- YO spot elevation FSOG horizon
- ZO# linestring FSOG horizon (for #, use unique number to distinguish linework)

This is important because when the Process Feature Codes command is used, the FXL will place the points on specific layers, which are recognized by predefined layer groups in the TBC project template. In no circumstances should surveyors use Geomatics codes for original ground surface modeling such as BZ (breakline), SE (spot elevation) and OG (original ground).

## 600.03 Field Survey Original Ground TBC Project Setup

The FSOG TBC project contains only data required for FSOG surface modeling and measurements for construction pay item removals. All other data relating to horizon/remeasure surfaces, new feature pay item quantities, layout data generation and monitoring is imported to separate TBC projects.

Before creating the FSOG project, ensure that the following settings have been disabled in TBC Options:

- Use project subfolders
- Copy imported files to import folder

This is because the onus is on the Construction Surveyor to copy and locate the sourced data files appropriately.

#### **Construction Supervision Survey Guide**

TBC projects for FS Original Ground are to be created using the following TBC project template:

• *BCMoTI-1FSOGVR#.vct* (where # is the version of the project template)

After creating the project, save the project using the following name:

PROJDESC-PROJ#-FSOG.vce

*PROJDESC* is an abbreviated project name, which is used as a prefix for all TBC projects.

*PROJ#* is the project number.





Once the project is created the procedure to copy data files from the controller to the project subfolders, is as follows:

1. Download files from controller to a task specific folder in the \04) DownloadedFieldData \ folder:



These files are to remain untouched and unedited.

- 2. Copy the corresponding JXL (RAW survey data) to a task specific folder under \04) DownloadedFieldData\02) JXLLegalDownload\ folder. These files represent the legal record of survey (instrument observations, as opposed to reduced coordinates).
- 3. Copy the files to \06) HorizonRemeasure\01) COG\01) UnprocessedData\ folder
- 4. Once the files are imported to the COG TBC project, move the files from \01) UnprocessedData to \02) ProcessedData \

Step number 4 is only required if there are several files, and the Construction Surveyor needs to keep track of which files have been imported versus which files still need to be imported. When all is said and done, all files imported to TBC need to reside in \02) ProcessedData.

The final step is to run the Survey  $\rightarrow$  Process Feature Codes command to generate linestrings, assign points and linestrings to the correct layers and identify nonstandard survey codes. Addressing nonstandard codes can be done in TBC or in the source data file. For the latter, reimport the file and run the Process Feature Codes command again.


## 600.04 Field Survey Original Ground FSOG Surface Model

The FS Original Ground surface model is used for calculating STRP (stripping) quantities. Once the FSOG surface is complete, it is then referenced by the TYPEDSTRP project to calculate stripping quantities.

Prior to conducting the FSOG survey, the Construction Supervision Team, under the direction of the Ministry Representative, should consider that the Geomatics surveyors, as part of the design process, have conducted a detailed survey using total station and/or GPS, to create the VSOG (Surveyed Original Ground) surface, and survey base (SURVBASE) drawing. In many projects, the VSOG surface is aggregated with the VLOG (LiDAR Original Ground) surface to create the VCOG (Combined Original Ground) surface. This is summarized in the following bullets:

- VSOG <u>Surveyed</u> Original Ground (collected using GPS and/or Total Station)
- VLOG <u>LiDAR</u> Original Ground (collected mostly using aerial and sometimes terrestrial LiDAR data collection system)
- VCOG <u>Combined</u> Original Ground, which combines the VLOG and VSOG data

An example of VSOG, VLOG and VCOG (Combined Original Ground) data is shown in the following illustration:



The Geomatics VCOG (Combined Original Ground) is created by effectively cutting a hole in the VLOG and replacing the removed VLOG data with VSOG data.

When considering the Construction Original Ground survey, the Construction Surveyor and the Ministry Representative need to be aware of the existence and physical extents of VSOG data, as the VSOG data is the only Geomatics survey data that could be used during construction supervision. Consideration should be given to the following:

- Date of the VSOG survey
- Extent of disturbed areas on the project (clearing and grubbing)
- Due diligence elevation checks on the VSOG

In no circumstances would the VLOG be suitable for reuse during construction supervision. If VSOG data were to be reused, FS Original Ground surveys would be limited to areas of Geomatics LOG coverage that fall within proposed construction limits.

The Geomatics VSOG surface should be imported to the FS Original Ground TBC project for the following reasons:

- To check random observations, in the areas of the VSOG, to validate the use of the VSOG surface
- Potential use of the VSOG surface to eliminate the need for resurveying existing features
- To identify plan limits of VSOG surface so locations for additional ground surveys can be identified

The VSOG surface is available in the following folder:

When importing the VSOG XML file use Triangle-based definition to prevent the addition of unwanted point and breakline data to the TBC project. This is shown in the following illustration:

If the VSOG XML file is not in the CSDP, the surveyor should contact the project Ground Modeler.

Should additional survey work be required for FS Original Ground surface modeling, care must be taken to use line and point feature definitions from the Feature Definition FXL File that have the Include in surface property set to Yes. If FSOG survey data is not required for removal item quantification codes in the 20 – Const Horizon Remeasure category of the Ministry Feature Definition FXL file. If the Construction Surveyor chooses to use the Geomatics VSOG surface, it can be combined with the Construction Original Ground surface using the TBC Surfaces  $\rightarrow$  Combine Surfaces command.

Refer to section 200.05 for naming standards for the FSOG surface.

#### 600.05 FSOG Data Transfer to Ground Modeler

The FSOG surface may be required by the project Ground Modeler, upon request by the Ministry Representatives, for the purpose of rerunning the corridor model. In these circumstances the COG surface is exported to a Land XML file using TBC Home  $\rightarrow$  Export  $\rightarrow$  Construction (tab)  $\rightarrow$  LandXML exporter routine.

The surface name and the XML file name should be the same, using the following format:

YYMMDD-PROJDESC-PROJ#-TYPE

*YYMMDD* = date of last operation on FSOG surface

PROJDESC = abbreviated project description

*PROJ#* = project number

*TYPE* = FSOG

For LandXML export settings, ensure the Surface description is set to 2 - Triangles, as shown in the following illustration:

# 700 Horizon and Remeasure Surveys, Surface Modeling and Volumes


This section describes procedures and standards associated with surveying and modeling horizon and remeasure surfaces and calculating volumes using surface to surface volume calculation method. Surfaces can be backed up by exporting to DXF.

### 700.01 Horizon Surfaces

A *horizon* surface represents the top of a particular material. Examples of horizon surfaces include the following:

- TYPEDH Top of TYPED (earth) material
- TYPEAH Top of TYPEA (rock) material
- SUBEXH Top of SUBEX (subexcavation) material

The following illustration shows examples of the FSOG Horizon surface and the TYPED Horizon surface in cross section format.



The shaded area between the FSOG Horizon and the TYPED Horizon represents the STRP (stripping) quantity, and the dashed lines represent the actual excavation.

Horizon surfaces are used for the following tasks:

- Calculation of material specific excavation volumes for monthly contractor payments
- Corridor are rerun against measured horizon surfaces (actual) by the Ground Modeler so that actual material excavation quantities can be calculated

The Construction Surveyor maintains the active horizon surfaces in a TBC project should be in regular communication with the Ground Modeler to provide horizon surfaces as requested. Horizon surfaces are exported to LandXML files for handoff to the Ground Modeler.

Please refer to section 200.05 for horizon surface naming requirements.

#### 700.01.01 Stripping

Stripping is a quantity and should therefore never be modelled as a horizon surface. The bottom of the stripping material is usually the TYPED horizon, but can sometimes be a TYPEA horizon. A STRPR stripping


remeasure surface is only possible in circumstances where the Ministry Representative determines that additional stripping material needs to be removed after surveying the initial excavation. In this circumstance, after the stripping material was removed, the surveyor would have initially used TYPEDH codes (ZD\* and YD) for the underlying TYPED horizon, or TYPEAH codes (ZA\* and YA) for the underlying TYPEA horizon.

If the Ministry Representative requires further excavation to remove additional stripping material, the original data files should be copied and then edited to change the TYPEDH (or TYPEAH) codes to STRPR stripping remeasure (KS\* and JS) codes. The original TYPEDH (or TYPEAH) data should be removed from the TBC project by deleting the file from the TBC Imported Files collection in Project Explorer, and the new file with the renamed codes is then imported. These changes should be noted in the survey data tracking spreadsheet.

## 700.02 Remeasure Surfaces

A *remeasure* surface represents an excavation within any given material and is measured and modeled by the Construction Surveyor for the purposes of monthly volume calculation to support contractor payment and for Quality Assurance. The remeasure surface is compared against the horizon surface for that material to calculate the monthly excavation volume for that material.

An example of a TYPED Remeasure surface is shown in the following illustration, which assumes just stripping (above TYPED Horizon) and TYPED material is present:



The shaded area between the TYPED horizon and the TYPED remeasure surface represents the TYPED remeasure quantity for that month. Note that the contractor is only compensated for quantities that fall within the corridor datum "neat line".

Remeasure surfaces are not required by the Ground Modeler.

## 700.03 Horizon and Remeasure Feature Codes

Horizon and remeasure feature codes are found in the 20 – Const Horizon Remeasure category of the Ministry Feature Definition FXL File. In no circumstances should codes in categories 01 through 12 be used for horizon and remeasure surveys (other than Field Survey Original Ground FSOG horizon, when feature data is required for removal pay item quantities). Codes in these categories originate from Ministry Geomatics and, for the most part, represent actual field features.

The codes in the 20 – Const Horizon Remeasure category consist of both point (spot elevation) and line codes (horizon and change to) for the following:

- 1. FSOG horizon
- 2. Gravel horizon and remeasure
- 3. STRP (stripping) remeasure only
- 4. TYPED (earth) horizon and remeasure
- 5. TYPEA (rock) horizon and remeasure
- 6. Waste (waste material) horizon and remeasure
- 7. RipRap horizon and remeasure
- 8. SUBEX (subexcavation) horizon and remeasure

Line codes and spot elevation codes use the following conventions:

- 1. Z\* = Horizon Material (Top of native material, prior to excavation)
- 2. K\* = Remeasure Material (Top of material, after excavation)
- 3. X\* = Change to Material (Interface of two materials)
  - a. Linestrings can be copied / exported for use with another surface
- 4. Y\* = Horizon Material Spot Elevation
- 5. J\* = Remeasure Material Spot Elevation

A summary of the horizon and remeasure feature codes, along with the respective TBC layers, is shown in the following illustration:

#### 700.04 TBC Horizon and Remeasure Project Setup

Data sharing capabilities in Trimble Business Center allow for the creation of task-based TBC projects, where the only data residing in a TBC project could relate to a specific task (TYPED and TYPEA project, for example). Creating task-based TBC projects is preferred for the following reasons:

- Reduces the amount of data in each TBC project
- Simplifies data management in each TBC project

Before creating the Horizon and Remeasure project, ensure that the following settings have been disabled in TBC Options:

- Use project subfolders
- Copy imported files to import folder



For example, the *PROJ*-STRPTYPED TBC VCT project files is stored in the \*02*) *STRPTYPED* folder and the *PROJ*-STRPTYPEA TBC VCT project file is stored in the \*03*) *STRPTYPEA* folder. Folders under \*06*) *HorizonRemeasure* that are not required can be removed.

- 2. Copy the corresponding JXL (RAW survey data) to a task specific folder under \04) DownloadedFieldData\02) JXLLegalDownload\ folder. These files represent the legal record of survey (instrument observations, as opposed to reduced coordinates)
- 3. Copy the CSV files to \06) HorizonRemeasure \TASK \01) UnprocessedData \ folder.
- 4. Once the files are imported to the TYPED TBC project, move the files from \01) UnprocessedData to \02) ProcessedData \

Step number 4 is only required if there are several files, and the Construction Surveyor needs to keep track of which files have been imported versus which files still need to be imported. When all is said and done, all files imported to TBC need to reside in  $\langle 02 \rangle$  ProcessedData $\langle$ .

The final step is to run the Survey  $\rightarrow$  Process Feature Codes command to generate linestrings, assign points and linestrings to the correct layers and identify nonstandard survey codes. Addressing nonstandard codes can be done in TBC or in the source data file. For the latter, reimport the file and run the Process Feature Codes command again.

### 700.05 Horizon and Remeasure Surface Modeling

All horizon and remeasure spot elevation and linework field codes have the *Include in surface* parameter toggled on. Use linework codes to generate terrain breaks in the surface model which i) forces triangulation along the break and ii) prevents surface triangulation from being generated across terrain breaks. Use Surfaces  $\rightarrow$  Create  $\rightarrow$  Surface Boundaries and/or Surfaces  $\rightarrow$  Edit  $\rightarrow$  Trim Surface Edge to remove long and inaccurate triangulation lines from the outside limits of the surface. You can also set maximum triangle length in Surface Properties to limit triangulation.

## 700.06 Volume Calculations

The Construction Surveyor is responsible for the calculation and reporting of monthly excavation volumes. Monthly volumes based on field surveys and surfaces are calculated using Surfaces (ribbon tab)  $\rightarrow$  View (panel)  $\rightarrow$  Earthwork Report (command).

All monthly volume calculations are to be calculated against horizon surfaces. The following sections detail some examples.

#### 700.06.01 Stripping Volumes


Stripping volumes are calculated in the TYPEDSTRP project, which references the FSOG surface from the FSOG project. Calculate the stripping volume using the FSOG surface as the Initial surface and the TYPEDH surface as the Final surface.

#### 700.06.02 TYPED Volumes

TYPED volumes are always calculated against the TYPEDH horizon surface. Assuming that there are multiple remeasure surfaces (one for each month), including the final remeasure, and that only TYPED material is present, calculate the TYPED excavation quantity by comparing the TYPEDR remeasure surface against the TYPEDH horizon surface. For remeasure surfaces beyond the first payment period, calculate the remeasure volume against the TYPEDH horizon surface, and subtract TYPED volumes from the prior months excavations to determine the current month volumes.

Volume calculations using the TBC Earthworks report command are calculated using "surface to surface" volume calculation methodology. This means that if daylight (catch) lines to the TYPEDH horizon surface are not included in the TYPEDR surface, then volumes are based on a vertical cut-off to the limits of the TYPEDR remeasure surface.

This is shown in the following illustration:



To eliminate the vertical cut-off for volume calculation, and to provide more accurate volumes, Construction Surveyors can use either of the following methods:

- Include daylight line linestring in TYPEDR surface model
- Use TBC Surfaces (ribbon tab) → Create (panel) → Surface Tie (command) to project a slope from a linestring to a surface (linestring at the outer limits of the TYPEDR surface)

Surface to surface volume calculations are sufficient for monthly quantity calculations and can be reconciled by the projects Ground Modeler by running the corridor model against measured construction horizons.

#### 700.06.03 TYPEA Volumes

TYPEA volume calculations are based on the same general principles for TYPED volume calculations. Surface to surface volumes will generally be more accurate due to the steep slopes (0.5:1, for example) associated with TYPEA excavation. As with TYPED volumes, TYPEA volumes are always calculated between the TYPEAR remeasure surface and the TYPEAH horizon surface. In instances where multiple remeasure surfaces are measured, then the monthly volume is determined by subtracting prior months volumes. Surface closures using surveyed daylight linestrings or TBC surface ties will always yield more accurate results.

#### **700.06.04** Volume Calculation in Trimble Business Center


To calculate a volume between 2 surfaces in TBC use the Surfaces (ribbon tab)  $\rightarrow$  View (panel)  $\rightarrow$  Earthwork Report (command), using the following options:

- Report Type: Surface to surface
- Initial: FSOG or TYPEDH/TYPEAH horizon surface
- Final: TYPED (for stripping) or TYPEDR/TYPEAR remeasure surface
- Boundary: Optional closed linestring for limiting volumes calculation to a specific area
- Volume Breakdown: Volume totals only

After clicking OK the routine will i) create and display an HTML Earthwork Report in your current browser and ii) create an *Isopach* surface in the Cut/Fill Maps collection in Project Explorer.

An isopach surface is a net surface with positive and negative elevations, representing the depth of fill and cut respectively and should only be displayed to verify the planimetric location limits for the volume calculation. The isopach surface should immediately be renamed using the isopach surface naming standards identified in section 200.05.

The following illustration shows a collection of isopach (volume) surfaces in TBC Project Explorer:



The *V* indicates volume, and by leaving the date as a prefix surface data sorting is better in TBC View Filter Manager. This is shown in the following illustration:

Renamed isopach surface provide an excellent record of a specific calculation as properties of the isopach surface include the following:

- Cut and fill volumes and areas
- Minimum and maximum elevations (maximum depths of cut and fill respectively)
- Initial and final surfaces (which can be edited)

Isopach surface are created on Layer 0 by default, can be toggled on and off in the View Filter Manager, and can therefore be incorporated into a View Filter.


#### 700.06.05 TBC Selection Sets, View Filters and Construction Data Management

Trimble Business Center is an excellent application for the management of construction data over the course of a lengthy project. To effectively manage data, Construction Surveyors need to understand the inner workings of both Selection Sets and View Filter Manager.

These are discussed in the following sections.

#### **TBC Selection Sets**


Selection Sets are available on the Selection Explorer palette. A selection set is a collection of common elements that can be "selected" for manipulation. An example of a selection set is a collection of points and linestrings imported to TBC relating to a specific task. All files imported to TBC are displayed in the Selection Explorer. The following image shows how to create a selection set from a collection of imported data files that have been processed against the project FXL file:



A task specific selection set is created for import files for each pay period to facilitate data management and viewing for any given pay period. In this example, the project is a TYPED project so the name of the selection set is indicative of the date only (YYMM) and does not require the task. Selection sets can be incorporated into view filters which makes it easy to view the point data and surfaces for any given pay period. This is addressed in the next section.

#### **TBC View Filters**

View filters area available on the TBC View Filter Manager palette and are used to control the visibility and selectability of different data types and layers in graphic views. For example, a view filter in a TYPED Horizon and Remeasure project, when set current, would display the TYPED layers. This is shown in the following illustration:




View filters make it easy to configure views to display specific data types by simply toggling the display of specific layers on and off.

Layer based view filters can also be combined with selection sets. For example, a surveyor may choose to create view filters for TYPED data for every pay period. This is accomplished in the View Filter Manager by choosing a previously created selection set in the drop-down menu below the view filter. This is shown in the following illustration:




Construction surveyors must always be cognisant of the current view filter when adjusting layer and other view filter settings. The following items should be given consideration when working with view filters:

• After creating a view filter lock it so it can not be disrupted. Use Advanced View Filter Settings to lock view filters.

Finally, the combination of TBC view filters and selection sets are what makes TBC extremely well suited to construction data management. The Construction Surveyor priority should be to become proficient with the use of these tools.

## 800 Spot, Linear and Area Survey Quantity Calculations

This task involves conducting surveys to measure spot, linear and area quantities associated with pay items for newly constructed features and features to be removed as part of a contract. Standardized components associated with this task include survey feature codes, the TBC project template, and the Microsoft Excel quantity tracking spreadsheet. Creating separate TBC projects for a limited number of, or individual pay items can simplify quantification and allow for more than one surveyor to manage updates. TBC project and surface overlays are useful for working with background information.

As there is not a standardized list of pay items that apply to every Ministry construction project, these standardized components serve as "templates" to assist with workflows associated with measuring and calculating spot, linear and area quantities, and are discussed in the following sections.

#### 800.01 Survey Codes

Measurement of newly constructed spot, linear and area features make use of survey codes in the Ministry's FXL file. Commonly used codes for typical pay items are indicated in the standard pay item reports (worksheets) for quantity tracking. Refer to section <u>1000.02 Survey Quantity Tracking</u> for details.

#### 800.02 TBC Project Creation

TBC projects created for spot, linear and area quantity calculations are created using the following TBC project template:

BCMoTI-4SpotLinearAreaQuantitiesR#.vct (where # is the version of the project template)

After creating the project, save the project using the following name:

PROJDESC-PROJ#-TASK.vct

PROJDESC is abbreviated project name, which is used as a prefix for all TBC projects

*PROJ#* is the project number.

TASK describes the task in the TBC project

Examples are as follows:

- HWY9932-12345-QUANT (Highway 99 / 32<sup>nd</sup> Avenue quantities)
- CHASEW-12345-STORM (Chase West storm sewer quantities)


TBC projects for spot, linear and area calculations are to be stored in the following folder:

PROJFOLDER represents the folder name for the project. Examples are as follows:

- 01) AllSurveyedQuantities
- 02) DrainageQuantities

Once the TBC project has been saved, survey data can be imported to create TBC features for quantification.

# 900 Other Types of Surveys

Construction surveyors may also be required to undertake other types of surveys, which are discussed in the following sections:

### 900.01 Monitoring

Monitoring surveys are required to identify movement of construction elements over time. These include items such as slope stability, settlement (preload, for example) and structures. Monitoring surveys require a sensible approach to collecting the information required to derive the differences between one set of monitoring data and the next.

Careful attention must be given to, but not limited to, the following:

- Accuracy and stability of control
- Survey equipment used and expected tolerances (total station, GPS, terrestrial scanners)
- Instrument calibration
- Monitoring methods
- Timing of measurements
- Redundancy in measurements
- Qualitative analysis of results
- Identification of and understanding sources of error

A thorough understanding of survey best practices is required to ensure reliable results for monitoring surveys.

#### 900.02 Pits and Piles

Pits (also known as borrow bits) represent locations and sources of gravels and other materials required for use on the project. Piles are typically stockpiles of materials that have been removed from the construction area and can be stored either on or off site.

The following general points shall be considered for gravel pits and piles:

- Identify legal and excavation boundaries where applicable
- May require surveys to identify right of way location and borrow boundaries
- Pre and post excavation surfaces may be required to calculate volume of material removed
- Additional flagging and staking may be required to identify potential conflicts with underground utilities, gas and other private utilities, overhead power, and other wires

When surveying for volumes, surfaces must consist of the appropriate boundaries and point densities should be detailed enough to calculate accurate quantities. Incorporate linestrings to define distinctive terrain breaks in the surface models and use descriptions in the 20 – Const Horizon Remeasure category in the Ministry FXL file.

## **1000** Survey Data Tracking and Quantity Reports

A core aspect of Construction Surveyor quality management is to keep accurate records for the following:

- Survey data files downloaded from the controller
- Quantity reports with metadata supporting the final numbers

Standards reports for survey data file tracking and quantity reporting are available, and discussed in the following sections.

### **1000.01** Survey Data File Tracking

The file format for TBC project data consumption is a CSV (comma separated value). Details of file names, file content format and where to locate them are available in section <u>200.04 Data Collector Downloads</u>.

Ideally data files downloaded from the controller contain only data specific to a task. The task could be COG, TYPEDR or spot/linear/area data for quantification of newly constructed assets. In some instances a survey data file may contain multiple tasks. When multiple tasks are represented in a single downloaded file, the original survey data file should copied to create task specific data files for consumption in TBC projects.

#### 1000.01.01 Survey Controller Data File Tracking

*SurveyControllerDataFiles.xlsx* is the Microsoft Excel workbook for survey controller data file tracking, and is located in the following folder:

Note that all survey data files should be checked to ensure data is correct and the standard feature codes have been applied.

#### 1000.01.02 Survey Task Data File Tracking

Task specific survey data files are created from data files downloaded from the controller and copied to the task specific folder. Note that if the downloaded file is task specific, the file still needs to be duplicated and copied to the task specific folder in order to ensure preservation of the original data file.

*SurveyTaskDataFiles.xls* is the Microsoft Excel workbook for survey task data file tracking, and is located in the following folder:

Task specific data files are to be recorded, even if the original downloaded data file is a task specific file.

### 1000.02 Survey Quantity Tracking

The Construction Surveyor is responsible for measuring, calculating, and tracking quantities for both item removal and newly constructed assets on construction projects. Pay item quantity tracking is enabled using the following workbooks, which have been created to reflect the 8 major sections included in Schedule 7 – Approximate Quantities and Unit Prices, which is prepared by the designers:

- Section 01 GENERAL.xlsx
   Section 02 GRADING.xlsx
   Section 03 DRAINAGE AND UTILITIES.xlsx
   Section 04 STRUCTURES.xlsx
   Section 05 PAVING.xlsx
   Section 06 ELECTRICAL.xlsx
   Section 07 SIGNING.xlsx
- 🗐 Section 08 FENCING, REVEGETATION SEEDING, AND LANDSCAPING.xlsx

Each of these workbooks contains the following:

- 1. A totals worksheet that summarizes quantity to date, % complete and quantity remaining for each of the pay items in the workbook
- 2. A collection of worksheets for sample pay items that can be used directly, or copied and modified to represent pay items specific to the project
- 3. Formulas in the worksheets (represented by red text) for various types of calculations and cell population

Section items and categories are not consistent across Ministry projects. Surveyors will need to rename workbooks and worksheets to reflect the correct Section number and category.

Pay items and will also vary significantly from project to project and the first Construction Surveyor tasks is to configure the quantity tracking workbooks to reflect the pay items for the project. Individual worksheets also indicate the feature code and layer (from FXL file) for each pay item.

All worksheets in each category workbook are configured specific to each pay item. A key component of each worksheet is the TBC project containing the field measurements, details of the quantity calculation, and where (TBC project) that information can be derived from.

#### **1000.03** Other Construction Surveys

Some projects require other types of surveys for items such as stockpiles, borrow pits and existing utility lines. In these instances surveyors can create additional TBC projects under \07SpotLinearArea)\ to track these items. These survey data files should also be recorded in survey tracking workbooks.

# **1100 Layout Quality Assurance Surveys**

To facilitate visual recognition and standardize color representations, all survey lines, layout lines, stakes, offset stakes and points must be marked with flagging of a colour or colour combination that is unique to the feature being identified. A legend of the colour scheme being used will be made available to the Ministry representative at the beginning of the project.

All electronic and hardcopy printouts, field notes, sketches and calculations for layout and/or pickup must be retained by the Ministry representative and/or contractor for quality management purposes.

### 1100.01 Right of Way

Right of way data is provided on the 100 Series Plan production drawing in the construction tender drawings. Identification of right of way in the field will ensure that the contractor does not encroach on private property and builds confidence in the property owner that encroachment will not take place.

Right of ways are required to be identified in the field when the proposed works are located within 3m of the existing right of way. The right of way should also be identified in areas where construction machinery and vehicles will travel within 3m of the right of way. Field identification of the entire right of way is encouraged.

- Right of way staking requirements are summarized in the following bullets:
- Right of Way stakes are located between 0.5 and 1.0m offset from the right of way, towards the centreline alignment.
- Line of sight (or 20m maximum intervals) continuously visible blue and white flagging, stake optional, and/or at Ministry representative's request.
- When stakes are used to identify corners and deflection points, the alignment name, station, and offset shall be written on the stakes.

Right of Way data is available in the 100 series plan drawing, or SURVPROP drawing that is provided in the Construction Survey Data Package. This information is consumed by a TBC project in the following location:

\05) Survey\06) GeomaticsDesign\

Right of way linework can be exported to a DXF file from the TBC project for data collector upload prior to layout.

## **1100.02** Clearing and Grubbing

Clearing and grubbing surveys require the following considerations:

- Line of sight (or 20m maximum intervals) with continuously visible flagging
- Stake to identify corners (C/G corner written on stake) with station/offset
- If clearing and grubbing extends to ROW limits then the stake shall be inscribed with Algn/sta/offset, R/W and C/G

Clearing and grubbing data is available in the 100 series plan drawing that is provided in the Construction Survey Data Package. This information is consumed by a TBC project in the following location:

\05) Survey\06) GeomaticsDesign\

Clearing and grubbing linework can be exported to a DXF file from the TBC project for data collector upload prior to layout.

## **1100.03** Working Easements / License to Construct

Contractors, developers, landowners, local governments, and utility companies must apply for a highway works permit to construct, relocate, replace, repair and maintain works on provincial highways, right-of-ways or on highway bridges or structures.

A highway use permit may require a working easement to facilitate construction practices such as the movement of equipment or material. Working easements are sometimes identified during the design and in these circumstances, this data is provided as part of the Construction Survey Data Package.

Working easement data is available in the 100 series plan drawing that is provided in the Construction Survey Data Package. This information is consumed by a TBC project in the following location:

\05) Survey\06) GeomaticsDesign\

Working easement stakes must be placed such that they are intervisible, or at a maximum of 20m intervals. The stakes must be inscribed with "Working Easement" or "License to Construct".

### **1100.04** Slope Staking and Grade Sheets

Slope stakes are used to identify the cross-section locations where proposed cut and fill slopes intersect the original ground and at other locations such as major grade breaks (ditches and benches), major elevation changes (retaining walls), locations where the material changes (TYPED to TYPEA) and design locations such as ditch transitions and road widenings.


The construction survey data package contains grade sheet documents which are XLSX workbooks containing slope stake data. These files are created for each of the major corridors (alignments), and can be found in the following folder:

In the *AlignmentName* folder there is a folder called *AlignmentName Grade Sheets*, which contains the slope stake reports for Top surface (toe to toe), Datum surface (toe to toe) and top of granular (PSS to PSS). The slope stake report shows data for each cross section along with a picture showing the coded cross section points. This is shown in the following illustration:

The first row of data displays the offset from the centreline to each of the cross section points. The second row of data shows the elevation of each of the cross section points. The third row of data shows the grades between the adjacent points.

For the end columns, C1.59 indicates 1.59m of cut at the PTC (for fill the letter would be an F). The @3.19 indicates an offset value from the prior point, and the slope value is the slope from the prior point.

Cross section offset geometry points are summarized as follows:

- AC Asphalt curb
- RMC Raised median curb
- MC Concrete median divider
- SD Storm drain (same applies to Civil 3D pipe networks)
- SS Sanitary sewer (same applies to Civil 3D pipe networks)
- WM Water main (same applies to Civil 3D pipe and pressure networks)

#### 1100.04.01 Slope Staking Requirements


The requirements for slope staking are summarized in the following bullets:

- Stakes placed at 20m intervals maximum and 5m intervals in TYPEA (rock) material
- Additional slope stakes are required at major grade/elevation changes, material changes, ditch changes and road widening transition points
- Nonstandard ditches (not represented in alignment typical section) are staked separately as part of the ditch alignment

- Slope stakes can be ±0.030m up or down chainage, or develop slope staking data at new station location to work around an obstruction
- Slope stake CL offset required accuracy is ±0.030m
- Vertical accuracy is ±0.015m, except for rock cut and fill tolerances of ±50mm as per Standard Specification section 201.47 (Finished Roadway)
- Offset / guard stakes (in addition to slope stakes) which are placed vertically and indicate offset from slope stake are acceptable. Offset stakes alone are not acceptable
- On cuts/fills greater than 10m (rock benching) the Ministry Representative may require placement of another set of slope stakes during the excavation/backfilling process

### **1100.04.02** Slope Stake Inscriptions – Front and Back Views

An example of a fill slope stake with the proper inscriptions is shown in the following illustration:




In this example:

- The slope of 1.5:1 is indicated on the top of the outside of the stake
- F represents fill (C would represent cut)
- 2.00 represents the depth of fill (or cut)
- 15.00 represents the offset to the centerline
- The down arrow indicates that the fill (or cut) is measured at the ground line point
- The station value is written on the back of the slope stake (facing the ROW)

The Construction Surveyor will inscribe the cross section code on the side of the slope stake, which is discussed in the following section.

#### **1100.04.03** Slope Stake Inscriptions – Side View

The right side of the slope stake, as shown below, indicates the PSS (Proposed Subgrade Shoulder) and the HP (hinge point) distance, which is 12.00m from the centreline.



The left side of the slope stake indicates the horizontal distance from the slope stake location, towards the centreline, to the PSS hinge point. In other words, this information is what the grader needs to know to properly determine a fill/cut, slope and distance. This information is also provided in a layout RXL file, for each corridor (alignment), which can be uploaded to Trimble Access for layout tasks. The information has been inscribed on the stake to reduce manual calculation errors in the field.

In the left edge of slope stake example, HD (horizontal distance to PSS) is written on the side of the stake. There should be an HD to the required points, either PSS or PCZ, etc. (this would depend on the point used to calculate the slope stake). This allows a grade person to easily discern where the end of the cut or fill slope is from the stake, toward centerline.


#### 1100.04.04 Cross Section Codes

Hinge point examples for slope staking calculations are summarized in the following bullets:

- PSS Proposed Subshoulder
- PCZ Proposed Clear Zone\*
- PBE Proposed Bench
- PBC Proposed Back of Cut
- PTF Proposed Toe of Fill
- PTC Proposed Toe of Cut

\* Additional slope stake required after fill placement to PCZ is complete.


A complete cross section coding diagram, showing all codes, is shown in the following illustration:


The following sections show examples indicating various slope staking scenarios required and to which Proposed Hinge Point the calculation is based on.

### Example 1: Propose Sub Shoulder (PSS) and Probable Fill Slope Stake Location





Fill slope stakes are calculated starting at the PSS (Proposed Sub Shoulder), running out and down at the design slope (1.5:1, for example) to where it intersects the TYPEDH horizon (PTS, PTF).

## Example 2: Proposed Clear Zone (PCZ) and probably Slope Stake Location




Fill slope stakes in a clear zone area are calculate starting at the PCZ (Proposed Clear Zone), running out and down at the design slope, to where it intersects the TYPEDH horizon (PTS, PTF). Once the fill has reached the PCZ hinge point, another slope stake calculated from the PSS on differing slopes may be required.






Cut slope stakes in ditch scenarios are calculated starting at the PBC (Proposed Back of Cut, which is at subgrade elevation), running out and up the design slope to where it intersects the TYPEDH horizon surface.

#### Example 4: Proposed Back of Bench (PBE) and Probably Slope Stake Location



Cut slope stakes in a TYPEA (solid rock) cut are calculated starting at PB1 (Proposed Bench), running out and up the design slopes and benches to where it intersects the TYPEAH, which in this situation is the original ground surface. The material will be removed down to the top bench and then will require another set of slope stakes at the next, and subsequent bench locations.

#### Example 5: Slope Stakes at Widening Points Along the Chainage




In this example, TYPED slope stakes are required at 20m intervals (10m for TYPEA) with added slope stakes at cross section width changes such as barrier flares.

# 1100.05 Grade Staking

Grade staking is similar in concept to slope staking and applies to granular materials that constitute the pavement structure. Grade staking requirements are summarized in the following bullets:

- Created at 20m intervals unless otherwise noted in the contract
- Required where typical section changes (gravel depths, slopes, widths etc.)
- All intersection locations (access/intersection curve beginning and ends)
- Grade break locations (BVC, EVC etc.)
- Grade stake density may be reduced when machine control is used
- Grade stake chainage locations required accuracy is ±0.050m up or down chainage
- Grade stake offset location required accuracy is ±0.030m towards or away from CL
- Vertical loop closure accuracies require minimum vertical requirement for a closed level loop is 0.008 times the square root of the level loop distance, in kilometres
- Elevation tolerances are i) Subgrade/SGSB/75mm ±0.015m ii) 25mm ±0.010m

Grade stakes are to be inscribed as per the following image:



## 1100.05.01 Intersection Layout

Intersection layout often requires an awareness of various grade break locations between converging/diverging mainline and ramp alignments, intersections, intersection islands, roundabouts, acceleration/deceleration lanes, gravel structure variations between different alignments, and gore area grade break locations.

Layout procedure for grade staking these areas must ensure that the lane grade cut off locations match 3D DTM location cut offs. The following examples are a guide to appropriate staking for different grade break cut off scenarios.



#### Example 1: Gore Area Cut Off Line and Grade Staking Locations


In this example, gore area grade break staking intervals will also indicate where the "grade break" will diverge from the mainline, which will almost always be in the gore area. Where this occurs, grade staking stationing layout will also begin on the ramp alignment, with the stakes positioned on the appropriate ramp should, and on the cut off line.

Generally, the grade break cut off line, indicating the divergence of grades, is near the starting point of the gore area. This may include the areas where there are differing depths of gravel grades. Where different gravel depths occur between a mainline and a ramp the stake must be inscribed with the station value.

## 1100.05.02 Bridge End Fills


Bridge end fills occur adjacent to both bridge abutments and wingwalls. Layout must consider the following:


- When setting alignment stakes on fills and especially higher fills, ensure that the subgrade shoulder points are constructed accurately, and at the correct perpendicular or other angle skew required
- On cuts/fills greater than 10m the Ministry Representative may require placement of another set of slope stakes during the fill process
- Bridge design and construction plans are to be reviewed for staking control and alignment as part of bridge end fill layout
- Care must be taken to ensure that location and elevation data is correct, in particular, when skew angles are involved

The following sections provide examples of different bridge end fill layout scenarios.

#### Example 1: Slope Staking Bridge End Fills – 90° Abutment Skews

In this scenario a 1.5:1 slope is used on both side slopes and the front face slope towards the creek. To establish the toe on the front face and corner curve locations, stakes are calculated from the corner abutments, offset to the **subgrade shoulder** locations, and placed at 90°, 45°, and 0° angles, as shown in the following illustration:






#### Example 2: Slope Staking Bridge End Fills – Abutment Angle Skewed

In this example the alignment of the abutment is not perpendicular to the centreline. Here we have a 1.5:1 (run over rise) slope on both side slopes and a 2:1 (run over rise) front face slope, along the skew, toward the creek.

To establish the toe of the side slope and corner curve locations, stakes are calculated from the corner abutment subgrade locations, and placed at 90° (perpendicular) to the CL road alignment. The 45° and 0° slopes are calculated from the **skew alignment** along the **face of the abutment**. If the front slope is 2:1, the 45° point becomes 1.75:1, to enable a transition to the side slopes at 1.5:1.

This will establish a front face toe that allows proper skew to match the proposed abutment skew at subgrade shoulder. The front face distance from the abutment to the sub shoulder along the face or skew alignment, will usually be determined by the bridge design and construction drawings to ensure sufficient room for the abutment.

This is shown in the following illustration:



## 1100.06 Drainage

Drainage involves the discharge of runoff water and includes the following:

- Surface runoff features, ditches, channels curb and gutter, extruded asphalt curb etc.
- Circular and box culverts
- Earthen and armoured ditching
- Closed drainage systems with catch basins
- Headwalls and inlet/outlet structures

Layout details are provided in the following sections.

## **1100.06.01** Culverts

Culverts are a very common feature of road and highway construction projects. Culvert and other pipe network data is available in the construction survey data package as an XML file, and is located in the following folder:



The following points are important consideration when providing QA on culvert layout:

- Station and offset (culvert length) and/or elevations for culvert layout may require adjustments field fit actual conditions
- Offset hubs with guard stakes for inlet and outlets (guard stake indicates cut/fill and offset to culvert inverts from nail in hub). Hubs are placed along the skew of the pipe at each end
- Guard stake should include pipe size, type, length information and pipe grade in percent noting approximate cardinal direction for inlet and outlet
- Place a stake or painted pavement at each pipe bend/elbow, indicating the degree of the bend
- Slope stakes may be required at culvert inlet and outlet locations
- In TBC check possible infringement on pavement structure by cutting a section along culvert and showing road subgrade surface and TBC pipe object

Layout details are shown in the following illustration.



## 1100.06.02 Ditches

When laying out ditches, take the following requirements into consideration:

- Staking for special ditch situations such as false grading may require ditch specific slope and grade staking
- Ensure the Construction Survey Data Package contains ditch alignment/profile for special ditching
- Ditching layout data is provided in corridor cross section RXL file. If 3D features are required, make the request to the project Ground Modeler

## **1100.06.03** Headwalls, Inlet and Outlet Structures

When laying out headwalls, take the following into consideration:

- Refer to design drawings or Standard Specifications section 303.31.04
- Layout methods to be determined by agreement between Ministry and contractor

#### 1100.06.04 Manholes and Catch Basins

Manholes and catch basins are components of closed drainage systems. Manholes and other types of structures may be required for other underground utilities such as sanitary discharge and water distribution systems.

Like culverts, underground utility pipe network data is available in the construction survey data package as an XML file, and is found in the following folder:



The XML files can be imported into TBC to create Utility Networks.

The following points are to be considered when laying out manholes and catch basins:

• The Ministry Representative, Construction Surveyor and the contractor foreman / superintendent shall agree on methods for layout QA

- Refer to Standard Specifications section 582.32/33 and Standard Specification Drawings (CBs SP582-02.02) and (MH's SP582-03.02) to ensure proper placement of barrel and lid. Be aware of possible offset lids on certain types of manholes and catch basins
- As a minimum requirement, place a stake at the center of the structure, place an offset hub with nail 5m away, place a guard stake with the required information 0.10m behind the hub and add one offset stake perpendicular to the alignment 3m further away



## 1100.06.05 Curb & Gutter

The following points are to be taken into consideration when laying out curb & gutter:

- Layout data required at minimum 10m on tangents
- Layout data required at minimum 5m or quarter points on intersections/access curve alignments
- For offsets, use nail in hub or spike in ground at 1m offset behind back of gutter with guard stake indicating cut/fill and offset to the gutter grade
- Stakes are required at each end of letdown and at each end of transitions to driveways, sidewalks and wheelchair ramps
- Stakes are required at reverse gutter areas (Traffic Circles) that clearly define the start and end of reverse gutter, ensuring the hub elevations reflect the actual revised gutter
- Mountable curb may require hubs offset at more than one metre from the gutter (offset as required to allow for construction)

# 1100.06.06 Extruded Asphalt Curb

The following points are to be taken into consideration when layout out extruded asphalt curb:

- Layout with paint and/or nails along the face or edge of curb
- Guideline marks at 10m intervals maximum

- Guideline marks at 5m intervals maximum along curves for traffic islands
- Continuous point line (via roping method) must connect guideline marks

## 1100.06.07 Sidewalks

The following points are to be taken into consideration when laying out sidewalk:

- Stakes should indicate type of sidewalk (pave stones, concrete, asphalt etc.)
- Start and end point locations to be identified
- Identify letdown locations (driveways, accesses, wheelchair ramps)
- Sidewalk widths are to be identified

## 1100.06.08 Islands

The following points are to be taken into consideration when laying out islands:

- Grade staking of road widened so gravel widths will accommodate paving 0.5m behind curb face, or as per the design requirements
- Intervals determined by curb return parameters
- Curb types are found in Standard Specifications drawing SP582-01.04 and SP582-01.02
- Curb letdown locations are to be identified

## 1100.06.09 Asphalt

The following points are to be taken into consideration for asphalt layout:

- Method of grade break identification determined by mutual agreement between Ministry and contractor (paint line, staking)
- Identify centerline, lane lines, EP at 100m on tangents and 20m on curves
- Identify islands with extra width paving required for completion of curbing
- Layout of asphalt curb areas mark start/end locations
- Identify spillway locations

Asphalt limits are not to be determined from grade or slope stake reports.

## **1100.06.10** Roadside and Median Barriers

The following points are to be taken into consideration for asphalt layout:

- Layout with paint and/or nails along the face/edge of barrier
- Guideline marks at 20m intervals along curves (maximum)
- Guideline marks at 100m intervals along tangents (maximum)
- Stake or paint to identify start/end and transition locations
- Continuous paint line (via roping method) must connect guideline marks

## 1100.06.11 Paint Lines

The following points are to be taken into consideration for paint line layout:

- Mark start and end of tangents 100m (minimum 50m intervals may be required at the direction of the Ministry representative)
- 100m minimum distance along tangents (or as directed by the Ministry representative)
- 20m minimum distance on curves/spirals (or as directed by the Ministry representative)
- Marking required at:
  - Taper points
  - Gore areas
  - Crosswalks
  - Stop bars
  - Start and end of solid to dashed
  - CL fog lines and chevrons

## 1100.06.12 Pavement Milling and Overlay

The following points are to be taken into consideration for pavement milling and overlay layout:

- Layout records (cut sheets) must be produced
- Paint cuts/fills directly on pavement at 5m grid interval
- Survey of proposed milling area may be required

## 1100.06.13 Signage

The following points are to be taken into consideration for layout of roadside signs:

- Stake are required at the sign location indicating the sign type
- Refer to the Manual of Standard Traffic Signs and Pavement Markings

## 1100.06.14 Fencing

The following points are to be taken into consideration for fencing layout:

- 10 meter intervals on tangent
- Layout as per design
- 0.300m inside of right of way when no design is available
- A stake is required at all corners and kinks
- A stake is required at all gate locations

## **1100.07** Private Utilities

Private utilities include BC Hydro, Fortis BC (natural gas), telephone and cable TV.

Potential conflicts between existing and proposed utilities must be resolved prior to excavation. Prior to commencing work, a locate ticket should be requested from <u>BC 1 Call</u>. When submitting a ticket, the following information is required:

- Name and contact information
- Exact location of the planned excavation
- Depth of proposed excavation
- Timing of proposed excavation

• Digging on private/public property, or both?

The following points should also be taken into consideration prior to excavation:

- Notification of Ministry Representative and lead contractor prior to commencing work
- Ensure communication between Ministry Representative, contractor and surveyor regarding flexibility and methods for layout

## **1100.07.01** Electrical Utilities

Ensure communication between Ministry representative, site foreman/superintendent, and surveyor regarding flexibility/methods of preferred layout. Minimum standards must be met as follows:

- Layout center of pedestal and 2 offset hubs with nails at 2m and 4m (or further depending on pedestal size) with guard stakes aligned perpendicularly to the relevant alignment (i.e. usually the road EP, back of curb, back of sidewalk). Cut/fill elevation information and type of pedestal written on guard stake is required. Junction boxes near pedestals: layout with distance/offset/elevation as per Standard Specifications. Junction box types and sizes written on guard stake are required.
- Stand alone junction boxes: center of junction box and one offset stake (perpendicular to relevant alignment on rectangular JBs). Junction box types and sizes written on offset stake are required.
- When staking layout for pedestals and JBs, finished grade/back of sidewalk elevations should be crosschecked with Civil 3D design data to avoid conflicts

# **1200** Quality Management for Construction Supervision

Quality management is central to all Ministry construction supervision projects and workflows require both quality control (QC) and quality assurance (QA) measures. Survey and design consultants provide QC on their projects to ensure deliverables meet the needs from a geomatics/design perspective, and from a data compliance perspective. Ministry Field Services staff provide QA on design and construction data to ensure data is complete, reflects the design, is organized, and configured properly prior to construction.

The Ministry's Civil 3D documentation outlines the requirements for geomatics and design data assembly. When geomatics and design data meets the requirements, the project data is deemed to be "compliant".

The Ministry's QA process begins with the Ground Modeler on the Construction Supervision Team, and involves a data compliance review at 90% complete for the following:

- Geomatics and design archive, which is handed off to Field Services for construction supervision
- Construction Tender Data Package (CTDP) which is provided to contractors during construction tendering

Quality Management is also central to the role of the Ministry Representative, who is ultimately responsible for the implementation of the processes and work instructions as outlined in the Quality Management System. Construction surveyor and Ground Modeler provide Quality Assurance, with the use of consistent procedures and standards, throughout all aspects of construction supervision.

Refer to the Ministry's <u>Quality Management</u> web page on TRANnet for more information. Section QP-600 Contract Administration outlines QM as they relate to construction supervision.

The following sections discusses all aspects of quality assurance as it relates to the technical aspects of construction supervision.

# **1200.01** Project Folders

All data created by Construction Surveyors must be stored in the Ministry standard construction supervision folder, as indicated in section <u>200.01</u>.

# **1200.02** Survey Data Files – Location and Naming

The following QC items are applicable to survey data files:

- For each reduced (CSV) file downloaded from the controller, the corresponding RAW (JXL) file must also be downloaded. CSV files are calculated files, whereas JXL files record the original instrument observations, and can be used to recalculate the CSV if required. The JXL file is the legal file that will "stand up" in a court of law
- Downloaded survey data files are to be located, and remain unedited, as outlined in section 200.04 of this document
- Downloaded survey data files are to be named in accordance with section 200.05 in this document
- Task specific survey data files are created by copying, or copying and editing the original downloaded CSV files, and placing them in the task specific folder

# 1200.03 Survey Data Files – Content

The following QC items are applicable to the contents of CSV survey data files:

• Data file internal format is a comma delimited using the following format

Point ID, Northing, Easting, Elevation, Feature Code, Description1, Description2

- Point ID must be in accordance with section 200.05
- Feature Codes must be in accordance with Ministry standard feature code list (see Appendices)
- Description 1 and Description 2 are optional parameters used to describe the point

# 1200.04 TBC Projects and Templates

Construction surveyors are responsible for multiple tasks involving data collection to be processed in Trimble Business Center. TBC project templates are available, and should be used for the following tasks:

- Consumption of geomatics and design data provided in the construction tender data package
- Verification of primary control and establishment of secondary control
- Creation of Construction Original Ground surface and calculate removal item quantities
- Creation of horizon and remeasure surface, and calculation of volumetric quantities
- Calculating spot, linear and area quantities for survey data

Descriptions of these tasks and TBC project templates can be found in sections 600, 700, 800, 900, 1000.

# **1200.05** Reports

Various reports can be generated from Trimble Business Center by the Construction Surveyor and from Civil 3D (by requesting to the Ground Modeler). Microsoft Excel is a useful tool for aggregating data for various report formats.

Some standard report formats are as follows:

#### **Slope Staking Reports**

#### Volume Reports

Volume reports are provided by the Ground Modeler and are available in the CSDP. Design volume reports are helpful for comparing design volumes to construction volumes. Design volume reports can be found in the following folder:

BC Ministry of Transportation and Infrastructure

Construction surveyors calculate volumes in Trimble Business Center using the surface to surface volume calculation method. Details on these types of reports can be found in section <u>700.06 Volume Calculations</u>.

## **1200.06** Survey Data Tracking

Survey data tracking is an important QM practice, as this information is the source for all quantity calculations. Survey data tracking involves tracking downloaded survey data files (from the controller), and task specific data files that are used in task specific TBC projects.

Details on Microsoft Excel workbooks developed for tracking survey data files are found in section <u>1000.01</u> <u>Survey Data File Tracking</u>.

# 1200.07 Quantity Data Tracking

The Construction Surveyor is responsible for field measurements and the calculation of quantities for both removed items and newly constructed features.

Details on Microsoft Excel workbooks developed for tracking quantities are found in section <u>1000.02</u> <u>Survey Quantity Tracking</u>.

## **1200.08** Cross Section Codes

Design data is based on standardized cross section codes, which are reflected in layout RXL files created by the Ground Modeler and delivered as part of the Construction Survey Data Package.

A complete list of design cross section codes can be found in section <u>1100.04.04 Cross Section Codes</u>.

# **1500** Appendix B – Horizon and Remeasure Coding and Surfaces

# **Construction Surveying Horizon and Remeasure Survey Codes**

Horizon and remeasure surveys are required to measure construction horizons for the purpose of surface modeling and volume calculation. The **Horizon** surface model is the *actual* top of the existing material surface (TYPED, TYPEA etc.) used for *actual* quantity calculations. The **Remeasure** surface is the excavated surface model used for calculating monthly quantities. The **Final Remeasure** surface represents the excavation through all materials for the road subgrade and grading neat line.

### **Construction Survey Codes**

- 1. Z\* = Horizon Material (Top of native material, prior to excavation)
- 2. K\* = Remeasure Material (Top of material, after excavation)
- 3. X\* = Change to Material (Interface of two materials)
  - a. Linestrings can be copied / exported for use with another surface
- 4. Y\* = Horizon Material Spot Elevation
- 5. J\* = Remeasure Material Spot Elevation

### **FSOG**

- Coded as ZO# (linework) or YO (spot) for original ground horizon
- Surveyed beyond cut/fill slopes

#### STRP Remeasure

- Coded as KS# (linework) or JS (spot) for stripping remeasure only
- Bottom of stripping is coded as ZD# (linework) or YD (spot) for TYPED horizons under stripping, or ZA# (linework) or JA (spot) for TYPEA horizons under stripping
