**MOVABLE BRIDGE OPERATION**

**17<sup>th</sup> Street Bridge (lift span, at Courtenay)**

**1. OBJECTIVE**

To provide safe navigable waterways for marine traffic.

**2. GENERAL PERFORMANCE SPECIFICATIONS**

**Routine Maintenance Services**

All services for this Local Area Specification are Routine.

There is one Movable Bridge to maintain in this Service Area: the 17<sup>th</sup> Street Bridge (lift span, at Courtenay).

**Quantified Maintenance Services**

**3. DETAILED PERFORMANCE SPECIFICATIONS**

**Routine Maintenance Services**

The Contractor must:

- a) open and close movable bridges in accordance with the Province's Bridge Operating Manual (available for viewing at the District Office).
- b) post contact telephone numbers for the Contractor and the Province at the marine approaches to the movable bridge at locations approved by the Province;
- c) operate in accordance with the applicable Coast Guard approvals under the provisions of the Navigable Waters Protection Act and/or the by-laws of the appropriate harbour commission;

- d) open and/or close movable bridges only when it is safe to do so, i.e., when all vehicles or vessels are clear of the structure;
- e) when marine traffic requests a moveable bridge opening on railway-shared structures, liaise with the applicable railway company to determine a suitable opening time, inform the marine traffic of the opening time, open the movable bridge at the scheduled time, and in compliance with the requirements of the appropriate authorities;
- f) maintain the movable bridge in accordance with the Bridge Maintenance Schedule Manual (available for viewing at the District Office);
- g) report to the Province any malfunction of the movable bridge where full closure is not possible, or where the movable bridge cannot be fully opened;
- h) ensure that all operators of movable bridges are qualified to operate V.H.F. radio and where railways are involved, are qualified under the applicable federal regulations and acts, and, as applicable, are certified by B.C. Rail, to the satisfaction of the Province.

### **3.1.1 Performance Time Frames**

The Contractor must:

- a) ensure response times for openings/closures are in accordance with the applicable Coast Guard approval under the provisions of the Navigable Waters Protection Act and/or the by-laws of the appropriate harbour commission, and/or as mutually agreed between the Contractor and Province;
- b) ensure maintenance is scheduled in accordance with the the Bridge Maintenance Schedule Manual; and
- c) immediately report any malfunctions to the Province.

A Movable Bridge is defined as a Bridge of any type having one or more spans capable of being raised, turned, lifted or slid from its normal vehicular and/or pedestrian service location to provide for the passage of vessels. The movements of the Superstructure may be produced either manually or by engine power.
