



RETURN DATE: The Eligible Student (ES) Form and Auditors' Report must be received by the Ministry of Education **NO LATER THAN JUNE 15, 2018** in order to process grant payments for disbursement on June 30. Late submissions will result in a significant payment delay to the Authority.

The Ministry strongly advises schools to retain student attendance, participation and enrolment documentation to assist in the enrolment audit process.

- ALL independent schools who received grant funding for the 2017/18 school year must complete the ES Form. (*Schools operating under a Distributed Learning Agreement are exempt from completing the ES Form.*)
- ALL students claimed in Section I – Eligible Students Only, must be school age.
- The parent or guardian of a student must be ordinarily resident of British Columbia, who is a citizen of Canada, or a permanent resident, or is lawfully admitted to Canada. Guardians may be recognized only if they are such within the meaning of the *Family Law Act* or the *Infants Act*.
- FTE = Full-Time Equivalent
- Absences due to sickness, or any other excused absence should not be subtracted from the total hours enrolled.
- Responsibility of Authority
The school authority must have student enrolment documents for all eligible students that include birthdate of student, citizenship of parent/guardian and residence of parent/guardian in order that the auditor may be satisfied that the student meets the definition of "eligible student".

NEW for 2017/18 Eligible Student (ES) Process

- Ø Auditors' Report (HB 5815 (Sample Auditors' Report on page 5)) is required to be submitted to the Ministry with the completed ES Form.
 - Failure to provide this report with the ES Form to the Ministry will result in a significant delay of the final grant funding payment of the school year to the Authority.
(Section 12 of the *Independent School Act*; Section 2 of the Independent School Regulation)
- Ø Auditor is qualified under the Act and has the appropriate licensing (Audit category) with the Chartered Professional Accountants of British Columbia (CPABC).

GENERAL Form Information

§ ES Form captures student enrollment and attendance between July 1, 2017 and May 15, 2018.

§ The ES Form is divided into two sections:

SECTION I – ELIGIBLE STUDENTS ONLY

Students that are school age, eligible for operating grant funding and enrolled in a Kindergarten to Grade 12 program.

EXCLUDE the following students: out of province, international, "Status Indians" living on-reserve, registered home school, distributed learning and if applicable, students in a Group 3 or Group 4 portion of a school.

SECTION II – ALL STUDENTS

All school age students enrolled in a Kindergarten to Grade 12 program.

INCLUDE the following students: eligible and non-eligible students enrolled in Kindergarten to Grade 12 **and**

EXCLUDE the following students: registered home school, distributed learning and not enrolled in a Kindergarten to Grade 12 program.

§ And each section has Part A and Part B:

PART A: Students attending 600 hours or more

PART B: Students attending less than 600 hours

For both Part A and Part B, Kindergarten is calculated by the program in which the student has been enrolled: Full Day Kindergarten or Half Day Kindergarten.

SAMPLE AUDITORS' REPORT

We have audited the Eligible Student (ES) Form ("the Form") for ABC School ("the School") for the period July 1, 20XX to May 15, 20XX, prepared by management in compliance with criteria established by the Independent Schools ES Audit Form Completion Information as required under Section 2(1)(d) of the Independent Schools Regulation (the "Regulation") of the Ministry of Education Office of the Inspector of Independent Schools for the Province of British Columbia. Management is responsible for compliance with the criteria established by the provisions of the Regulation. Our responsibility is to express an opinion on this compliance based audit.

We conducted our audit in accordance with Canadian Generally Accepted Auditing Standards. Those standards require that we plan and perform an audit to obtain reasonable assurance whether the School complied with the criteria established by the Regulation referred to above. Such an audit includes examining, on a test basis, evidence supporting compliance, evaluating the overall compliance with these criteria, and where applicable, assessing the accounting principles used and significant estimates made by management.

In our opinion, the Form for ABC School for the period July 1, 20XX to May 15, 20XX, has been prepared in compliance, in all material respects, with the criteria established by the Independent School ES Audit Form Completion Information as required under Section 2(1)(d) of the Independent School Regulation of the Ministry of Education.

Our report is intended solely for the ABC School and the Ministry of Education and should not be used by parties other than the School and the Ministry of Education.

"authority" means

- (a) a society incorporated under the *Society Act*,
- (b) a company within the meaning of the *Business Corporations Act* or a corporation incorporated under a private Act, or
- (c) a person designated, by regulation, as an authority that operates or intends to operate an independent school;

"educational program" means

an organized set of learning activities that is designed to enable learners to develop their individual potential and to acquire the knowledge, skills and attitudes needed to contribute to a healthy, democratic and pluralistic society and a prosperous and sustainable economy;

"guardian" means

- (a) a guardian within the meaning of the *Family Law Act*, or
- (b) a personal guardian within the meaning of the *Infants Act*;

"school age" means a person is deemed

- (a) to be of school age at the beginning of a school year if the person will have reached age 5 on or before December 31 of that school year, and
- (b) to continue to be of school age until the end of the school year in which the person reaches age 19.

"student record" means

a record of information in written or electronic form in respect of a student, but does not include a record prepared by a person if that person is the only person with access to the record;

"eligible student" means a student

- (a) who is of school age, and
- (b) whose parent or guardian
 - (i) is, or was at the time of that parent's or guardian's death, a citizen of Canada or a permanent resident, as defined in the *Immigration and Refugee Protection Act* (Canada), who is or was at the time of the parent's or guardian's death, ordinarily resident in British Columbia, or
 - (ii) is lawfully admitted to Canada and is ordinarily resident in British Columbia.

Reports

- 2 (1) Subject to subsection (3), in order to qualify for a grant under the Act in respect of an independent school, an authority holding a group 1 or 2 certificate for the independent school must file the following with the inspector...
- (d) by June 15 of the school year for which a grant is claimed, an audited report, in the form specified by the inspector, stating
 - (i) the number of eligible students
 - (A) classified as FTE kindergarten students, or
 - (B) students in grades 1 to 12
- enrolled in and in attendance at the school as of May 15 who have completed at least 600 hours of instruction after July 1 but before May 15 of that school year in an educational program that is not delivered through distributed learning,

- (ii) the number of eligible students classified as 1/2 FTE kindergarten students enrolled in and in attendance at the school as of May 15 who have completed at least 320 hours of instruction after July 1 but before May 15 of that school year in an educational program that is not delivered through distributed learning, multiplied by 1/2,
- (iii) the number of eligible students classified as FTE kindergarten students and students in grades 1 to 12 enrolled in and in attendance at the school as of May 15 who have completed fewer than 600 hours of instruction after July 1 but before May 15 of that school year in an educational program that is not delivered through distributed learning,
- (iv) the number of eligible students classified as 1/2 FTE kindergarten students enrolled in and in attendance at the school as of May 15 who have completed fewer than 320 hours of instruction after July 1 but before May 15 of that school year in an educational program that is not delivered through distributed learning,
- (v) the total number of hours of instruction received through the school by the students referred to in subparagraph (iii), divided by 600, and
- (vi) the total number of hours of instruction received through the school by the students referred to in paragraph (iv), divided by 320 and multiplied by 1/2.

(1.1) For the purposes of subsection (1), kindergarten students enrolled in an independent school are classified as

- (a) FTE kindergarten students if the students are enrolled in an educational program that offers at least 850 hours of instruction, and
- (b) 1/2 FTE kindergarten students if the students are enrolled in an educational program that offers fewer than 850 hours of instruction...

- (3) Where the inspector accepts the filing of a report after the date it is due under subsections (1) and (2), the report is deemed to be filed on time for the purposes of subsection (1) or (2), as the case may be.
- (4) A report referred to in subsection (1) (d) or subsection (2) must be audited by a person qualified under section 112 of the *Societies Act* to be an auditor of a reporting society.

Hours of instruction

- 3 (1) For the purposes of this section, "hours of instruction" means in respect of an independent school, an hour in which students of the independent school are in attendance and under supervision for the purpose of receiving instruction in an educational program, including work study and work experience programs, examinations or other learning activities provided by the authority, but does not include recesses, lunch periods and other scheduled breaks between classes;
- "school day" means a day scheduled as a day on which instruction is to be provided in an independent school.
- (2) In each school year, an authority must provide not fewer than the following hours of instruction to students enrolled in an educational program in an independent school operated by the authority:
- (a) to students in half day kindergarten, 450 hours of instruction; and
 - (a.1) to students in full day kindergarten, 850 hours of instruction.
 - (b) to all other students, 850 hours of instruction.
- (3) For the purposes of subsection (2), where an independent school is closed on a school day as a result of a strike or lockout, the hours of instruction scheduled for that school day shall be included for the purposes of calculating the hours of instruction of the independent school under subsection (2).
- (4) This section does not apply in respect of an educational program delivered in whole or in part through distributed learning.

Persons qualified to act as auditor

- 112 A person is qualified to act as an auditor of a society only if
- (a) the person is a member of, or is a partnership whose partners are members of, a provincial or territorial institute or ordre of chartered accountants, or a provincial or territorial organization of chartered professional accountants, within Canada, or
 - (b) the person is certified, under section 222 [*board function and liability*] of the *Business Corporations Act*, by the Auditor Certification Board continued under section 221 [*Auditor Certification Board*] of that Act.

1. What is the definition of an “eligible” student?

“eligible student” (as defined in the Independent School Regulation at: http://www.bced.gov.bc.ca/legislation/schoollaw/i/bcreg_262-89.pdf) means a student

- (a) who is of school age, and
- (b) whose parent or guardian
 - (i) is, or was at the time of that parent's, or guardian's death, a citizen of Canada or a permanent resident, as defined in the *Immigration and Refugee Protection Act* (Canada), who is or was at the time of the parent's, or guardian's death, ordinarily resident in British Columbia, or
 - (ii) is lawfully admitted to Canada and is ordinarily resident in British Columbia.

2. What is the definition of “school age”?

A person is deemed to be of school age at the beginning of a school year if the person will have reached the age of 5 on, or before December 31 of that school year and continue to be of school age until the end of the school year in which the person reaches 19. As set out in section 1(2) of the Independent School Act at: http://www.bced.gov.bc.ca/legislation/schoollaw/independent_school_act_contents.pdf

3. How should an independent school verify parent/legal guardian's lawful admission to Canada and residency in British Columbia?

By using the “Status of Parent” - Appendix II or III form (produced by the Office of the Inspector of Independent Schools) for this purpose, or something similar into the school's student registration information.

4. How can residency be established?

A list of indicators is provided in “Eligible Student Information” Appendix I to assist with determining residency.

5. Does the guardian of a child have to be appointed through a BC judicial process?

Yes (“guardian” means guardian of the person of a child within the meaning of the *Family Relations Act*). Documentation from another country is not acceptable. It must be through a BC judicial process.

6. If a parent/guardian is on a work visa, are his/her children eligible students?

Yes, if the parent/guardian will be working in BC for one year or longer. Copy of the parent's/guardian's “Employment Authorization” from Citizenship and Immigration Canada must be placed in the student record.

7. If a student's parent/guardian is a student attending a university, or school in BC, can the student be considered an eligible student?

Yes, if the parent/guardian will be attending a university or school in BC for one year or more. Copy of parent's/guardian's “student visa” from Citizenship and Immigration Canada must be placed in the student record.

8. If a student's parent/guardian is in BC on a visitor's permit, can the student be considered an eligible student?

No.



9. **If parents/guardians leave BC to reside in another province or country, is the student an eligible student?**
Only if a parent/guardian would continue to meet "residency" in BC requirements, and only for the period of time that such is the case.

10. **If parent/guardian leaves BC during the school year and no longer is a BC resident, is the student eligible for funding for the remainder of the days enrolled?**
Only if a parent/guardian would continue to meet residency in BC requirements and only for the period of time that such is the case.

11. **Do status Aboriginal students living on reserve, who are funded by the federal government through Indian and Northern Affairs Canada (INAC) qualify for any provincial funding?**
No, their funding is fully provided by the federal government.

12. **Do status Aboriginal students living off-reserve, who are not funded by the federal government qualify for provincial funding?**
Yes.

13. **Are home-schooled students that are registered with the school to be included in the ES Audit count?**
No.

14. **Can students who are children of foreign diplomats and refugees be considered eligible students?**
Yes, if they meet the requirements stated in Status of Parent - Appendix II; copy of official documentation must be in the student(s) file.

15. **Can a foreign exchange student be considered an eligible student?**
Yes, if the exchange is a one-on-one student exchange and completed within a 2 year timeframe.

16. **Can international students in British Columbia on student visas (visa students) be considered eligible students?**
No. An eligible student's parent/legal guardian must be a citizen of Canada or a permanent resident, as defined in the Immigration and Refugee Protection Act (Canada) or be lawfully admitted to Canada and be ordinarily resident in BC.

17. **Do I have to calculate attendance differently, now that the Ministry is using hours instead of days to calculate full time attendance?**
No, all the rules regarding attendance remain the same.

18. **How do schools compare hours of instruction to days of instruction?**
Full-time attendance for 600 hours of instruction is comparable to (for example) approximately 4.5 hours per day (or more) of instruction x 135 days of school. (i.e. # of hours/day x # of days in school)



- 19. What is the minimum number of hours of attendance for half time Kindergarten students in Section A. of the ES Audit form?**
Half time Kindergarten students must attend a minimum of 320 hours by May 15.
- 20. Should the following days be included in the total hours of instruction: scheduled student examination days, learning activity days (i.e. field day) school community involvement days and days that school is closed due to inclement weather?**
Yes, they may be counted as school hours (formerly called "school days"). Please refer to Educational Standards Order, section 3.
- 21. Should the following days be included in the total hours of attendance: teacher professional days, statutory holidays, school holidays, and extended school holidays?**
No.
- 22. Do I include recess and lunch breaks when calculating hours of instruction?**
No. Please refer to Educational Standards Order, section 3.
- 23. Can a kindergarten student be considered a full-time eligible student (1.0 rather than 0.5 FTE) if enrolled in a full-day program?**
Yes, for the 2011/12 school year the BC Government has provided funding for universal full-day or half day Kindergarten available in independent schools.
- 24. Can a student be counted as 1 FTE, (as opposed to .5 FTE) if that student is in kindergarten, but is age 6 (grade 1 age)?**
Depending on whether the student is attending a full day or half day kindergarten program, as long as they are "of school age", then they are counted by the program (grade) they are enrolled in, not by age.
- 25. Can a student who is enrolled at a school, but has to be away from school for a period of time (e.g., due to pregnancy) be considered a fully eligible student?**
Yes, as long as the school continues to provide and supervise the student's educational program and assess student progress.
- 26. If a student is away sick for an extended period of time, e.g., five months, can the student be counted for funding purposes?**
Yes, if the school continues to provide and supervise the student's educational program and assess student progress as far as possible. The auditor must be satisfied that there is sufficient documentation to substantiate this in the student's file.
- 27. If a student "skips" school various days, is that student still considered to be "in attendance" for funding purposes on those days?**
No, un-excused absences do not count as days "in attendance".
- 28. If a student is absent various days due to illness, is the student considered to be "in attendance" for funding purposes on those days?**
Yes. Excused absences may count as days "in attendance".



29. If a student goes on an extended holiday and is expected to brief the school and give presentations on return to school, can the days missed be counted?

Yes, if this is an excused absence and the school continues to provide and supervise the student's educational program and assess student progress.

30. If a student moves out of BC (and no longer resides in BC) and is completing courses provided by the school, can the student be considered an eligible student?

No.

31. If a student, who was enrolled as an eligible student on September 30, becomes a registered home-schooled student in January, can the school claim the September to January portion of the student grant?

Yes, only as a pro-rated portion for September to January; for the remainder of the school year the student is to be considered a home-schooled student.

32. Does a study block count towards the 600 hours?

Yes, if attendance is taken and it is supervised by a teacher.

33. Does a dual credit course, at a Post Secondary Institution ("PSI"), count towards the 600 hours?

Yes, if the course qualifies as a dual credit course as per the policy: (http://www.bced.gov.bc.ca/policy/policies/earning_credit_through.htm#) and is supervised by a BC Certified teacher who ensures that:

- o the course is part of the student learning plan,
- o the course meets the requirements and is reported as per policy (http://www.bced.gov.bc.ca/policy/policies/earning_credit_through.htm#)

34. If a Grade 8 or 9 student is taking a course at a Distributed Learning School can they also take a course at a Brick and Mortar school and receive funding?

Yes, they would be considered an eligible cross enrolled student.

35. If a student is an Adult, but has not graduated can they receive funding?

Yes, an non-graduated adult would be considered an eligible student, if they took a course between July 1 and June 30, that leads to graduation.
