<b>B.C. RESIDENCY AND OUT-OF-PROVINCE STUDENTS</b>				
<p><i>To be eligible for provincial funding, Boards of Education must ensure that students are:</i></p> <ul style="list-style-type: none"> <li>• <i>ordinarily resident in B.C. (and where applicable for school age students) with their parent/legal guardian</i></li> <li>• <i>enrolled in the district</i></li> </ul> <p>(Ref: <a href="#">K-12 Funding General Policy</a>)</p> <p>Non-resident Out-of-Province/ International students are not eligible for funding. <b>Planning and General Understanding of the Program</b>				
<p>The <a href="#">Form 1601</a>’s definition of Continuing Education Schools has been in place since 1989 and says: “<i>To be reported in a CE school, students must be enrolled in a course offered by the CE school. Instruction must be provided by TRB certified staff whose FTE position is assigned to the CE school. Students in a face to face setting must be in a classroom consisting of CE students only.</i>” Form 1601 data is collected every school year at the Fall Data claim period with Principals required to read the descriptions to ensure their facility type meets the school facility type requirements.</p>

<p><b>Note:</b> The organization of District CE schools vary. The ECHO9100 Report lists all the CE students for the district. However, the students may be attending one or more CE school locations resulting in their records being distributed. See <a href="#">Form 1601</a> CE facility definition.</p> <p><b>Note:</b> Identifying locations in advance is essential, as it will enable an efficient and effective use of time and audit personnel.</p>	<p>An understanding of the organization, location of school facilities (including incarceration centres), location of files, key personnel and how the CE programs are delivered.</p>	<p>How the District CE school operates and whether it operates in accordance with Ministry policies and requirements.</p>	<p><b>Key Documents:</b> As above, and <a href="#">Form 1601</a></p> <p><b>Note to Lead Auditors:</b> Most of this information could be acquired (prior to the audit review) by telephone, email, or through exploration of the district’s website.</p> <p><b>Audit Steps:</b></p> <ol style="list-style-type: none"> <li>1. <p><b>Student Eligibility</b></p>				
<p><b>NOTE:</b> The provision of an educational program to students before verification of funding eligibility has been undertaken does not meet the reporting directives.</p>				
<p>Students are to be reported by the CE school with which they are enrolled and meet the Adult Funding Policy’s definition of attendance.</p> <ul style="list-style-type: none"> <li>• <i>School aged students reported in a Continuing Education School must be born June 30, 2009 or before</i></li> </ul> <p><b>Adult learners</b> reported for funding include: (Form 1701 Instructions, P.2)</p> <ul style="list-style-type: none"> <li>• Non-graduated adults, which include: <ul style="list-style-type: none"> <li>• Students born prior to July 1, 2006 and enrolled in the B.C. **Course Claim Eligibility (Number of Eligible Courses Reported)**

**NOTE:** Prior to audit, lead auditor will request samplings of district/school documentation to verify FTE claims are in a format which enables auditors to undertake their review process to: *ensure the accuracy and eligibility of the student enrolment and other school data reported to the Ministry of Education and Child Care by school districts and the extent to which policies are followed.* (Ref. [Compliance Policy](#))

**Program and Course Claim Eligibility (Number of Eligible Courses Reported)**

**‘COURSE’ CLARIFICATIONS:**

**Course Definition:** A course is defined by the [Student Credentials Ministerial Order M164/96](#)... One credit represents the value attached to the understanding, knowledge, skills and competencies that most students can acquire in **approximately 30** hours of instruction (Ref: Form 1701 Instructions, P.13), Chapter 3 of the [Handbook of Procedures for the Graduation Program](#) and the [Recognition of Post-Secondary Transition Programs for Funding Purposes Policy](#).

**Courses** encompass only one organized set of learning standards. While completion of the course’s learning outcomes [competencies] may be over several registration periods, only one course is undertaken and therefore eligible for only one funding claim. (Ref. Form 1701 Instructions, P.14)

**NOTE:** There is to be evidence of a qualified teacher’s instructional component to meet the requirements of Section 17 of the *School Act* and [BC Reg 265/89](#), Section 4 (Duties of a Teacher) **NOTE:** *Students are not allowed to take the same course at the same time during the funded school year whether in different schools or the same school* (Ref: Form 1701 Instructions, P.14)

**Not fundable through Form 1701:** (Ref: Form 1701 Instructions, P.14) credit awarded through equivalency, prior learning assessments, credit recognition, credit granted, tutorial time, teacher consultation and courses completed via challenge and external credential courses. **NOTE:** Partial credit courses are Ministry approved and must have assigned Ministry course code (verify through online [Course Registry](#)).

**Advanced Placement –** *Schools may claim an AP course as a separate course...only if it meets the definition of a course, is a separate and distinct instructional session of approximately 120 hours (for a four credit course) on the student’s timetable, the course is being taught by a certified teacher and is in accordance with the Student Credentials Ministerial Order M164/96.* (Ref: Form 1701 Instructions P.15)

**Support Blocks:** *Support block are not to be reported for school-aged graduates, adult students or by Continuing Education (CE) or Online Learning (OL) schools.* (ref. Form 1701 Instructions P.16)

<p><b>Independent Directed Studies (IDS):</b> related to or is an extension of one or more of the learning outcomes established in Ministry Authorized or a Board/Authority Authorized course...<i>an area of study in an educational program undertaken by a student that is undertaken pursuant to a plan developed by a teacher and a student and approved by a principal, vice principal or director of instruction, and carried out by the student under the general supervision of a teacher...The number of credits a student earns for an IDS will be set out in the plan developed by that student and a teacher and approved by a principal.</i> (Ref: <a href="#">Graduation Program Order M302/04</a>).</p> <p>Use the auditors IDS checklist as a guide to verify eligibility of IDS claims.</p> <p><b>NOTE:</b> IDS courses and BAA courses do not count towards credit in the Adult Graduation Program (limited to Ministry Authorized courses and some External Credentials). IDS and BAA courses are ineligible claims for those adult students undertaking the Adult Graduation Program (although adult students on the B.C. Graduation Program may be funded for BAA courses).</p>				
<p align="center"><b>CAREER/SKILLS TRAINING/DUAL CREDIT TRANSITION PROGRAM OF COURSES</b>  <b>NOTE: Each course claim must meet attendance requirements in addition to career directives</b></p>				
<p><b>Audit Steps:</b> Prior to audit, request a list of all students in career/skills training and PSI transition courses, as well as the name of the district/schools' Career Program Coordinator or school district personnel that support career education programing. It should be that this district staff member will have all the documentation for each funded student claim.</p> <p><b>NOTE:</b> If associated with a post-secondary partner see related audit process below. If a BAA course option, audit in accordance with standard course eligibility verification.</p>				
<p><b>Youth WORK in Trades/WRK (school age only)</b> courses provide students with opportunities to begin apprenticeship training while in secondary school (Ref. Form 1701 Instructions, P.13) and meet the requirements as outlined in the current <a href="#">Youth Work In Trades Guide</a>.</p> <p><b>NOTE:</b> each of these four credit courses are only claimed once regardless of the number of reporting periods the student requires to complete the workplace component (Form 1701 P.15 – for WEX and WRK).</p> <p><b>Audit Steps:</b> use the auditor's Career Program checklist for WRK based on the following Ministry directives to verify WRK course(s).</p> <p><b>WRK</b> allows secondary students to earn graduation requirements while transitioning into the work force with a total of 480 hours of trade-specific work experience (not to overlap with WEX12A/12B but OK to fulfill 30 hours of career explorations for Career-Life Connections). Program consists of WRK11A/B and WRK12A/B – each 4-credit course claims. Requirements in accordance with Program Guide for Secondary School Apprenticeship:</p> <ul style="list-style-type: none"> <li>• Students must have an in-school orientation</li> <li>• Students must have sponsors recognized by the SkilledTradesBC</li> <li>• Students in WRK programs complete an SkilledTradesBC registration form with the recognised school district staff, and SkilledTradesBC recognized sponsor</li> <li>• School district staff retain copies of all forms required for registration and retain the student's SkilledTradesBC registration number (SkilledTradesBC ID number), including verification of worksite WorkSafeBC coverage</li> </ul>

<ul style="list-style-type: none"> <li>• There is a <b>unique training plan (created and signed off by an educator in conjunction with student and SkilledTradesBC recognized sponsor) demonstrating student progression through each of the WRK11A to WRK12B courses</b> once students are registered with SkilledTradesBC. Each WRK placement requires a unique, signed student training plan</li> <li>• Work-based training hours are accrued only after application for registration as <b>youth apprentices*</b> has been done with SkilledTradesBC (see auditor’s checklist for information regarding Recognition of Prior Work [aka – ‘HiddenApprenticeship’])</li> <li>• WRK students are <b>monitored by school personnel and evaluated by educators with valid teaching certificates</b> who assign final percentages.</li> </ul>				
<p><b>*WRK youth apprentices are funding eligible for WRK until June 30<sup>th</sup> of the school year in which students turn 19.</b></p>				
<p><b>Work Experience 12A and 12B</b> claims must meet the directives of the <a href="#">Elective Work Experience Courses and Workplace Safety Policy, MO237/11 Work Experience Order</a>, and in accordance with the <a href="#">Program Guide for Ministry-Authorized Work Experience Courses</a>...when tracking hours related to the work study program segment of WEX12, each of these four credit courses are only claimed once regardless of the number of reporting periods the student requires to complete the work placement component. (Ref. Form 1701 Instructions P.15)</p>				
<p><i>In order to be reported as a Ministry-authorized Work Experience 12A or 12B course, the work experience must be supported and monitored by the school and <b>consist of authentic workplace experiences.</b></i>(Ref. Elective Work Experience policy)</p>				
<p><b>Definition: “standard work site”</b> means a location, other than a work site created specifically for work experience by a school or board,(a) at which a worker performs the tasks and responsibilities related to an occupation or career under the general supervision of an Employer, or (b) at which a self-employed person performs the tasks and responsibilities related to that person’s self-employment (Ref. Work Experience Order)</p>				
<p><b>Audit Steps:</b> use the auditor’s Career Program checklist for WEX. (WEX hours not to overlap with WRK11A/B and 12A/B but OK to fulfill 30 hours of career explorations for Career-Life Connections.)</p>				
<p><b>Before undertaking work study program portion of WEX course:</b></p>				
<ul style="list-style-type: none"> <li>• Boards must establish guidelines regarding conduct, supervision, evaluation and participation of students in all school-arranged work placements</li> <li>• There must be a training plan of skills and areas of knowledge to be developed and demonstrates student’s progress for each of the WEX courses</li> <li>• Students must have an in-school orientation</li> <li>• There must be a duly signed Work Experience Agreement Form</li> <li>• Evidence students are at sites where WorkSafeBC coverage is provided</li> </ul>				
<p><b>During/after work study program portion of WEX course:</b></p>				
<ul style="list-style-type: none"> <li>• Evidence school personnel have monitored students in accordance with Board guidelines</li> <li>• An educator with valid teaching certificate must evaluate the performance of all students in work experience courses and assign final percentages</li> </ul>				
<p><b>NOTE:</b> Students on the Adult Graduation Program are eligible for both WEX 12A and 12B. “Credit can be awarded for current or past work experience via prior learning assessment provided that appropriate procedures are followed.</p>				
<p><b>NOTE:</b> While not funding eligible, “A board may recognize a student’s current or past paid employment as Work Experience, provided that the student satisfies the board that the employment provides or provided for coverage for student under the Workers Compensation Act as confirmed in writing by</p>

<b>Post-Secondary Transition Programs (Dual Credit) (non-graduated school-age only)</b>				
<p><i>Post-secondary transition programs are educational programs that combine secondary and post-secondary courses, and that lead to Grade 12 graduation as well as to help students make smooth transitions to further education or training...Ministry of Education and Child Care recognizes post-secondary courses for funding purposes if they are part of the school-age students' planned programs of study leading to graduation. (Ref. <a href="#">Recognition of Post-Secondary Transition Programs for Funding Purposes policy</a>). Courses taken in BC outside of the public school system (through colleges, post-secondary institutions, private organizations, etc.) are not funded unless permission and support is arranged through the Board of Education and the course is taken for credit towards Grade 12 graduation. (Ref. <a href="#">K-12 Funding-General Policy</a>).</i></p>				
<p><b>Youth Train in Trades (TRN)</b> is a type of dual credit in which students take courses that will provide both high school graduation credits and apprenticeship technical training. (TRN hours are not to overlap with WEX12A/12B, WRK11A/B, or WRK12A/B, nor to fulfill 30 hours of career explorations for Career-Life Connections.)</p>				
<p><b>Audit Steps:</b> use the detailed PSI audit steps document – the criteria are based on Ministry directives verifying Post-Secondary Transition Program course claims.</p>				
<ul style="list-style-type: none"> <li>• Students begin taking the post-secondary courses that are part of their transition program during their Grade 11 or Grade 12 year and are taken for credit towards Grade 12 graduation.</li> <li>• Post-secondary courses lead to a post-secondary credential from a member of the <a href="#">BC Transfer System</a>, or Le Collège Éducacentre (for courses offered in French), or a SkilledTradesBC certified Youth Program training provider.</li> <li>• District has a current agreement with the post-secondary institution(s).</li> <li>• School district pays tuition costs for post-secondary courses reported for funding.</li> <li>• Student signs a planned program of courses, updated annually, listing the transition program course(s).</li> <li>• There is evidence that the purchased educational services are under the general supervision of an employee of the board who is a certificate holder per Sec.86 <i>School Act</i>.</li> </ul>				
<p><b>NOTE:</b> To be eligible for Ministry funding, a dual credit course must be taken by a school-age student and start prior to June 30<sup>th</sup> of their Grade 12 year.</p>				
<ul style="list-style-type: none"> <li>• <b>NOTE:</b> Questions about how to offer TRN and other dual credit opportunities in compliance with current policy are answered online (see the <a href="#">dual credit policy FAQ</a>)</li> </ul>

(Ref. <i>Adult Funding Policy</i>)</li> </ul> <p><b>Definition:</b> a graduated student is defined as adults that completed the requirements for graduation from a secondary school or high school in any jurisdiction (See Sec 82 <i>School</i></p>	<p>Verification that the district has claimed only eligible courses for graduated adult students.</p> <p>Confirmation that the district has passed a motion to provide tuition-free education to graduated adults.</p>	<p>Whether the sampled graduated adult FTE represent eligible courses in accordance with relevant policy and legislation for graduated adults.</p> <p>Whether the district has notified the Ministry of their motion to provide tuition-free</p>	<p><b>Key Documents:</b> As above.</p> <p><b>Audit Steps:</b></p> <ol style="list-style-type: none"> <li>1.
