### **Criteria for Educators**

- ✓ Hold a valid BC Ministry of Education and Child Care Certificate of Qualification and be in good standing with the Teacher Regulation Branch;
- ✓ Current Grade 10-12 educator in a BC-certified school. Must have experience with:
  - the BC Ministry of Education and Child Care's Grade 10 curriculum launched in 2018/19; and
  - the BC Ministry of Education and Child Care's Grade 11/12 curriculum launched in 2019/20.
- ✓ Educators may be affiliated with the External Credential organization; however, this is not a requirement. If affiliated, the educator must approach this process impartially.

## **Criteria for Subject Area Experts**

- ✓ Minimum 3 years of experience with the subject matter as an instructor, examiner and/or evaluator. Must possess any provincial, national, or international certification required by their position.
- ✓ Subject area experts may be affiliated with the applying organization; however, this is not a requirement.
- ✓ Include a CV (Curriculum Vitae) for each subject area expert with each application.

The application must provide evidence demonstrating how:

- The credential meets or exceeds the breadth, depth, and rigour of a Ministry course;
   and
- The content of the course or program fosters the development of the core competencies (communication, critical thinking, personal and social) and/or supports student transitions and lifelong learning.

If an organization is applying to have multiple credentials recognized, an Application for Recognition of Credential must be completed for each credential. Please include a rationale for why the credential should be approved, as well as a rationale for the credits and Grade level requested. If a more substantial response is required than space available, please attach any additional information or documentation as required.
