Criteria for External Credential Organizations

Applying organizations are to confirm how they meet these mandatory criteria:

- Organizations have a provincial, national, or international governing body.
- Organizations have provincial, national, or international standards and examinations or evaluations, and there must be public or professional recognition of those standards.
- Organizations have non-discriminatory enrolment practices, and courses are accessible to a significant number of BC students in more than one district or region, including those from families of limited financial means.
- Organizations have a provincial, national, or international certification or selection process for instructors, examiners and/or evaluators as well as a process by which instructors, examiners and/or evaluators may be decertified or dismissed if their actions are deemed unprofessional, unethical, or illegal.
- Organizations issue credentials that can be verified, which indicate successful completion of a credential and specify the performance level.
- Courses are educational in nature, respectful of differences, and free from prejudice.
