**ON THE APPLICATION** of the Petitioner, the Honourable Melanie Mark, Minister of Advanced Education, Skills and Training, coming on for hearing at Vancouver, British Columbia on December 14, 2018 and on hearing Kate A. Hamm, counsel for the petitioner, and the respondent Hardashan Sandhu on behalf of all respondents.

**THIS COURT ORDERS that:**

1. Global 1 Traders Inc. and Hardashan Sandhu, doing business as Global 1 University.com, are permanently enjoined and restrained from doing the following under that name or at all:
  - a. using the term “university” or an abbreviation, via the Internet or in any other written or oral form, to indicate that educational or degree programs


are available through them or a business that they control, without the consent of the Minister of Advanced Education Skills, and Training;

- b. providing any degree programs, or component courses of a degree program, via the Internet, or in any other written or oral form, without the consent of the Minister of Advanced Education, Skills and Training; and
  - c. advertising, via the Internet or in any other written or oral form, degree programs, or component courses of degree programs, without the consent of the Minister of Advanced Education Skills, and Training.
2. The Honourable Melanie Mark, Minister of Advanced Education, Skills and Training is awarded costs in this proceeding.
  3. The requirement of the signature of the respondents is dispensed with.
  4. This order of the court may be filed in the Vancouver Judicial District.
