THIS COURT ORDERS that

1. Under section 8(1) of the *Degree Authorization Act* SBC 2002 c 24 ("the Act") each of the Defendants be and the same is hereby restrained from directly or indirectly within British Columbia

- (a) granting or conferring a degree within the meaning of the Act (which does not include a degree in theology);
- (b) advertising or otherwise offering to persons for sale a diploma, certificate, document or other material that indicates or implies the granting or conferring of a degree within the meaning of the Act in British Columbia;
- (c) selling or providing by agreement for a fee, reward or other remuneration, a diploma, certificate, document or other material that indicates or implies the granting or conferring of a degree within the meaning of the Act in British Columbia

unless authorized to do so by the Plaintiff.
