

GUANGDONG SCHOLARSHIP PROGRAM APPLICATION

Instructions for Applications

Scholarship Information

The Guangdong Scholarship Program is available through an agreement between the Department of Education of Guangdong Province, People's Republic of China (PRC) and the Province of British Columbia (B.C.).

Through this program, the Department of Education of Guangdong Province, PRC offers scholarships to students from British Columbia to study in China at selected post-secondary institutions (see *Eligible Institutions in Guangdong* Section). It is a valuable opportunity to gain exposure to Chinese language, culture and business practices, and to develop enriching, life-long relationships.

Scholarships will be available to eligible B.C. K-12 and post-secondary students to complete a four-year undergraduate degree in Guangdong Province, PRC. Students will commence study in September 2019 and will receive funding until spring 2023. It is a one-time, non-renewable scholarship.

Value of Scholarship

A scholarship covers tuition fees, accommodation, living expenses and medical insurance. Annual funding of approximately \$13,500 is transferred to the institution of choice for disbursement. The total value of a four-year scholarship is approximately \$54,000.

NOTE: The cost of the flight to China is not covered under scholarship.

Award Value: approximately \$54,000

Application Deadline: March 29, 2019

Eligibility Criteria

The following criteria must be met to be eligible to apply for this scholarship. Applicant must:

- be a Canadian citizen, permanent resident (landed immigrant), convention refugee, or protected person living in Canada;
- be a resident of British Columbia, defined as having a primary residence in the province for at least 12 consecutive months prior to the date of full-time enrollment in the program for which the scholarship is applied for;
- have clearly demonstrated significant community and/or school involvement and academic achievement, supported by two references submitted with the application;
- be graduating secondary school students and students enrolled in post-secondary studies at eligible¹ post-secondary institutions;
- have not immigrated from China within the past 10 years; and
- have a valid Canadian Passport.

¹ Eligible B.C. post-secondary institutions include all B.C. public post-secondary institutions.



Eligible Institutions in Guangdong

British Columbia students will attend one of three institutions identified by the Department of Education of Guangdong Province, PRC including:

- South China University of Technology
- Jinan University
- Guangzhou University of Chinese Medicine

Applicants are requested to rank institutions as personal preferences from the list of eligible institutions. Preferences will be taken into account but choices are not guaranteed.

Applicants are **recommended** to apply to institutions of choice to obtain a pre-acceptance letter at the same time as submitting the scholarship application. This may improve the ability to attend a university of choice. If the applicant does not have a preference, obtaining a pre-acceptance letter is not required at this time.

Application Materials

Applicants must provide a copy of the following materials

- 1. **Application form** (completed digitally in English and printed off).
- 2. **Official transcripts** from the most recent place of study, which could include either a senior high school or a post-secondary institution. The transcripts must be in an envelope sealed by the school or institution or it must be a notarized photocopy. Applicants must also include a notarized photocopy of any diplomas, certificates or degrees. Documents in languages other than English must be translated into English and notarized.
- 3. A study or research plan that describes the applicant's short and long-term study goals, including what areas of knowledge will be acquired during the course of study and how applicants plan to make use of this knowledge in their future careers.
- 4. **Two letters of reference** in English on the attached letter of reference form. One of these letters must be from a person who has taught the applicant. Reference letters may be submitted as paper letters or electronically as a PDF copy of the reference letter. Paper letters should be sent by the referee to the applicant in an envelope the referee has sealed and signed. Alternately, PDF copies of the reference letter must be sent from the referee directly to AEST.PlanningInternationalandIntergovernmental@gov.bc.ca. The title of the email should be "Reference Letter: Guangdong Scholarship Program." The email must include the applicant's name and the referee's contact details.
- 5. A Foreigner Physical Exam Form is required. The form is available via the following link:
 - Application for Medical Examination
 - Physical Examination Record for Foreigner

Incomplete medical records or those without the signature of the attending physician, the official stamp of the hospital or a sealed photograph of the applicants are invalid.

- 6. **Legal consent and guardianship documents** for applicants under the age of 18 only. Once completed, this document must be translated into Chinese and notarized. The notarized document must also be legalized by the Consulate General of the PRC in Vancouver and the Government of British Columbia. The letter is available via the following link:

Scholarship Evaluation and Notification

- The Ministry of Advanced Education, Skills and Training, in collaboration with the Ministry of Education, is responsible for the application evaluation of the Guangdong Scholarship Program in British Columbia.
- Award recipients will be chosen based on an evaluation of all applications.
- Applications that are incomplete will not be eligible for selection.
- Successful applicants will be notified by email by the end of April 2019.

Personal Information

By submitting this Guangdong Scholarship Program Application the applicant is consenting to the collection, storage, and use of the submitted personal information by the B.C.
