Collection Notice:

The Security Programs Division (SPD) will collect your personal information for the purpose of fulfilling the requirements of the Cannabis Control and Licensing Act (CCLA) and associated regulations in cannabis licensing, and compliance and enforcement matters in accordance with sections 26(a) and (c) of the Freedom of Information and Protection of Privacy Act (FolPPA) and section 10 of the CCLA, and section 20 of the Cannabis Licensing Regulation. Additionally, SPD may collect personal information under section 26(e) of FolPPA for the purpose of evaluating the Liquor and Cannabis Regulation Branch (LCRB) programs and activities to better serve you. Declaration and Consent:

I, the undersigned, authorize the collection of any and all information related to the security screening checks in support of this application by the Royal Canadian Mounted Police (RCMP) and other federal government institutions under the Privacy Act for the purpose of conducting a check of criminal investigations, charges, convictions and information in police databases including incidents that did not result in conviction. I also authorize the provision of my personal information on this application by the BC Municipal Law Enforcement Agencies as well as other authorized public bodies under FolPPA for the same purpose.

I consent to the disclosure to the SPD and LCRB by the RCMP, the BC Municipal Law Enforcement Agencies as well as other authorized public body agencies of any personal information related to my security screening checks under the Privacy Act, FolPPA, and other relevant applicable provincial and federal legislation. The personal information may include: (a) criminal record check or fingerprint-based criminal record verification by searching the Canadian Police Information Centre database; (b) a police information check, including the Police Records Information Management Environment (PRIME-BC) and the Police Reporting and Occurrence System (PROS); (c) a check of intelligence databases maintained by law enforcement agencies. The security screening checks could result in disclosure of any information in the named database regardless of whether a conviction resulted.

Note that as part of the security screening process, SPD will also complete a check of records in the justice information system of the Ministry of Attorney General and in the corrections information system of the Ministry of Public Safety and Solicitor General.

I certify that, to the best of my knowledge, the information I have provided on my application and will provide as necessary is complete, honest and accurate. I understand that a false statement or omission of facts herein may be grounds for a finding that the applicant is not fit and proper, which could lead to a denial of a cannabis retail licence pursuant to the CCLA. I am also aware that later discovery of an omission or misrepresentation may be grounds for a finding that an applicant or licensee is not fit and proper, which could lead to enforcement action such as the suspension or cancellation of a licence.
