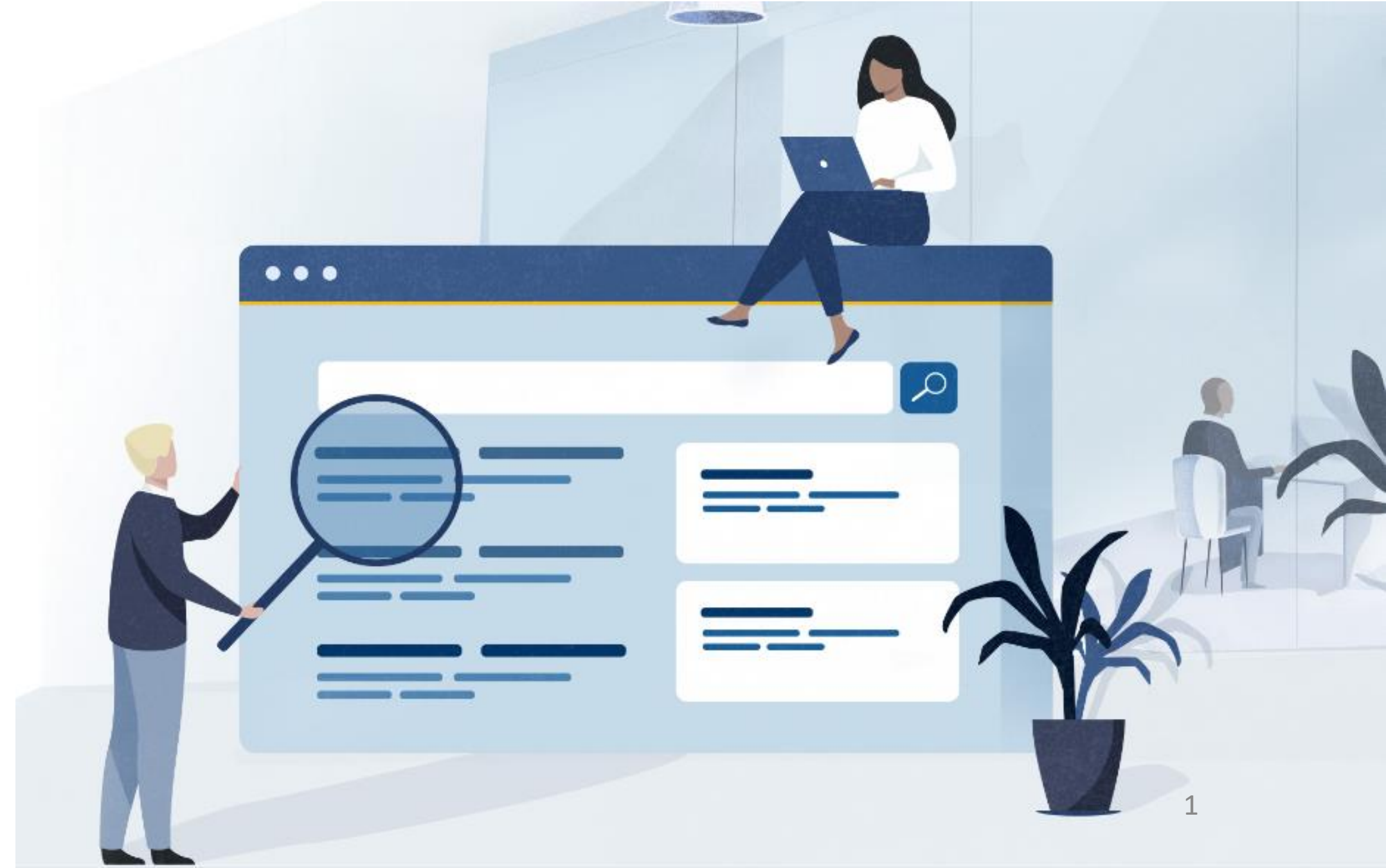

Go to BC Registries and Online Services <https://www.bcregistry.gov.bc.ca/en-CA/login>

If you see that your company's information needs to be updated, such as the address or directors, make these changes before filing the annual report.

This alert shows when one or more annual reports still need to be filed.

(1) In the **"To Do"** list, find the annual report you want to file.

(2) Check the box that says, **"All information about the Office Addresses and Current Directors is correct."**

(3) Then select **File Annual Report**

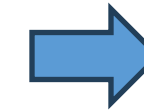

Legal Obligations Reminder

You are required by the Business Corporations Act to keep the information about your corporation up to date with the Registrar. The most common information you are legally responsible to update includes:

- Annual Reports** - file an annual report each year within two months after each anniversary of the date on which the company was recognized. This ensures your company remains in good standing with the Registrar.
- Director Changes** - update director information within 15 days of any change (appointing, ceasing or updating an existing director's name or address).
- Company Address Changes** - update any changes to a company's registered or records office addresses as they occur.

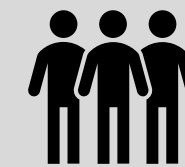
