

PPR Quick Guide: PPR dashboard and using the My Registrations table

PPR dashboard is used to:

- Search for personal property liens
- Register a security agreement or lien
- Amend, renew or discharge a registration

Conduct a search by selecting a search category and entering search value

Search result reports (PDF) are stored in the My Searches table for approximately 30 days

Click 'Create New Security Agreement' to register a security agreement or the dropdown arrow for more lien types, like a Repairer's Lien

Registrations are stored in the My Registrations table, from where a user can amend, renew, or discharge a registration; registration drafts and Verification Statements are also stored here

Using the My Registrations table

Click 'Create New Security Agreement' to register a security agreement or the dropdown arrow for more lien types

To amend, renew, or discharge a registration, it must be present in the My Registrations table; retrieve and add an existing registration to the table by entering the known registration number in field and clicking on the magnifying glass

Click 'Show/Hide Amendments' to view any amendments, renewals, or discharges related to a base registration; amendments are located below the base registration and together are marked by a blue background
