Declaration

By submitting your application, you:

- a) confirm that you have reviewed and agree to the following terms; and
- b) declare that all of the following statements are true as they relate to your business:

I understand that I am applying for the Small and Medium Sized Business Recovery Grant, which is intended to support the long-term recovery and viability of my small business in B.C.

All information provided in my Grant Application and supporting documents, including my recovery plan is true, complete and accurate.

I was not planning to sell or close my business prior to March 10, 2020.

I understand that in order to be eligible to apply for the Small and Medium Sized Business Recovery Grant, or to continue with this application, I must develop or demonstrate that I have a recovery plan that is consistent with the criteria of this program and clearly shows my business is currently solvent, or could regain solvency upon grant funding, and has a viable path into the future.

I confirm that all the actions and activities identified in my recovery plan can be implemented and that I have or will obtain all permits, permissions or approvals necessary to give effect to my recovery plan.

I understand that grant funding received through this program must be used to support the actions identified in my recovery plan, or to help with short term recovery measures that will assist with regaining viability / solvency.

I understand that to be eligible for this grant, I must provide consent for the Province of B.C. to conduct a third party review of my recovery plan and I will provide supporting documents to such third parties as part of this review.

I confirm that I understand that the personal information collected through this application process is collected for the administration of Small and Medium Sized Business Recovery Grant including to confirm residency, under s.26(c) of the Freedom of Information and Protection of Privacy Act. I also confirm that I have obtained authorization from the employees to whom the personal information relates to share that information with the Ministry for the above mentioned purposes.
