- 2.2 Obtaining prior-written approval from the Deputy Inspector of Dikes for any subsequent changes and/or modifications to a project already approved under the *Dike Maintenance Act*.
- 2.3 Unless differently specified by the *Dike Maintenance Act* Approval issued for the project, within 60 days after project completion providing the Deputy Inspector of Dikes the following:

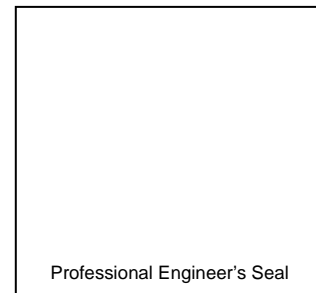
