#### One Hospital.





R.W. Large Memorial Hospital has fifteen beds total – 9 acute and 6 Residential. There is a four bed emergency department and a physicians clinic and retail/hospital pharmacy located on the premises. It is the only Residential Care facility in the area and there are no private care homes. Opportunities to reduce GreenHouse Gases (GHG) are not readily available to us due to our remote site. Wherever we can we recycle electronic goods and containers. The community we serve is approximately 1,600 people and is very remote on the Central Coast of B.C.

#### Summary of Actions Taken in 2013:

**Boiler repairs were done to the main furnaces in 2013 to repair failing equipment.  
VCH funded the repairs through Minor Capital Funding.**

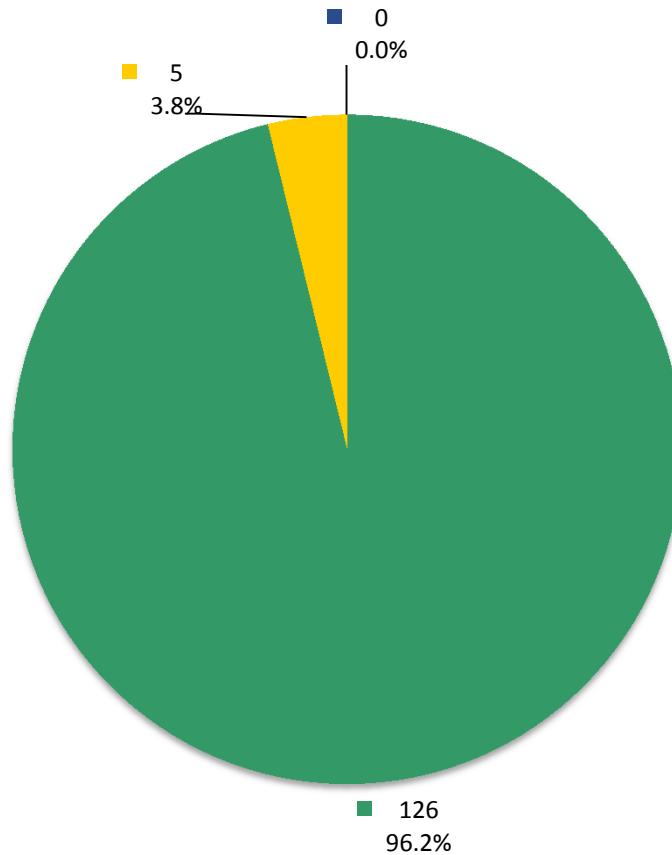

\*Tonnes of carbon dioxide equivalent (tCO<sub>2</sub>e) is a standard unit of measure in which all types of greenhouse gases are expressed based on their global warming potential relative to carbon dioxide.

\*\* Under the *Carbon Neutral Government Regulation of the Greenhouse Gas Reduction Targets Act*, all emissions from the sources listed above must be reported. As outlined in the regulation, some emissions do not require offsets.
