Going forward FII will continue to contribute to BC's carbon reduction targets through additional initiatives and strategies as appropriate.

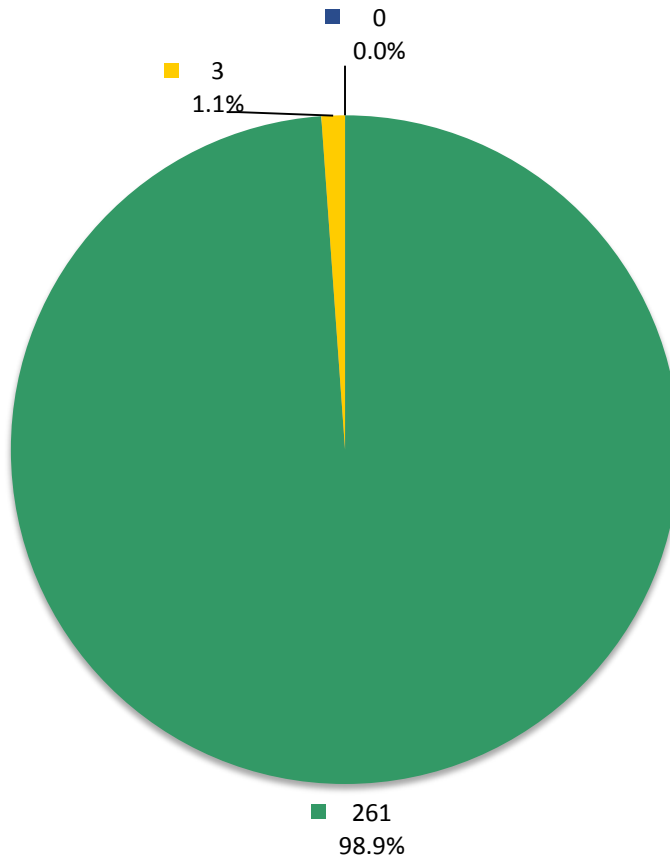
