Briefly describe the top three actions taken by your organization in 2017 to reduce GHG emissions and/or improve sustainability from its operations:

## Action

- 1. Composting in the staff kitchen continued in 2017. Kitchen food waste is transported to the Castlegar Community Garden and composted. The composted food waste is then used in the community garden as a soil amendment.
- 2. Columbia Power continues to undergo facility lighting upgrades to energy efficient LED lights. The Brilliant Expansion Facility and Brilliant Dam lighting upgrades continued in 2017.
- 3. Columbia Power encourages staff carpooling. Staff are also encouraged to select fleet vehicles that are most appropriate for the intended use. It is encouraged that people use the most fuel efficient fleet vehicles, when available.

Briefly describe plans your organization has for continuing to reduce your GHG emissions in future years:

Columbia Power plans to expand general recycling at its facilities and office in 2018 and include the recently expanded list of items that are accepted through the Regional District recycling program.

Describe any actions your organization took during 2017 to strengthen its ability to manage the likely effects of climate change in the coming years and decades (e.g., have assessed whether increased frequency of extreme weather events and/or long term changes in climate will affect your organization's infrastructure, its employees and/or its clients.)

Columbia Power is investigating how climate change will impact water management in the Columbia Basin and how these changes will impact the management of the hydroelectric facilities.

the retirement of the offsets obligation reported above for the 2017 calendar year, together with any adjustments reported for past calendar years. The Organization hereby agrees that, in exchange for the Ministry of Environment and Climate Change Strategy ensuring that these offsets are retired on the Organization's behalf, the Organization will pay the associated invoice to be issued by the Ministry in an amount equal to \$25 per tonne of offsets retired on its behalf plus GST.
