Title: 2020 PSO Climate Change Accountability Report

Organization: The First Peoples' Cultural Council

**Declaration statement:** This Climate Change Accountability Report for the period January 1, 2020 to December 31, 2020 summarizes our emissions profile, the total offsets to reach net-zero emissions, the actions we have taken in 2020 to reduce our greenhouse gas emissions and our plans to continue reducing emissions in 2021 and beyond.

## Overview:

- Our default printing mode continues to be double-sided.
- We use sugar sheet paper which promotes protection of B.C's old growth forests and vibrant ecosystems. Sugar sheet is 100% recyclable, chlorine-free, acid-free paper that lasts longer than regular-use printing paper.
- Our staff regularly conducts meetings via video conference, and teleconference.
- We transmit most documents electronically. We store all our files electronically.
- We continue to turn off lights, small appliances, and electronics at night. We have a motion-activated lighting system to ensure lights are switched off when not in use.
- Many staff worked from home prior to the COVID-19 pandemic, and many will continue to do so.
- Our new online grant portal eliminates the need associated with freight costs.
- Our new efficient office design maximizes available square footage. Staff are assigned small workspaces, with access to "pods" and small meeting rooms.

## **Optional Content:**

- Working from home has reduced GHGs that result from paper consumption, transportation, and from heating and cooling of office space.
