# **PART 1. Legislative Reporting Requirements**

**Declaration statement:** This PSO Climate Change Accountability Report for the period January 1, 2023 to December 31, 2023 summarizes our greenhouse gas (GHG) emissions profile, the total offsets to reach net-zero emissions, the actions we have taken in 2023 to minimize our GHG emissions, and our plans to continue reducing emissions in 2024 and beyond.

#### **Emission Reductions: Actions & Plans**

#### A. Stationary Sources (e.g. buildings, power generation)

- 1) As a part of the ongoing review for space requirements CLBC is continuing with the Leading Workplace Strategy approach for locations that are coming up for lease renewals to align with our Hybrid Workplace model
- 2) In 2023, Community Living BC is working on upgrading lighting as part of the tenant improvements projects to address energy consumption.
- 3) Future office space projects will incorporate LWS to maintain the existing office footprint rather than increase it to accommodate additional staffing.

#### B. Mobile Sources (e.g. fleet vehicles, off-road/portable equipment)

1) In 2024, and ongoing, Community Living BC will review existing inventory and consider replacement of vehicles in urban areas to EVs. The availability of EV charging stations will be taken into consideration.

### C. Paper Consumption

- 1) In 2024, Community Living BC will consider alternative sources of paper such as bamboo, hemp, and wheat.
- 2) In 2024, Community Living BC will be moving towards digital document management to reduce paper consumption.
