**Declaration statement:** This PSO Climate Change Accountability Report for the period January 1, 2025 to December 31, 2025 summarizes our greenhouse gas (GHG) emissions profile, the total offsets to reach net-zero emissions, the actions we have taken in 2025 to minimize our GHG emissions, and our plans to continue reducing emissions in 2026 and beyond.

#### **Emission Reductions: Actions & Plans**

- *Infrastructure BC continues to use recycled paper for its printers and copiers.*
- *Infrastructure BC limits paper printing and opts to use an electronic records management system.*
- *Infrastructure BC prints paper in double sided forms and puts papers in recycled bins for recycling.*
- *Infrastructure BC limited the amount of travel between its Victoria and Vancouver offices in 2025 and continues to promote the use of its video conference facilities for virtual meetings in place of in-person meetings.*
- *Infrastructure BC continued its organics/composting program to reduce the amount of kitchen waste.*

#### **Disclosure**

- *Infrastructure BC's Victoria site has expanded; therefore, emissions have slightly increased.*
