Terms defined in the Act or Regulation is capitalized in this document.

Operators applying for designation as an opted-in **Linear Facility Operation (LFO)** to the B.C. Output Based Pricing System (B.C. OBPS) as both a reporting operation and a regulated operation must complete their application using this form and submit to GHGRegulator@gov.bc.ca. The following formatting should be used:

Introduction

Under Section 41.1 of the Regulation, for the purpose of section 20.1 of the Act, the Operator of an industrial operation may apply to the Director, in accordance with the requirements of the Regulation, for designation as an opted-in operation that is a regulated operation. If the application is for a designation that is intended to be effective for April 1, 2024, this application must be completed **as soon as possible**. For the 2025 reporting year the application must be completed by August 1, 2024.

Before completing this application form, you must apply for a B.C OBPS Regulated Operation ID (BORO ID) on the [B.C. Industrial Emissions Reporting System](#) (BCIERS) web application.

Section 11.2(1)(b) of the Regulation requires that an operation making an application under section 20.1 of the Act for designation as an opted-in operation must register in accordance with section 11.3 of the Regulation. The information required in the BC Industrial Emissions Reporting System (BCIERS) web application when applying for a BC OBPS Regulated Operation ID (BORO ID), as well as the completion of the additional registration fields in this form, fulfils that requirement. This form also contains additional fields to confirm eligibility and complete your application for designation as an opted-in operation.
