## **Directions for delegation of sections 93.4 and 93.6 of the *Land Act***

### District Managers:

The delegated authority is limited to amending old growth management areas (OGMAs) in an order made under section 93.4. Amending OGMA orders includes

- additions or deletions to the boundaries of one or more OGMA polygons,
- deleting existing OGMA polygons, and
- establishing replacement OGMA polygons.

Amending OGMA orders does not include the authority to make OGMA amendments that will have substantial social economic and environmental implications.

### Direction:

The delegated powers and duties are subject to the following direction:

- The district manager must consider the Land Use Objectives Regulation: Policy and Procedures document and where they exist, regional and sub-regional policies, procedures or similar direction for processing OGMA amendments in making a decision on an OGMA amendment.

Any change to an OGMA established under the *Land Act* for the purposes of the *Forest and Range Practices Act* requires a change to the corresponding OGMA established under the *Oil and Gas Activities Act*. This will ensure the areas remain the same across industries.

### Regional Executive Directors:

#### Direction:

The delegated powers are subject to the following direction:

The regional executive director must refer to establishment of land use objectives to the Minister for decision when

- the initial establishment of objectives that have arisen from a Land and Resource Management Plan or Regional Land Use Plan are, in the opinion of the regional executive director, objectives that would have substantial social, environmental or economic implications, or
- any other actions to establish, amend or repeal objectives are in the opinion of the regional executive director, likely to have substantial social, environmental or economic implications.
