#### Re: Designation of Assistant Water Managers

I, Lori Halls, Deputy Minister of Water, Land and Resource Stewardship, under Section 114 (4) of the *Water Sustainability Act*, designate the public service employees listed in Appendices 1 to 9, Appendix 11, and British Columbia Energy Regulator employees listed in Appendix 10 as Assistant Water Managers.

The persons listed in the appendices (designated as Assistant Water Managers) are authorized to exercise all the powers and perform all the duties of an Assistant Water Manager under the *Water Sustainability Act* and its regulations in all areas of the Province.

The exercise of authority as an Assistant Water Manager is as provided under applicable legislation and guided by the policies and procedures of the Ministry of Water, Land and Resource Stewardship.

The designation as an Assistant Water Manager remains in effect until the employee designated ceases to be a British Columbia public service employee or a British Columbia Energy Regulator employee, as applicable, or until the designation is rescinded by the Minister of Water, Land and Resource Stewardship, whichever is earlier.

This designation revokes and replaces the previous Designation of Assistant Water Managers, signed by the Deputy Minister of Water, Land and Resource Stewardship and dated July 15, 2024.
