Re: Designation of Water Officers

Under Section 114 (6) of the *Water Sustainability Act*, I designate the public service employees listed in Appendices 1 to 9 and British Columbia Energy Regulator employees listed in Appendix 10 as a Water Officer.

The persons listed in the appendices (designated as Water Officers) are authorized to exercise all the powers and perform all the duties of a Water Officer under the *Water Sustainability Act* and its regulations in all areas of the Province.

The exercise of authority as a Water Officer is as provided under applicable legislation and guided by the policies and procedures of the Ministry of Water, Land and Resource Stewardship.

The designation as a Water Officer remains in effect until the employee designated ceases to be employed by the Ministry of Water, Land and Resource Stewardship or a British Columbia Energy Regulator employee, as applicable, or until the designation is rescinded by the Comptroller of Water Rights, whichever is earlier.

This designation revokes and replaces the previous Designation of Water Officers, signed by the Comptroller of Water Rights and dated January 7, 2025.
