MODIFICATION AGREEMENT North Coast Cumulative Effects Demonstration Project Agreement

THIS MODIFICATION AGREEMENT dated for reference March 31, 2018 (the "Reference Date")

BETWEEN:

Her Majesty the Queen in Right of the Province of British Columbia, as represented by the Minister of Energy, Mines and Petroleum Resources, Minister of Indigenous Relations and Reconciliation and the Minister of Forests, Lands, Natural Resource Operations and Rural Development (the "Province")

AND:

Gitxaala First Nation, Gitga'at First Nation, Kitselas First Nation, Kitsumkalum Indian Band, and Metlakatla First Nation as represented by their Chief or authorized representative (the "Participating Coastal First Nations" or "PCFNs")

(Hereinafter referred to individually as a "Party" and collectively as the "Parties")

WHEREAS

- A. The Parties entered into the Environmental Stewardship Initiative North Coast Cumulative Effects Demonstration Project Agreement dated for reference November 24, 2016 (the "Agreement").
- B. The Parties have agreed to modify the Agreement.

NOW THEREFORE in consideration of the promises and mutual covenants and agreements set out hereinafter, the Parties agree as follows:

- 1. The reference to "Demonstration" in the title of the Agreement is removed.
- 2. Recital A is deleted and is replaced with the following:
 - "A. The Environmental Stewardship Initiative ("ESI") is a collaborative government to government initiative between the Province and First Nations intended to generate a positive environmental stewardship legacy through projects related to:
 - ecosystem assessment and monitoring;
 - ecosystem restoration and enhancement;
 - ecosystem research and knowledge exchange; and
 - stewardship education and training."

- 3. Subsection 2.1.3 is deleted and is replaced with the following:
 - "2.1.3 undertake a process to understand the potential gaps in cumulative effects assessment and monitoring initiatives within the traditional territories of the PCFNs, and inform decision-making by the Parties on aligning environmental values for the Cumulative Effects Project with other existing and potential cumulative effects initiatives:"
- 4. Subsection 3.1.1.2 is deleted and is replaced with the following:
 - "3.1.1.2 implement the Agreement and reach major milestones in a timely manner by March 31, 2021; and,"
- 5. Subsection 3.1.3.2 is deleted and replaced with the following:
 - "3.1.3.2 the capacity and travel costs of PCFN representatives to participate in the RSF and Project Team shall be in accordance with the ESI North Coast Project Participation letters of agreement entered into by each PCFN and the Province."
- 6. Subsection 3.1.6 is deleted and is replaced with the following:
 - "3.1.6 The Parties agree that the Nisga'a Nation, Haisla Nation and Lax Kw'alaams may become a party to this Agreement by executing with the Minister of Energy, Mines and Petroleum Resources on behalf of the Province an adherence agreement, in substantially the form attached at Appendix A to this Agreement ("Adherence Agreement") and this Agreement will be deemed to be amended as of the date the Adherence Agreement is fully executed.
- 7. Subsection 4.8 is deleted and replaced with the following:
 - "4.8 The term of this Agreement will be from November 24, 2016 until March 31, 2021, or when the elements in section 3.0 of the Agreement are completed to the satisfaction of the Parties, whichever is sooner."
- 8. Appendix A: Adherence Agreement is deleted and replaced with the form attached to this Modification Agreement.
- 9. In all other respects, the terms of the Agreement remain in effect.
- 10. This Modification Agreement will commence on the Reference Date.

11. This Modification Agreement may be entered into by each Party signing a separate copy of this Agreement and delivering it to the other Party by facsimile or electronic transmission.
