(the "Agreement")**

**KAMLOOPS FOREST DISTRICT**

**Between:  
The Skeetchestn Indian Band**

**As represented by  
Chief Edward Jules and Council  
(the "Skeetchestn Indian Band")**

**And**

**Her Majesty the Queen in Right of the Province of British Columbia  
As represented by the Minister of Forests and Range  
(“British Columbia”)**

**(collectively the "Parties")**

**Whereas:**

- A. British Columbia and First Nations Leadership Council, representing the Assembly of First Nations-BC Region, First Nations Summit, and Union of BC Indian Chiefs ("Leadership Council") have entered into a New Relationship in which they are committed to reconciliation of Aboriginal and Crown titles and jurisdiction, and have agreed to implement a government-to-government relationship based on respect, recognition and accommodation of Aboriginal title and rights.**
- B. This Agreement is in the spirit and vision of the "New Relationship".**
- C. Work is underway regarding the implementation of the New Relationship and that this Agreement may need to be amended in the future to reflect the outcomes of that work.**
- D. The Skeetchestn Indian Band has a relationship to the land that is important to its culture and the maintenance of its community, governance and economy.**
- E. The Skeetchestn Indian Band has Aboriginal Interests within its Area of Interest.**

- F. Skeetchestn hopes that this interim measures agreement will represent an initial step towards their longer term goal of achieving a long-term, economically viable, renewable forest tenure, such as a Community Forestry Agreement, within the Deadman and Durand watersheds.**
- G. Skeetchestn hopes that this interim measures agreement will represent an initial step towards their goal of seeking further direct award access to Mountain Pine Beetle harvesting opportunities within the Area of Interest.**
- H Skeetchestn wishes to ensure that its Aboriginal Interests are considered appropriately in accordance with existing case law through participation in the Mountain Pine Beetle Action Plan and involvement in strategic level planning in general.**
- I The Parties wish to enter into an interim measures agreement in relation to forest and/or range resource development within the Traditional Territory.**
- J. References in this Agreement to Crown Lands are without prejudice to the Skeetchestn Indian Band's Aboriginal title and/or rights claims over those lands.**
- K. British Columbia intends to consult and to seek a workable Interim Accommodation with the Skeetchestn Indian Band on forest and/or range resource development activities proposed within the Skeetchestn Indian Band Traditional Territory that may lead to the infringement of the Skeetchestn Indian Band's Aboriginal Interests.**
- L. The Skeetchestn Indian Band intends to participate in any consultation with British Columbia or a Licensee, in relation to forest and/or range resource development activities proposed within the Skeetchestn Indian Band's Traditional Territory, that may lead to an infringement of the Skeetchestn Indian Band's Aboriginal Interests.**
- M. British Columbia and the Skeetchestn Indian Band wish to resolve issues relating to forest and/or range resource development where possible through negotiation as opposed to litigation.**

**Therefore the Parties agree as follows:**

## **1.0 Definitions**

**For the purposes of this Agreement, the following definitions apply:**

- 1.1 "Operational Decision" means a decision that is made by a person with respect to the statutory approval of an Operational Plan that has potential effect in the Skeetchestn Indian Band's Area of Interest.**
- 1.2 "Operational Plan" means a Forest Development Plan, Forest Stewardship Plan, Woodlot Licence Plan, a Range Use Plan, or Range Stewardship Plan, that has a potential effect in the Skeetchestn Indian Band's Area of Interest.**
- 1.3 "Aboriginal Interests" means aboriginal rights and/or aboriginal title.**
- 1.4 "Administrative Decision" means one or more of the following decisions made by a person under forestry legislation.**
- The making, varying or postponing of Allowable Annual Cut (AAC) determinations for a Timber Supply Area or a Forest Tenure;**
  - The issuance, consolidation, subdivision, amendment or boundary adjustment of a Forest Tenure or a Range Tenure;**
  - The adjustment of Animal Unit Months in a Range Tenure;**
  - The extension to the term of, or replacement of a Forest and/or Range Tenure;**
  - The disposition of volumes of timber arising from undercut decisions on a Forest Tenure;**
  - The conversion of a Forest Tenure to a different form of Forest Tenure;**
  - The reallocation of harvesting rights as a result of the implementation of the Forestry Revitalization Act;**
  - The issuance of a Special Use Permit;**
  - The decision regarding approval or extension of a Tree Farm Licence Management Plan, Community Forest Management Plan and/or Woodlot Licence Management Plan;**
  - The deletion or addition of provincial forest;**
  - The transfer of AAC between Timber Supply Areas;**
  - The removal of private land from a woodlot or Tree Farm Licence; and,**
  - The establishment of an interpretive forest site, recreation site and/or recreation trail.**

- 1.5 **“Forest Tenure” means an agreement granting rights to harvest Crown timber as defined in the Forest Act.**
- 1.6 **“Range Tenure” means an agreement granting rights over Crown range as defined in the Range Act.**
- 1.7 **“Area of Interest” means the Skeetchestn Indian Band’s area of interest defined specifically and only for the purposes of the Agreement and as shown on bold black on the map attached in Appendix A.**
- 1.8 **“Licensee” means a holder of a Forest Tenure or a Range Tenure.**
- 1.9 **“Workable Interim Accommodation” means the accommodation provided in this Agreement, of the potential infringements of the economic component of the Skeetchestn Indian Band’s Aboriginal Interests arising from or as a result of forest and range development, prior to the full reconciliation of these Interests. The Province acknowledges that the timber opportunities and funding provided through this Agreement are an interim accommodation only and that broader processes are underway that will assist in determining the appropriate accommodation in respect of impacts on the Skeetchestn Indian Band’s Aboriginal Interests as a result of forest activities occurring within their Area of Interest. The revenue component reflects the present budget limitations of the Minister of Forests and Range. It is acknowledged that other accommodations, including economic accommodations, may be jointly developed by the Parties during the term of this Agreement.**

**2.0 Purpose and Objectives**

**The purposes and objectives of this Agreement are to:**

- 2.1 **Create viable economic opportunities and to assist in the improvement of social conditions of the Skeetchestn Indian Band through economic diversification.**
- 2.2 **Provide interim payment and other economic benefits to the Skeetchestn Indian Band through a forest tenure opportunity and/or economic benefits related to forestry received by British Columbia from forest resource development.**
- 2.3 **Engage in consultation and provide Workable Interim Accommodation, as set out in this Agreement.**

- 2.4 Provide a period of stability to forest and/or range resource development on Crown lands within the Area of Interest of the Skeetchestn Indian Band during the term of this Agreement, while longer term interests are addressed through other agreements or processes.**

### **3.0 Economic Benefits to the Skeetchestn Indian Band**

**During the term of this Agreement, British Columbia will provide one or more of the following economic benefits to the Skeetchestn Indian Band:**

#### **3.1 Forest Tenure**

**After the execution of this Agreement, the Minister will invite the Skeetchestn Indian Band, or such legal entity as the Skeetchestn Indian Band has appointed as its representative to hold the licence to apply under the Forest Act for a Non-Replaceable Forest License (the "Licence") on a non-competitive basis for up to 25,064m<sup>3</sup>/yr in the Kamloops Timber Supply Area(s). Of this total, the uplift amount is 11,139m<sup>3</sup>/yr for 5 years totalling 55,695m<sup>3</sup>, and the base amount is 13,924m<sup>3</sup>/yr for 5 years totalling 69,620m<sup>3</sup>.**

**If the intended holder of the licence is a legal entity other than Skeetchestn Indian Band, this Agreement must include supporting documentation, as specified in Appendix C, stating that the intended holder has been validly appointed by the Skeetchestn Indian Band as its representative.**

**3.1.1 For greater certainty, the maximum volume that may be available under the Licence referred to in Section 3.1 will be up to 125,315 cubic meters over five years.**

**3.1.2 The Parties will strive to ensure that the assigned operating area for the Licence in the Kamloops Timber Supply Area has a representative timber profile and logging chance relative to other licensees and BC Timber Sales, taking into account the quality of timber, access and commercial viability. Prior to the Skeetchestn Indian Band making an application for the Licence, the Parties will work together to identify the location of an operating area for the Licence, which to the extent that it is operationally feasible will be within the Area of Interest.**

- 3.1.3 A Licence entered into as a result of an invitation under section 3.1 will be for a term of five years, with an option to enter into a subsequent licence in accordance with sections 7.1 and 7.2 of this Agreement.**
- 3.1.4 If the Licence remains in effect beyond the term of this Agreement, the Licence will continue to be considered by the Parties to be a Workable Interim Accommodation until the Licence expires or is terminated.**
- 3.1.5 The Minister may invite the Skeetchestn Indian Band to apply for a subsequent Licence under the Forest Act for a term that would commence after the expiry of this Agreement.**

## **3.2 Range Tenure**

**If crown range is available for disposition to Skeetchestn Indian Band, then Subject to the Range Act, the District Manager may be directed to enter into a Range Permit, within Skeetchestn Indian Band Area of Interest to the Skeetchestn Indian Band for up to 250 Animal Unit Months (AUMs).**

## **3.3 Interim Payment**

- 3.3.1 During the term of this Agreement, British Columbia will make an interim payment to the Skeetchestn Indian Band of approximately \$ 232,071 annually.**
- 3.3.2 The funding commitment set out in section 3.3.1 is subject to the availability of annual appropriations for that purpose by British Columbia.**
- 3.3.3 For the purposes of determining amounts for partial years, one-fourth (i.e.  $\frac{1}{4}$ ) of the annual amount will be used for each fiscal quarter or part thereof that the Agreement is in effect. Payments will be made quarterly.**
- 3.3.4 Upon signing of this Agreement, the Skeetchestn Indian Band will be paid the full revenues for the quarter in which the Agreement is signed (e.g. if this Agreement is signed at the end of the quarter, the FN would receive payment for that entire quarter), with subsequent payments being made at the end of each quarter.**

**3.3.5 British Columbia will not seek to direct or influence the expenditure of the funds provided to the Skeetchestn Indian Band.**

**4.0 Consultation and Accommodation Regarding Operational and Administrative Decisions and Plans**

- 4.1 The Skeetchestn Indian Band is entitled to full consultation with respect to all potential infringements of their Aboriginal Interests arising from any Operational or Administrative Decisions or Plans affecting the Skeetchestn Indian Band's Aboriginal Interests, regardless of benefits provided under this Agreement.**
- 4.2 At the request of the Skeetchestn Indian Band British Columbia will request the Licensee provide an Operational Plan proposed within the Area of Interest and supporting documents to Skeetchestn Indian Band.**
- 4.2 During the term of this Agreement, and subject to the terms and the intent of this Agreement being met and adherence by British Columbia, the Skeetchestn Indian Band agrees that British Columbia will have provided Workable Interim Accommodation with respect to the economic component of potential infringements of the Skeetchestn Indian Band's Aboriginal Interests as an interim measure in relation to forest and range development within the Area of Interest.**
- 4.3 The interim payment set out in this Agreement reflects an amount that British Columbia, through the Minister of Forests and Range is willing to pay as an interim measure, which the Skeetchestn Indian Band has agreed to accept.**
- 4.4 The Parties agree to jointly develop a consultation processes regarding both Operational and Administrative Decisions or Plans which may affect the Skeetchestn Indian Band's Aboriginal Interests within their Area of Interest, Appendix B provides a consultation process framework that will be followed in the event that the Parties cannot jointly agree on a consultation protocol.**
- 4.5 Where Skeetchestn Indian Band is a member of a larger Tribal Nation, this Agreement does not limit the obligation of British**

**Columbia to fulfil its consultation obligations with the Tribal Nation.**

## **5.0 Dispute Resolution**

- 5.1 If a dispute arises between British Columbia and the Skeetchestn Indian Band regarding the interpretation of a provision of this Agreement, the Parties or their duly appointed representatives will meet as soon as is practicable to attempt to resolve the dispute.**
- 5.2 If the Parties are unable to resolve differences at the appropriate level, the interpretation issue will be raised to more senior levels of British Columbia and the Skeetchestn Indian Band.**
- 5.3 If the interpretation dispute cannot be resolved by the Parties directly, they may appoint an independent and mutually agreeable mediator to resolve that dispute within 60 days, or such period as agreed upon, or the Parties may choose other appropriate approaches to assist in reaching resolution of the interpretation issue.**

## **6.0 Term and Termination**

- 6.1 The term of this Agreement is five years.**
- 6.2 This Agreement will take effect on the date on which the last Party has executed it.**
- 6.3 This Agreement will terminate on the occurrence of the earliest of any of the following events: expiry of its term, 90 days notice; or mutual agreement of the Parties.**
- 6.4 Neither Party shall terminate this Agreement on the grounds that the other Party has challenged an Administrative or Operational Decision by way of legal proceedings.**
- 6.5 Notwithstanding section 6.4, British Columbia may terminate the Agreement when there is a challenge on the basis that the Economic Benefits set out in section 3 are not adequate or sufficient Workable Interim Accommodation.**
- 6.6 Prior to termination under section 6.5, the Parties agree to meet and endeavour to resolve the dispute.**



## **7.0 Renewal of the Agreement**

- 7.1** Prior to the expiry of its term, in accordance with Section 6.3, if the terms and conditions of this Agreement are being met, British Columbia and the Skeetchestn Indian Band will seek the necessary authorities and approvals to renew this Agreement.
- 7.2** Any subsequent forestry agreement between British Columbia and the Skeetchestn Indian Band may provide for an opportunity to acquire a licence, other forest tenures, and/or other economic benefits, as well as other terms and conditions that are agreed to by the Parties.
- 7.3** This Agreement will not limit Skeetchestn's ability to participate in the forestry sector in any other lawful manner.

## **8.0 Amendment of Agreement**

- 8.1** Any alteration or amendment to the terms and conditions of the Agreement must be in writing and duly executed by the Parties.
- 8.2** Either Party may request the participation of the other Party to review the effectiveness of this Agreement annually and consider amendments to this Agreement.
- 8.3** The Parties agree that new approaches for consultation and accommodation, including benefit and revenue sharing, will be developed as a priority under the New Relationship by British Columbia and the Leadership Council. The Skeetchestn Indian Band may choose to opt into such approaches as they become available, through amendment of this Agreement or other mutually agreeable methods.

## **9.0 Entire Agreement**

- 9.1** This Agreement and any amendment to it constitute the entire Agreement between the Parties with respect to the subject matter of this Agreement.

## **10.0 Notice**

- 10.1** Any notice or other communication that is required to be given or that a Party wishes to give to the other Party with respect to this Agreement, will be in writing and will be effective if delivered, sent by registered mail, or transmitted by facsimile to

**the address of the other Party as in this section of the Agreement.**

- 10.2 Any notice or other communications will be deemed to have been given on the date it is actually received, if received before 4:00 p.m. If received after 4:00 p.m., it will be deemed to have been received on the next business day.**
- 10.3 The address of either Party may be changed by notice in the manner set out in this section of the Agreement.**

**11.0 Miscellaneous**

- 11.1 This Agreement shall be interpreted in a manner consistent with provincial, federal and constitutional law.**
- 11.2 This Agreement is not a treaty or a lands claims agreement within the meaning of sections 25 and 35 of the Constitution Act, 1982 and does not define or amend aboriginal rights, or limit any priorities afforded to aboriginal rights, including aboriginal title.**
- 11.3 This Agreement does not address or prejudice conflicting interests or competing claims between First Nations.**
- 11.4 This Agreement will not limit the positions that a Party may take in future negotiations or court actions.**

- 11.5 Nothing in this Agreement, including the recitals, defines or confirms the specific nature, scope, location or geographic extent of Aboriginal Interests of the Skeetchestn Indian Band.**
- 11.6 Nothing in this Agreement shall be interpreted to authorize any infringement that may occur following the termination of this Agreement, even if that infringement is caused by a decision that was made during the term of this Agreement.**
- 11.7 This Agreement does not address or affect any claims by the Skeetchestn Indian Band regarding infringement of its Aboriginal Interests arising from past Operational or Administrative Decisions made previous to the signing of this Agreement.**
- 11.8 This Agreement and any decisions and or Licenses issued during the term of this Agreement do not change or affect the positions either Party has, or may have, regarding jurisdiction and authorities.**
- 11.9 Any reference to a statute in this Agreement includes all regulations made under that statute and any amendments or replacement of that statute and its regulations.**
- 11.10 There will be no presumption that any ambiguity in any of the terms of this Agreement should be interpreted in favour of either Party.**
- 11.11 The applicable laws of British Columbia and Canada shall govern this Agreement.**
- 11.12 British Columbia encourages other third party forest and range tenure holders to enter into mutually-beneficial arrangements with the Skeetchestn Indian Band and specifically British Columbia encourages Licensees to enter into information sharing agreements with Skeetchestn Band to share information on the Licensee's Forest Stewardship Plans.**
- 11.13 This Agreement is not intended to limit any obligation of forest licensees or other third parties to the Skeetchestn Indian Band.**
- 11.14 This Agreement may be entered into by each Party signing a separate copy of this Agreement, including a photocopy or faxed copy, and delivering it to the other Party by fax. Each facsimile will be deemed to be an original for all purposes and**

**all counterparts taken together will be deemed to constitute one document.**

**11.15 This Agreement does not exclude the Skeetchestn Indian Band from accessing forestry economic opportunities and benefits, which may be available, other than those expressly set out in this Agreement.**

## **12.0 Giving Effect to the New Relationship**

**12.1 Notwithstanding this Agreement, the Parties may negotiate interim agreements in relation to one or more of the forestry, range and related plans that give effect to the New Relationship, which may include, but are not limited to the following components:**



- (a) a process for shared decision making about the land and resources;**
- (b) new mechanisms for land and resource protection;**
- (c) a process for the Skeetchestn Indian Band's land use planning at all spatial scales and for reconciliation of Crown and the Skeetchestn Indian Band's plans;**
- (d) dispute resolution processes which are mutually determined for resolving conflicts rather than adversarial approaches to resolving conflicts;**
- (e) financial capacity for the Skeetchestn Indian Band and resourcing for British Columbia to develop and implement new frameworks for shared land and resource decision making and other components listed above; and**
- (f) on a priority basis, interim protection for landscapes, watersheds and/or sites identified by the Skeetchestn Indian Band to be reserved from resource development pending the outcome of negotiation of agreements referred to in a-e above.**




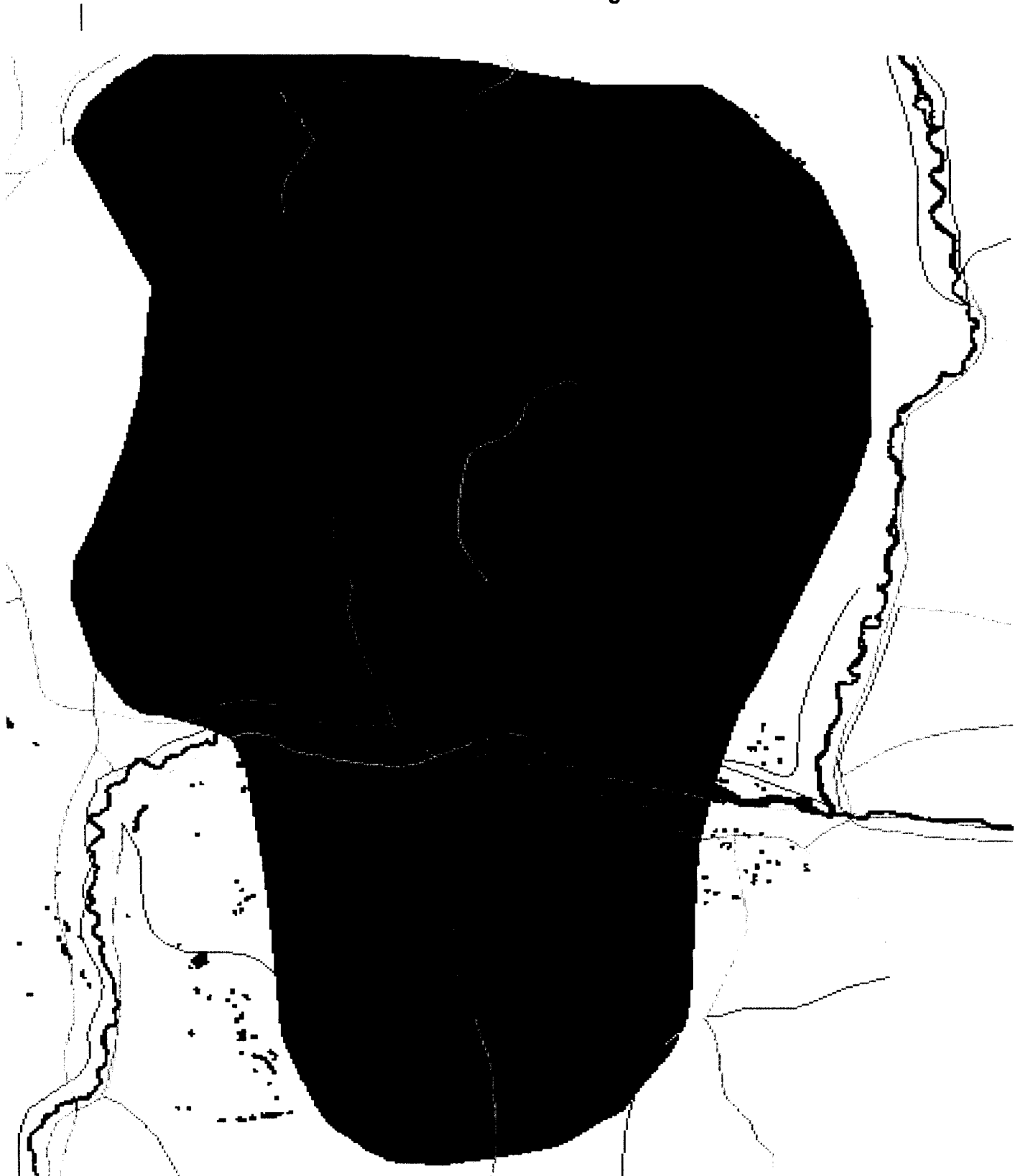

## **APPENDIX B**

### **Consultation Process Framework**

1. British Columbia and Skeetchestn agree to meet within the first year of the "Skeetchestn Interim Measures Agreement" to seek to develop a consultation process that is acceptable to both Parties.
2. British Columbia will provide to Skeetchestn Indian Band a consultation matrix on an annual basis following the format outlined in the Consultation Spectrum Table below. The consultation matrix will list all proposed Administrative and Operational Decisions that may have an effect on Skeetchestn's Aboriginal Interests within their Area of Interest and who the decision makers are for each decision.
3. Additionally either upon the request of the Skeetchestn Indian Band, or when British Columbia becomes aware of other proposed Administrative and/or Operational Decisions, British Columbia will provide Skeetchestn Indian Band an updated consultation matrix.
4. The Parties agree to review and seek to incorporate the consultation matrix into a consultation process. And also where consistent with both Parties' interests, the Parties agree to explore opportunities to include guidelines or portions of the guidelines provided by Skeetchestn (the "SNTC consultation and accommodation guidelines") in the consultation framework, to the extent that doing so is consistent with the Ministry of Forests and Range' statutory jurisdiction, authority and responsibilities. The intent of the matrix is to seek an understanding on consultation levels and approaches from notification to deep consultation for each type of decision.
5. The Parties agree to establish a joint consultation committee (the "Committee") comprised of representatives from the Band and Ministry of Forests and Range.
6. The Committee will extend an invitation to other Governmental land use agencies such as the Ministry of Environment and the Integrated Land Management Bureau to sit on the Committee where and when appropriate.
7. The Committee will meet quarterly throughout the year, or as mutually agreed to by the Parties.
8. The role and responsibilities of the Committee are to:
  - share information on proposed forest and range developments and related decisions;
  - share information on possible economic opportunities for the participation of the Skeetchestn First Nation in the forestry and range sector;

- provide a forum for the Band to identify its Aboriginal Interests and concerns respecting potential infringements of those interests;
- update and amend the consultation matrix as needed and mutually agreed to;
- begin giving effect to the New Relationship by commencing discussions and, where the Parties agree, negotiations in regards to some of the items specified in section 12.1 of this Agreement;
- discuss information regarding forest and range stewardship, including "Skeetchestn Cultural Resource Management Zones" Skeetchestn's "Silviculture Strategy", "Skeetchestn Indian Band Territorial Heritage Conservation Law", and Skeetchestn's land use objectives and strategies;
- advance mutual understanding of Skeetchestn's "Cultural Resource Management Zones (C.R.M.Z.s)" and "Silvicultural Strategy in regards to Mountain Pine Beetle" between the Parties; and,
- explore opportunities to include information provided by Skeetchestn in operational planning to the extent that doing so is consistent with the Ministry of Forests and Range' statutory jurisdiction, authority and responsibilities, and where consistent with both Parties' interests.

Intent is to notify (or negotiate) on an annual basis which decisions fall in this category. FN can request more detail if they wish
3) <b>Notification</b>	Notify in writing the First Nation about an upcoming decision and provide overview information. Would be an opportunity for comment	Intent is to provide base level information and time to comment. Limited follow-up.

## BAND COUNCIL RESOLUTION
