



2015 AMENDING AGREEMENT

BETWEEN

GITANYOW NATION, as represented by the Gitanyow Hereditary Chiefs, and the Gitanyow Huwilp Society ("Gitanyow")

AND

HER MAJESTY THE QUEEN IN RIGHT OF THE PROVINCE OF BRITISH COLUMBIA
as represented by
the Minister of Aboriginal Relations and Reconciliation and
the Minister of Forests, Lands and Natural Resource Operations ("British Columbia")

(Each a "Party" and collectively the "Parties")

WHEREAS

- A. The Parties entered into the Gitanyow Huwilp Reconciliation and Recognition Agreement (Reconciliation Agreement) attached as Schedule 1 on March 28, 2012;
- B. The Parties representatives agreed to the Engagement Framework attached as Schedule 2 on April 23, 2013;
- C. The term of the Reconciliation Agreement ends on March 27, 2015;
- D. The Reconciliation Agreement section 22.10 provides the Parties may amend that agreement;
- E. The Parties wish to extend the term of the Reconciliation Agreement on the terms and conditions set out in this Amending Agreement.


Therefore Parties agree as follows:


- 1. This Amending Agreement will take effect on the date that it is signed by all of the Parties (Effective Date).
- 2. The Parties agree to extend the term of the Reconciliation Agreement to March 27, 2016.

3. British Columbia agrees to provide Gitanyow with \$125,000 to supplement its own resources to implement the Reconciliation Agreement and the Engagement Framework between the Effective Date and March 27, 2016.
