



## Fumigation Certification Study Materials

Certification exams for the fumigation categories are based on study material listed below. Some material is from Ontario, the United States and other jurisdictions. Remember that you must always follow British Columbia legislation and Canadian pesticide labels when conflicting information is presented from other jurisdictions.

Categories of fumigation certification are:

- **Fumigation – Ships and Structures** (for the fumigation of ships, aircraft or buildings and the fumigation of bulk cargo in ships)
- **Fumigation – Container** (for the use of fumigants to treat stored grain or commodities in shipping containers, rail cars, under tarps)
- **Fumigation – CO<sub>2</sub>** (for the use of use of carbon dioxide to treat grain or flour inside storage bins, silos, rail cars or elevators)
- **Fumigation – Soil** (for the use of chloropicrin, dazomet, metam sodium, methyl bromide, and/or chloropicrin in a fumigation of soil) **Category under construction**
