

Fumigation Management Plan Template

Instructions:

1. Prepare a Fumigation Management Plan (FMP) for each type of fumigation (under tarps, building, grain bins, railcars, ships' holds, etc.) performed at each site in each separate facility.
2. Submit the appropriate FMP to the regional delegate of the *Integrated Pest Management Act* Administrator at least two business days before the first fumigation is conducted at a site. Addresses for regional delegates are:

3. Keep FMPs on file for a minimum of three years after they have been used.
4. Prepare and submit updated FMPs when FMP deficiencies are identified, when changes are made to fumigant labels or equipment used and when changes are made to fumigation sites (e.g. due to nearby construction or change of site manager).

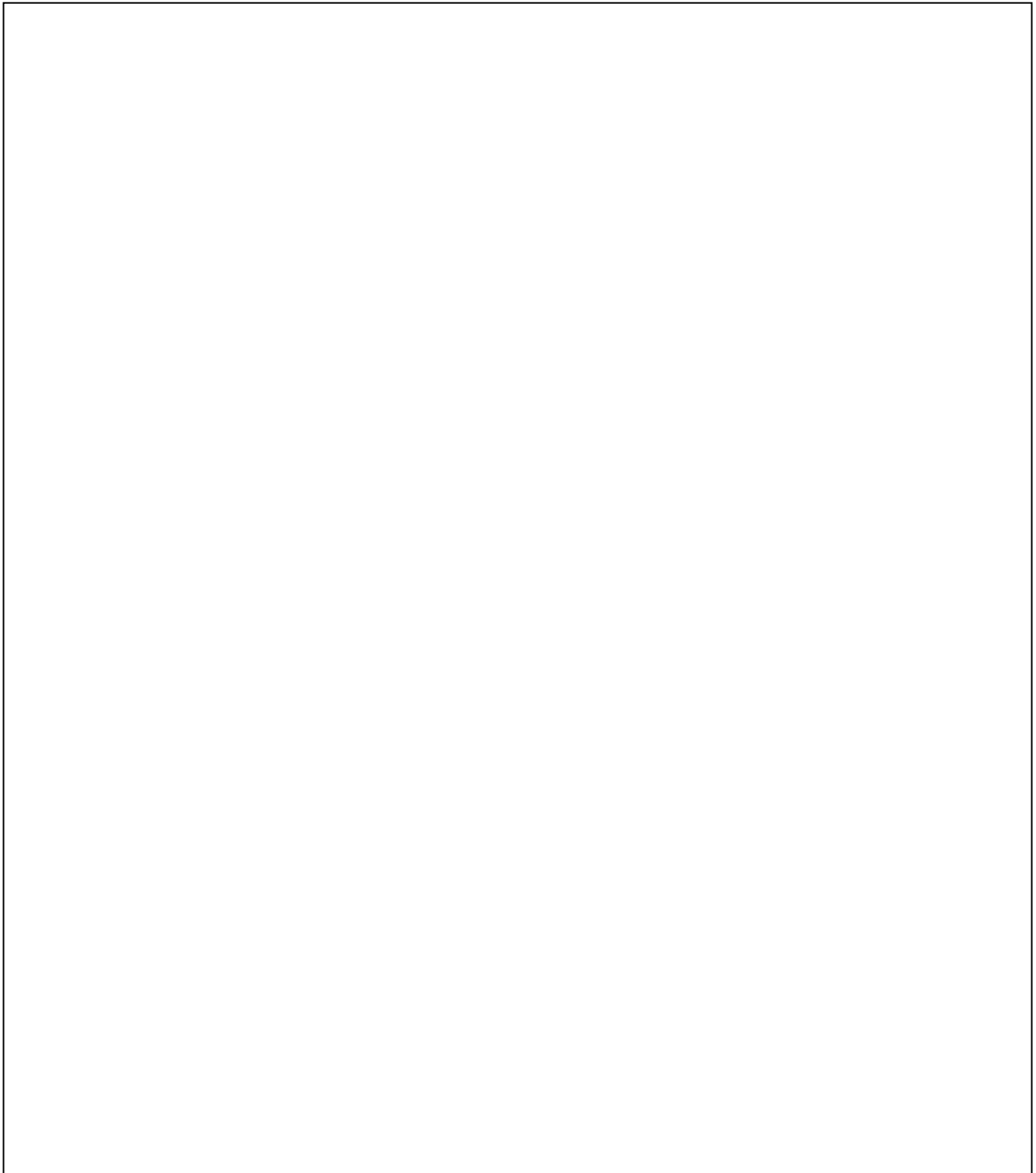
