On January 08, 2018, Environmental Protection Division staff from the Ministry of Environment and Climate Change Strategy conducted an inspection of your facility, LIONS' GATE FISHERIES LIMITED, located at 612 Campbell Street, Tofino, with authorization number 7952 under the *Environmental Management Act*.

Inspection Details:

Requirement Description:	<b>GENERAL REQUIREMENTS - Bypasses</b> 2.2: The discharge of effluent which has bypassed the designated treatment works is prohibited unless the approval of the Regional Waste Manager is obtained and confirmed in writing.
Details/Findings:	This report follows up on the compliance advisory issued with regards to the December 5 and 6, 2017 inspection (report 73999), in which permit section 2.2 was listed as out of compliance due to effluent from the boat hold bypassing the screening process prior to discharge through the outfall. On December 27, 2017, the Lions' Gate Fisheries manager informed ministry staff by email that as of December 22, the effluent is now directed through the screening process prior to discharge, therefore this section is no longer out of compliance. Section 2.2 was the sole section noted as out of compliance in the previous inspection.
