This order was amended to include additional specific requirements for the EIA.

Ilnicki, Ed	Abbotsford	<i>Environmental Management Act</i>	63/88	81	Pollution Prevention Order - was issued for storing hazardous wastes in quantities exceeding that allowed by the Hazardous Waste Regulation, and for possessing hazardous wastes without registration or approved plans. The order required the owner to retain a qualified consultant to conduct an inventory and characterization of the hazardous waste and submit the results, along with methodology used to the ministry.

Double 00 Ranch Inc. 100298	Quesnel/Kersley Creek	<i>Water Act</i>		88	Engineer's Order was issued in response to a professional forest hydrologist's report (commissioned by MoF) stating danger to public safety and environment if remediation is not undertaken. At risk were the railway, highway, gas pipeline, hydro right-of-way, other landowners downstream and fish habitat. Order is under appeal and Environmental Appeal Board hearing planned for spring 2007.
LGB9 Development Corp	Victoria	<i>Water Act</i>		88	Engineer's Order was issued requiring the building of temporary works to reinforce existing unauthorised dam, as public safety was at risk. Party had placed fill in spillway to enable land development downstream. Order has been complied with.
