This newsletter is meant to share information and support the ministry's commitment to ongoing consultation and collaboration with Indigenous Peoples, partners and governments to develop legislation and services consistent with the provincial *Declaration on the Rights of Indigenous Peoples Act* as well as the *UN Declaration on the Rights of Indigenous Peoples*.

We will listen to the children, youth and families we serve, knowing their voices and experiences are central to the creation of services that truly meet their needs.

## Children and Youth with Support Needs

In November 2022, the ministry committed to engaging in deeper consultation with Indigenous Peoples, parents and caregivers, experts and practitioners and others with lived experience, to build a system that better serves all children and youth with support needs, based on their unique needs, co-developed with Indigenous communities.

We invite First Nations families and communities to participate in a virtual gathering in May to begin deeper engagement and to view the proposed engagement process on the Engage BC website.

We also invite Métis Peoples, urban Indigenous people, Inuit families and others to participate in additional upcoming engagement opportunities.

## Youth Transitions Improved Supports

The ministry continues to develop new and improved supports for youth and young adults transitioning to adulthood from care, up to the age of 27.

Here are some upcoming changes:

- Increased annual dental limit to \$1,000
- Expanded optical benefits to \$600/two years including eye exams and glasses
- Temporary Support and Temporary Housing Agreements available between age 19-21 and flexibility to move between agreements
- Regulation change to extend the maximum duration of Agreements with Young Adults to 84 months starting April 2023
- Provincial Tuition Waiver Program available for all ages starting August 1, 2023

## Splatsin, Canada and British Columbia celebrate coordination agreement signing

The Splatsin First Nation has signed a coordination agreement, with Indigenous Services Canada and the ministry that supports the exercise of Splatsin's jurisdiction of their child, family and community services under Spallumcheen Indian Band Bylaw #3-1980 and Secwépemc law. Splatsin will continue to take care of their children and families, as they have always done.

This agreement is the first coordination agreement in British Columbia and the fifth in Canada.

We connected with 203 individuals in sessions, received 534 responses to the public survey and over 1,000 submissions from social work practitioners. Thank you for your participation and partnership in this process.
