Improved Strengthening Abilities and Journeys of Empowerment (SAJE) Supports Coming in Fall 2023

New life-skills, training and cultural connections funding will be available for young adults pursuing their goals through the Agreements with Young Adults (AYA) program. Also, young adults on AYA, a Temporary Housing Agreement, or Temporary Support Agreement will have access to new mental health and counselling benefits.

These new and improved supports are for eligible youth and young adults up to age 27 through the SAJE program.

As a result of your participation, several changes were immediately made to child and family service legislation with the introduction of Bill 38. Further work is underway across the ministry to reform the child and family services system based on the feedback we received.

Engagement on Regulations to Support Bill 38

The ministry is developing regulations to give full force and effect to Bill 38, in consultation and collaboration with Indigenous Peoples. Engagements on regulations happened over the spring and summer and are expected to come into force by the end of 2023.

The first round of engagements to gather input on the Indigenous Child Welfare Director position also took place over the spring and summer.
