Changes to Missing Children and Youth In-Care Policies

In response to the Representative for Children and Youth report "Missing," the ministry has made changes to missing children and youth in-care policies and drafted interim practice guidelines to address immediate safety concerns.

These revisions are the first step in improving supports for children and youth who may go missing. For February 2024, the ministry plans to make additional changes to policies, including how missing child and youth responses can be improved through focusing on relationships and belonging.

You are invited to participate in engagement sessions planned for January 2024 and as well provide written feedback on the existing policies and interim practice guidelines.

Improved Supports: Strengthening Abilities and Journeys of Empowerment (SAJE)

Over the coming weeks, new Life-skills, Training, and Cultural Connections funding will be available for young adults pursuing their goals through the the SAJE Program and on Agreements with Young Adults (AYA). Also, young adults on AYA, a Temporary Housing Agreement, or Temporary Support Agreement will have access to new mental health and counselling benefits.

New and improved supports are available for eligible youth and young adults up to their 27th birthday. *Eligibility* varies by program.

Proposed Strengthening Abilities and Journeys of Empowerment (SAJE) Guide Policy

The ministry is seeking feedback on the proposed policy for the new SAJE Guide role. Feedback provided will help to refine the policy.

SAJE Guides will be available to support eligible young adults from care as they transition to adulthood. The proposed policy provides SAJE Guides with information about how they can support young adults to successfully navigate the transition to adulthood and interdependence, including how they can access the range of supports available.
