Dear NAME:

Our government is committed to reconciliation and, as Minister of Children and Family Development, I will work with Indigenous Peoples to transform child and family services in British Columbia to deliver services that meet the needs of Indigenous children, youth and families and addresses the systemic overrepresentation of those children and youth in the child welfare system. This includes working with Indigenous governing bodies towards exercising jurisdiction for child and family services and continued dialogue with Indigenous communities that are planning for increased decision-making authority or jurisdiction. In doing so, we pledge to embark in partnership on a collaborative journey that is consistent with the provincial *Declaration Act*, the federal *Act respecting First Nations, Inuit and Métis children, youth and families* and the *UN Declaration on the Rights of Indigenous Peoples*.

Our focus in the design of reformed legislation, regulation and any new policy or system of supports for children and youth must reflect those human rights principles and legislative obligations, as well as our <u>Letter of Commitment</u> sent on August 31, 2021, to the First Nations Leadership Council. This letter commits the ministry to actively engage and co-develop policy, practice and legislation changes with Indigenous Peoples (including First Nations, Métis and Inuit).

For the ministry, that requires us to reflect on the history of colonialism and racism, including in residential schools, that affects all our systems of support. We acknowledge this will be a major shift for the ministry that requires structural change and that there is substantial work to be done with your partnership. There are large scale system-wide changes that need to be addressed. For example, we are committed to reforming the *Child, Family and Community Service Act*, the legislation that guides the work of social workers and the child welfare system in British Columbia.

In addition to these broad changes, there are also more focused changes required for legislation, policy and practice. We will seek your input and create space to listen so we understand how to ensure more immediate changes support a long-term vision for child and family services that are culturally appropriate, and support positive outcomes, connected families and healthy communities.

As we work to decolonize services, we want our invitations for engagement to be accessible, predictable and transparent. There are several ways we will keep you informed of the work that is happening and provide opportunities to be involved.

These include:

- A regular newsletter (see enclosure) that will describe all priority initiatives, how you can participate and who you can contact should you want to engage directly;

- Correspondence directly to Indigenous Peoples to highlight significant initiatives;
- Web-based interactive opportunities to share your priorities, opinions and ideas when it is convenient for you, including surveys, consultation drafts, and discussion papers posted on www.engage.gov.bc.ca;
- Engagement sessions with Indigenous Peoples for large-scale systemic changes;
- Special advisory circles for key systemic initiatives, including legal and technical advisory committees.

The newsletter is one of the many ways we will provide updates on the progress of our work together and opportunities for engagement. The newsletter will be shared with Indigenous Peoples, leadership partners and service providers including (but not limited to) the First Nations Leadership Council, Métis Nation British Columbia and Delegated Aboriginal Agencies. It will also be on our Web site.

We welcome input and I encourage you to participate in upcoming opportunities so that, together, we can successfully move forward and achieve real and meaningful change that respects your rights and improves services and supports for Indigenous children, youth and families.

Child, Family and Community Service Act Reform

This is a critical reform of child welfare legislation. The Act has not kept pace with the need for decolonization and contributes to the over representation of Indigenous children and youth in care.

This reform will:

- Promote positive changes to services
- Support Indigenous jurisdiction and shared decision making
- Align with the Act respecting First Nations, Inuit and Métis children, youth and families (federal), and the Declaration on the Rights of Indigenous Peoples Act (provincial)

Indigenous Peoples must have every opportunity to drive these changes. We are working with Indigenous partners, including distinctions-based advisory circles (First Nations and Métis), so their knowledge and input can guide engagement as we develop new policy and legislation together.

Through the Childcare BC Plan, we are creating thousands of quality, affordable child care spaces, building better facilities, and training more people to become early childhood educators.


We value your input and would like to know what you think is most critical as we continue to evolve early learning and child care.

Work in Progress

Indigenous Child & Family Services Jurisdiction

We are currently meeting with five Indigenous Governing Bodies who are seeking to exercise jurisdiction for child and family services under the Federal Act respecting First Nations, Inuit and Métis children, youth and families. Along with representatives from the federal government, we are working with the Indigenous Governing Bodies to support the development of tripartite coordination agreements.

We continue to work with First Nations and Métis as they pursue their self-determined goals of increased authority, decision making and/or jurisdiction over child and family matters.

Policy and Practice Adjustments

The ministry regularly makes smaller focused changes to specific policies or practices in order to bring them into alignment with the federal Act, to provide clarity to staff and service providers, or address input and recommendations from those we serve and oversight bodies. As we move forward we will include information about those proposed changes and seek your input.
