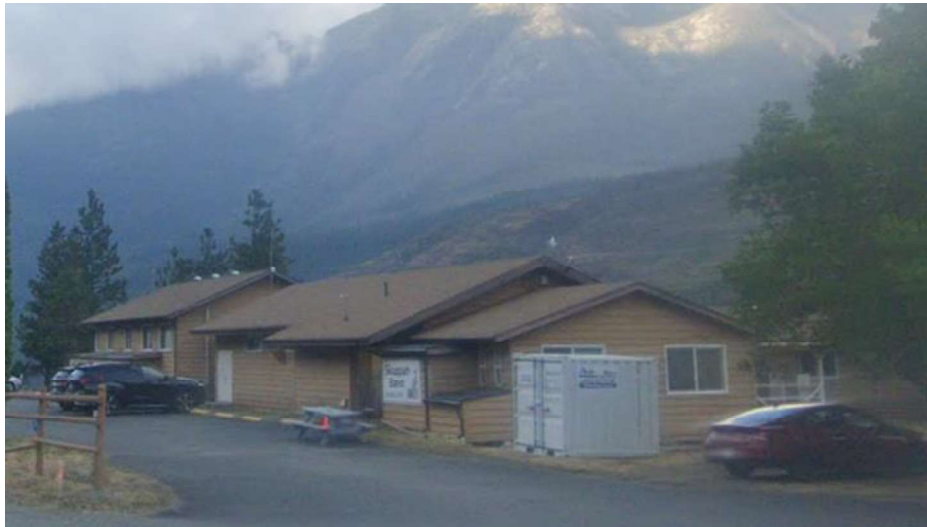

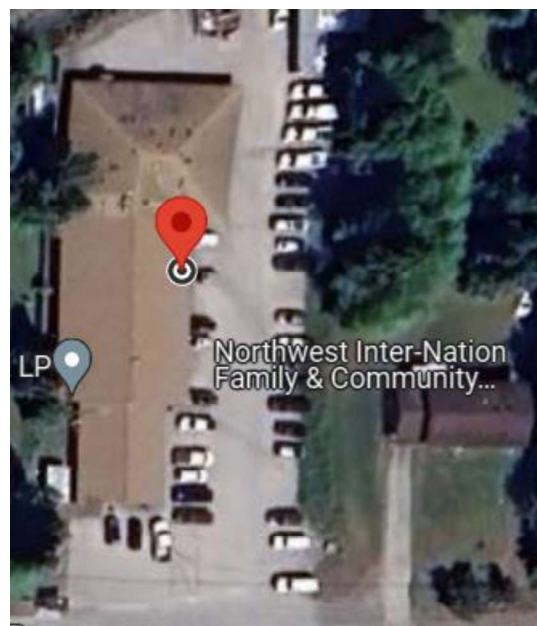

"Signs of Safety" practice is being implemented across all teams. The SCFSA Family Preservation teams receive, assess, and respond to child protection reports for both on and off reserve as well as providing ongoing services through collaborative planning/decision-making with families and communities to identify existing signs of safety for the purposes of promoting the safety and well-being of children. Connecting youth with numerous support networks once they transition out of care to ensure they have the life skills they need to succeed in life, is a big focus for our team. The guardianship team works with children and families until the child reaches the age of 19 or until there is a permanency plan implemented. 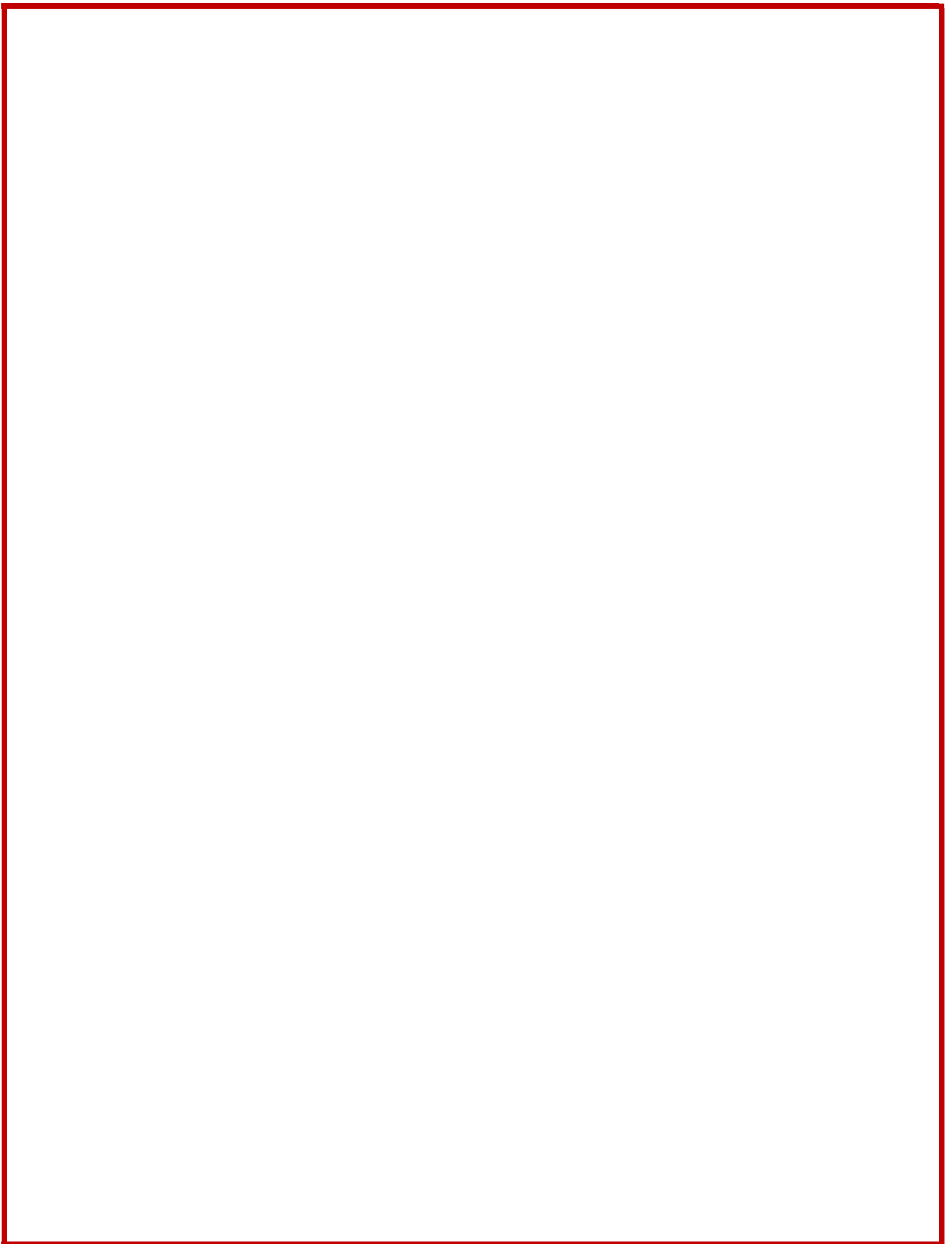
