## **CONDITIONS OF LICENCE**

### **Security for Payment**

1. An applicant for a licence to purchase live poultry for processing and resale shall furnish, and a holder of licence to purchase live poultry for processing and resale shall maintain, security in the form of a surety bond or irrevocable letter of credit as described in the Poultry Health and Buying regulation and the Bonding Act regulation, for the payment of money payable to a producer for the purchase of live poultry for processing and resale by or through the holder of a licence, in the following amounts:
  - a) for an annual purchase of less than \$50,000, a bond for \$5,000
  - b) for an annual purchase of more than \$50,000 to \$1,000,000, a bond of \$20,000
  - c) for an annual purchase of more than \$1,000,000, a bond of \$50,000

### **Licencing**

2. An application for a licence or renewal of a licence to purchase live poultry for processing and resale shall be accompanied by:
  - a. the fee provided in the schedule and
  - b. a security in the appropriate amount as referred to in section 1 above
3. An application for renewal of a licence shall be made by the last day of February.
4. The term of the licence is from April 1 or the date of issuance, as the case may be, to March 31.

### **Branch Licences**

5. No licence holder shall operate at more than one location unless he is the holder of a valid and subsisting licence for each branch premises.

### **Schedule of Licence Fees**

6. Licence to purchase live poultry for processing and resale or renewal of a licence is \$ 45.00
7. For multiple licensed locations a person must pay \$45.00 for the first location and \$23.00 for additional locations.
