APPLICANT DECLARATION:

By submitting this application and loss schedule(s) to the British Columbia Ministry of Agriculture and Food 2023 Canada-British Columbia Wildfire and Drought Recovery (the "Program"), I:

- represent that I am the duly authorized signatory of the applicant;
- declare that I have/ the applicant has not knowingly submitted false or misleading information and that the information provided in this application and loss schedule(s) are true and correct in every respect to the best of my knowledge;
- understand that failing to comply with all application requirements may delay the processing of this application or make me/ the applicant ineligible to receive funding under the Program;
- represent that I have/ the Applicant has read and understood the Program Terms and Conditions and agree to be bound by the Program Terms and Conditions, including but not limited to:
 - Section 9 (Verification and Declarations), and
 - Section 11 (Refunds/ Overpayments);
- represent that I am/ the applicant is in compliance with all Program eligibility requirements;
- agree not to pursue a claim or, if applicable, to withdraw an existing claim, in civil litigation against the Province which seeks to recover an amount for the same losses for which a payment has been applied for under this Program;
- agree to disclose to the Business Risk Management Branch ("BRMB") of the Ministry of Agriculture and Food all other sources of funding received with respect to the wildfire and/ or drought recovery activities I/ the applicant receives assistance for from this Program including financial and/or in-kind contributions from industry, federal, provincial, or municipal governments; acknowledge that the *Income Tax Act*, RSC 1985, c.1, requires the BRMB to prepare a Statement of Farm Support Payments (AGR-1) and report the Tax Reporting Number on the AGR-1 for any Payments made under this Program; and
- without limiting the generality of section 9.5 of the Program Terms and Condition, consent to the BRMB disclosing all personal information that I/the applicant provides to the BRMB and the BRMB collects about me/ the applicant to other provincial or federal government ministries or municipal governments that are offering any assistance whatsoever as a result of the wildfires and drought for the purpose of verifying the information provided and for the purpose of coordinating the assistance provided. This consent is valid for three years from the date of signing.
